Introduction

Congratulations! You now own a powerful electronic spelling corrector that you can use at home, work, or school. Using your new *Webster's Spelling Corrector*, you can...

- correct and check spellings,
- find missing letters in words,
- find prefixes, suffixes, and other parts of words,
- find words that people often confuse,
- build words from letters, and
- play exciting and educational word games.

To learn how, follow the steps in this User's Guide using the examples shown or words that interest you.

To learn even more, also read tips like the ones below.

✓ **Changing the Contrast**

To adjust the screen contrast of your spelling corrector, first turn it on and then press **CLEAR**. Then press  or  repeatedly until the contrast suits you.

✓ **Replacing the Battery**

This spelling corrector uses one CR2032, 3-volt lithium battery. Should you need to replace the battery, remove the back cover of the spelling corrector with a small screwdriver. Then install a new battery, with its plus sign facing you, and replace the cover.

Key Guide

BACK	Backs up (e.g., erase a letter).
BUILD	Builds words from letters.
CLEAR	Clears to <i>Ready for word</i> .
CONF	Display Confusables®, if any.
DEMO	Displays a brief demonstration.
ENTER	Enters a word or selects an item.
GAMES	Displays the games.
HELP	Displays help messages.
ON/OFF	Turns this spelling corrector on or off.
←	Scrolls left or erases typed letters.
↑	Scrolls up or types an apostrophe.
↓	Scrolls down or types a period.
→	Scrolls right or types a space.
?	Types a ? to stand for a letter in a word. During a game, reveals a word.
*	Types an * to stand for a series of letters. During a game, reveals a hint.

✓ Follow the Arrows

The flashing arrows at the right of the screen show which arrow keys you can press to view more text.

Finding Spellings

It's easy to check or correct spellings. When you enter a correct word, a list of similar words appears. When you enter a misspelling, a list of corrections appears. Follow these steps.


1. **Type a word. To erase, press**  **or** .



serkut

You cannot type capital letters, but capitals are displayed in corrections.

2. **Press** .



circuit

The flashing arrow indicates more words.

3. **Press**  **repeatedly to view more words.**

To find even more corrections, press  twice.

4. **Press**  **when finished.**

✓ Resuming Where You Left Off

If you forget to turn off this spelling corrector, it turns off automatically in about two minutes. When you turn it on again, the screen that you last viewed appears.

Finding Letters in Words

If you are uncertain how to spell a word, type a question mark in place of each unknown letter. A list of matching words will appear.

1. Type a word with question marks for letters.

conc??ve

2. Press **ENTER**.

conceive



3. Press  to view more matching words.
4. Press **CLEAR** when finished.

✓ Viewing a Demonstration

To see a brief demonstration of what this spelling corrector can do, press **DEMO**. To stop the demonstration, press **CLEAR**.

✓ Help is Always at Hand

You can view a help message at virtually any screen by pressing **HELP**. To exit a help message, press **BACK**.

Finding Parts of Words

You can find prefixes, suffixes, and other parts of words by typing asterisks in words. Each asterisk can stand for any series of letters.

1. Type a word with one or more asterisks.



2. Press **ENTER**.



3. Press **↓** to view more matching words.

4. Press **CLEAR** when finished.

✓ Tips for Finding Letters

- You can type both question marks and asterisks in a word.
- You can type asterisks at the beginnings of words, but the spelling corrector may take a while to find matches.
- You can use question marks to help solve crossword puzzles and similar word games by typing them in place of missing letters.

Finding Confusables®

Confusables are words that sound alike but are spelled differently. When a question mark flashes to the right of a word in a list, that word has Confusables. Try this example.

1. Type *air* and then press **ENTER**.

Notice the flashing question mark.

2. Press **CONF** to see its Confusables.

air : atmosphere †

3. Press **↓** repeatedly to view more.

ere : before †

4. Press **CLEAR** when finished.

✓ A Quick Way to View Confusables

Simply type a word and press **CONF**. Its Confusables, if any, will appear.

✓ Viewing Long Words

Some words in lists are too long to fit on the screen. To see the entire word, press **ENTER**. The rest of the word will automatically scroll into view.

Building Words from Letters

To help solve anagrams and similar word games, you can build words from letters by using the BUILD key.

1. Type letters.



xozjre

2. Press **BUILD**.



zero



3. Press to view more words.

4. Press **CLEAR** when finished.

✓ Typing Punctuation

You don't need to type punctuation marks to find spellings.

But if you want to type an apostrophe in a word, press . To type a period, press .

Note, however, that punctuation marks can't begin a word.

✓ Understanding the Skill Levels

The skill levels change the number of guesses in Hangman and the minimum number of letters (*Min size*) in Anagrams.

Playing Anagrams

Anagrams challenges you to find the anagrams of words. An anagram is a word formed from some or all the letters of another word.

1. Press **GAMES**.
2. Press **↓** or **↑** until you see *Anagrams* and then press **ENTER**.
3. Press **↓** or **↑** and then **ENTER** to select a skill level.

The *Min size* is the minimum number of letters the anagrams can have.

4. Type an anagram and then press **ENTER**.
If the anagram is correct, *OK* appears.
5. Enter more anagrams.
6. Press ***** to jumble the letters.
7. Press **↑** to view the used anagrams.
8. Press **?** and then **↓** repeatedly to reveal all the anagrams.
9. Press **ENTER** to play a new round.

Playing Hangman

In Hangman, you try to guess mystery words.

1. Press **GAMES**.
2. Press **↓** or **↑** until you see *Hangman* and then press **ENTER**.
3. Press **↓** or **↑** and then press **ENTER** to select a skill level.

4. Type letters you think are in the word.



5. Press **ENTER** or ***** to reveal a letter.
6. Press **?** to reveal the word.
7. Press **ENTER** to play a new round.

✓ Cleaning and Storage

To clean this spelling corrector, spray a mild glass cleaner onto a cloth and wipe its surface. Don't spray liquids directly on the spelling corrector. Don't use or store this spelling corrector in extreme or prolonged heat, cold, humidity, or other adverse conditions.
