Instructions


Thank you for choosing this RUBBADUBBERS toy!

Includes 2 x 1.5V "AA"/R6 batteries. Alkaline batteries recommended. Phillips/cross head screwdriver (not included) required for battery installation.

ADULT PLEASE NOTE: This product is shipped in "Demo" mode. Open seam on underside of toy and slide switch toward triangle mark for full use at home.

### TO REPLACE BATTERIES

Open seam on underside of toy. Loosen screw in battery compartment cover using a Phillips/cross head screwdriver. Remove cover (screw remains attached to cover). Remove and discard old batteries. Replace with 2 x 1.5V "AA"/LR6 alkaline batteries. Replace cover and retighten screw. Close seam.

# **CAUTION:** TO AVOID BATTERY LEAKAGE

- 1) Be sure to insert the batteries correctly and always follow the toy and battery manufacturers' instructions;
- 2) Do not mix old and new batteries or alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium) batteries;
- 3) Always remove weak or dead batteries from the product.

## CAUTION:

- 1. Always follow the instructions carefully. Use only batteries specified and be sure to insert them correctly by matching the + and -
- polarity markings. Do not mix old batteries and new batteries or standard (carbon-zinc) with alkaline batteries.
- 3. Remove exhausted or dead batteries from the product.
  4. Remove batteries if product is not to be played with for a long time.
- Do not short circuit the supply terminals.
- 6. Should this product cause, or be affected by, local electrical interference, move it away from other electrical equipment. Reset
- (switching off and back on again or removing and re-inserting batteries) if necessary.
