

## Nova-13 Stereo Headphones

Your Optimus Nova-13 Stereo Headphones deliver a wide frequency response in an extremely lightweight design. They are ideal for use with portable CD players, pocket-sized cassette players, or even your home stereo system. The adjustable headband accommodates any head size or shape for a comfortable fit.

The frequency response is 20–20,000 Hz. The impedance is 32 ohms  $\pm 15\%$ . Total harmonic distortion is less than 3% at 98 dB SPL 1 kHz. The diameter of each speaker is  $1\frac{3}{16}$  inches (30 mm).

**High Energy Elements** — deliver professional quality sound in a lightweight package.

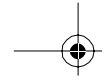
**Soft Foam Earcushions** — let you listen in comfort.

## OPERATION

**Caution:** Turn down the volume on your sound source before plugging in the headphones.

1. Plug the headphones into a  $\frac{1}{8}$ -inch stereo jack.
2. Put on the headphones and adjust the headband for a comfortable fit.
3. Adjust the sound source's volume to a comfortable level.

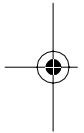

## Listening Safely

To protect your hearing, follow these guidelines when you use headphones.

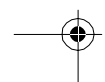
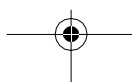
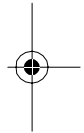
- Set the sound source's volume to the lowest setting before you begin listening. After you begin listening, adjust the volume to a comfortable level.
- Do not listen at extremely high volume levels. Extended high-volume listening can lead to permanent hearing loss.
- Once you set the volume, do not increase it. Over time, your ears adapt to the volume level, so a volume level that does not cause discomfort might still damage your hearing.



## Traffic Safety

Do not wear headphones while operating a motor vehicle or riding a bicycle. This can create a traffic hazard and could be illegal in some areas.

Even though some headphones are designed to let you hear some outside sounds when listening at normal volume levels, they still can present a traffic hazard.

## OPTIONAL ACCESSORIES

**Stereo-to-Mono Adapter (Cat. No. 274-368)** — lets you connect your stereo headphones to any monaural source such as a CB.

**20-Foot Extension Cable (Cat. No. 42-2462)** — lets you move about comfortably while listening.

**Stereo Y-Adapter (Cat. No. 274-313)** — lets you connect two sets of stereo headphones to one stereo headphone jack.

**1/4-Inch Adapter (Cat. No. 274-367)** — lets you plug the cord's 1/8-inch plug into a 1/4-inch jack.

## CARE

To enjoy your Optimus Nova-13 Stereo Headphones for a long time:

- Keep the headphones dry. If they get wet, wipe them dry immediately.
- Use and store the headphones only in normal temperature environments.
- Handle the headphones gently and carefully. Don't drop them.
- Keep the headphones away from dust and dirt.
- Wipe the headphones with a damp cloth occasionally to keep them looking new.

Modifying or tampering with the headphones' internal components can cause a malfunction and might invalidate their warranty. If your headphones are not performing as they should, take them to your local RadioShack store for assistance.
