The Appendix chapters are provided for quickly finding technical information about the ZX Station.

Expansion room is available inside the ZX Station to add other computer components.

The fold-down front allows easy access to panel-mounted components.

Designed to be deployed in transit cases, shelters, vehicles, airplanes, ships and military command centers, the ZX Station offers the latest in processor and components.

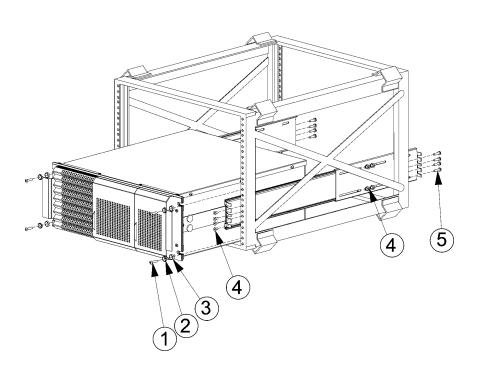

TOOLS REQUIRED

PRECAUTIONS



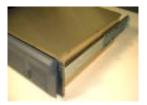
NOTE: For the fastest and easiest installation of the ZX Station, follow these steps in the sequence they are presented.

In preparation to install the ZX Station, take the following precautionary steps:

Verify the ZX Station power switch is off. If the power is off, the light on the front panel will not be illuminated.

Install Slides

SLIDE REMOVAL



Lay the ZX Station on a workbench.



The slide rail will reach a stop about half way out.

This is a safety stop to prevent the ZX Station from sliding out too far while mounted to the rack.

Simultaneously press in the safety catches on each slide rail and remove the slide rails all the way off the back of the ZX Station.



The slides should now be separated from the ZX Station.

Install Slides

INSTALL THE SLIDES IN CABINET FRAME



Use the proper screws (from left to right).

Pancakehead Phillips screw to install the front of the slider rail and top of lid.

Panhead Phillips screw and washer to install the back of the slider rail.

Ovalhead Phillips screw, stainless steel and nylon receptacle washers to install the front panel.



On the slide rails, using a Phillips screwdriver, loosen the screws on each side.

An adjustable wrench or box wrench may be used to hold the nut on the other side of the slide rail.



On the front of the RETMA Rail, use three pancakehead Phillips screws per side to secure the right and left slider rails.

DO NOT tighten these screws to allow for adjustment of the ZX Station within the cabinet frame.



On the rear of the RETMA Rail, use three panhead Phillips screws with washers per side to loosely secure the right and left rear slider mount to the RETMA Rail.

DO NOT tighten these screws fully at this time.



Tighten the slide mount to the cabinet frame on the back of the cabinet frame.

Make sure to hold the slide mounts hard against the rack rail.

Install ZX Station

INSTALL THE ZX STATION IN CABINET FRAME



Pull the two ZX Station slides out until they lock.



Hold the ZX Station by each side, with the front towards you.

Guide the ZX Station into the slide rails and slide the ZX Station in until it stops. If the ZX Station binds, the rollers are not properly in the slide rails.



Simultaneously press in the catches on each slide and push the ZX Station all the way into the cabinet frame.

The ZX Station should slide in and out easily.

INSTALLATION TEST



Slide the ZX Station in and out several times. The ZX Station should easily close completely.



To be sure the slide and mount assembly are aligned properly, slide the ZX Station in and out several times.

If the ZX Station binds during sliding, do the following:

Install ZX Station

FINAL ADJUSTMENTS



Slide the ZX Station partially out.

Lift the ZX Station while tightening the pancakehead Phillips screws in the front slider bracket.



Go to the rear of the cabinet to tighten the slider rail screws. If there is not enough room to work at the back of the cabinet, the ZX Station may need to be removed to tighten the rail screws.

The ZX Station should now slide in and out smoothly. If not, repeat these steps.



The ZX Station should slide in and out easily. If not, repeat these adjustment steps.

SECURING ZX STATION IN CABINET FRAME



Use four ovalhead Phillips screws, stainless steel and nylon receptacle washers to secure the front panel of the ZX Station to the front of the cabinet frame.

Install ZX Station

INSTALLING CABLES



WARNING: Be sure all electrical power to the cabinet is off before connecting any of the cables.



WARNING: There is a key guide for alignment on all the cables. Be sure the cable plug and receptacles are aligned properly using the key guide. Misalignment can cause short circuiting.

Several cables connect the back of the ZX Station to other equipment, depending upon the ZX Station internal configuration.

- Power cable
- Video cable
- Printer cable
- Keyboard cable
- · Mouse cable
- · and others



The power cable coming out of the back of the ZX Station should be connected to an appropriately grounded 110 VAC supply.

After connecting the power cable, turn the power switch next to the power cable in the back to the on position (circle down) and leave it on until disconnect the power cable.

POWERING UP



Switch the ZX Station on by pushing and releasing the power switch located on the right of the center front panel.

CONTROLS AND DISPLAYS



Peripheral options from left to right, top to bottom:

- Empty slot front cover.
- · CD-ROM.
- · Power light.
- Power switch. Press down and release for on.



On the right panel of the ZX Station, from left to right, top to bottom:

- 3-1/2 inch floppy drive.
- Handle for TranzPak

 memory drive.
- Power Light.
- Active Light.
- · SCSI ID Set Switch
- Read-only light.
- · SCSI ID.
- Removable memory drive security lock.
 Push drive all way in and rotate security lock clockwise to lock drive in place.

TRANZPAK 6

FRONT PANEL

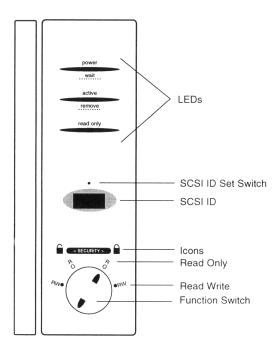
The front panel of the TranzPak 6 contains three LEDs, a SCSI ID indicator, a push-switch to set the SCSI ID and a function switch.

The top LED indicates power to the hard disk drive. The middle LED indicates an active state when the computer is accessing the TranzPak 6. The bottom LED indicates a read only state.

The SCSI ID Indicator shows a number, which is the setting for the disk module.

The SCSI ID Set Switch is a push-toset switch that advances the SCSI ID Indicator by one number with each push.

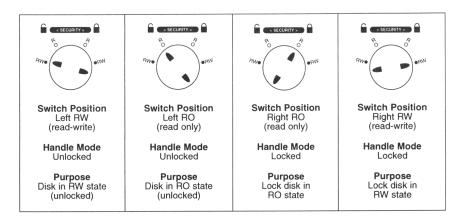
The Function Switch has four positions.

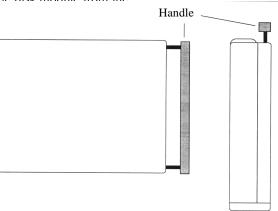
FUNCTION SWITCH

The function switch has multiple features and is used for a variety of tasks in operating a disk module and its internal disk drive.



DISK MODULE HANDLE

The handle serves several functions: (1) it is an on/off power switch for the internal hard disk drive, (2) it is a mechanical lock, and (3) it disengages the module latch to allow removal of the disk module from the docking

Handle Positions

- 1. Fully In—Disk Powered (locked when function switch is on right RW or RO position)
- 2. In (but not against front panel)
- 3. Locked—Disk Not Powered (switch in right RW or RO)
- 4. Out (stopped by spring)
- 5. Fully Out (handle fully extended)

^{*} Note: The light sequence of the active LED depends on the installed disk and may be different than this table.

^{**} Note: The read only LED turns on when the switch is in either RO position. Your disk may or may not be Read-Only, depending on whether the disk manufacturer requires a power shutdown to change from Read/Write to Read-Only.

INSTALLING DISK MODULE



NOTE: The disk module can be installed with the disk module handle in any of its five positions and the function switch in any of its four positions. However, it is recommended that the bandle be pulled out and that the function switch be in an unlocked mode. If the disk module is plugged into the docking base with its bandle in Position 1, the bard disk will immediately start to spin up.

Although the handle does not have to be used for supporting the module during installation, it is designed as an installation aid by holding the entire weight of a loaded disk module in any position.

It allows the disk module to be held with one hand so that it can be guided into the docking base with the other hand.

With the handle extended from the disk module, grasp the handle and guide it into the docking base.

Push firmly on the disk module front panel until the disk module is fully seated.

You will hear a snap or a click that indicates the module latch locking mechanism is engaged.

The center active light (green LED) on the front panel will blink, indicating that there is power going to the disk module.



POWERING UP THE HARD DISK

The disk module handle is the on/off power switch for the hard disk drive. When the handle is pushed fully in, power is applied to the hard disk drive inside the disk module.

The hard disk will spin and the light green power LED will illuminate, staying illuminated as long as the handle is fully in.

When there is power going to the disk module, the SCSI Identification (ID) number appears in a window above the function switch on the disk module front panel.

At the top of that window is a small hole in the panel. To set or change the SCSI ID, use a small blunt-end probe and gently but firmly press the switch that is behind the panel. Each push (click) advances the ID by one number.

SETTING THE SCSI ID



NOTE: It is important that each disk module be given an ID

(from 0 through 6) that is not used by any other Z

Microsystems' disk module on the same bus, or any other device, such as a tape drive or CD-ROM that may already be on the bus.



NOTE: Depending on the computer of the host computer, the choice of ID number for the TranzPak 6 disk module may be limited. Some operating systems reserve certain ID numbers for disk drives. Consult the computer's User Guide if the initial ID setting is not recognized by the host operating system.



NOTE: The bost computer may or may not recognize the addition of a device on the SCSI bus. The computer may have to be rebooted after adding a new device. Refer to the operating system manual.



FUNCTION SWITCH ELECTRICAL DESCRIPTION



NOTE: Some disk manufacturers require that the power to the disk be cycled after setting it to a write-protect mode in order to use the write-protect feature. The only way to determine if the disk requires power-down to change to Read-Only is to turn the function switch to a RO position, then try to write to the disk.

The function switch has four positions:

- Two Read/Write (RW). The hard disk can be fully accessed by the host computer. There is no front panel LED to indicate this position.
- Two Read-Only (RO). The orange Read-Only LED will be lit.

FUNCTION SWITCH VERSIONS

The function switch has two modes:

- Handle locked
- Handle unlocked

The function switch also has two versions:

- Knob
- Key lock

The switch functions identically in both versions. The only difference is that with the key lock version, a key is required to be inserted into a lock in order to change the position of the switch.

LOCKING THE DISK MODULE AND HARD DISK

On the disk module front panel on each side of the word SECURITY there are small padlock icons.

The left icon indicates an unlockedhandle mode when the function switch is in one of its two left positions (either RW or RO). The right icon indicates a locked-handle mode when the function switch is in one of its two right positions (either RW or RO).



LOCKING THE DISK MODULE AND HARD DISK

When the function switch knob is in either the left two disk accessing positions, the disk module handle can be moved freely from being Fully In to power the hard disk, to being Fully Out to remove power from the hard disk drive and to remove the module from the docking base.

When the function switch knob is in either of the right two positions, the disk module handle is locked and cannot be moved. The disk module is locked in the docking base, and the hard disk is locked in either a powered or unpowered state (depending on the position of the module handle).

In either a Read/Write or Read-Only disk accessing state (depending on the position of the function switch).

The main reasons for using a locked position are to prevent unauthorized reading and/or writing to the hard disk, and unauthorized removal of the disk module.

Depending on the module handle position, the hard disk drive can be locked with or without power.

Both the knob and key lock version of the function switch operate in the same way. The only difference is that with the key lock version, a key is needed to change all positions of the function switch. When the key is removed, the function switch position cannot be changed.



WARNING: Be sure to return the function switch to the unlocked mode before attempting to remove the disk module.



OPERATING THE DISK MODULE



NOTE: Refer to the operating system

User Manual for the

operation of the specific hard

disk drive



NOTE: Depending on the bost operating system, the computer may or may not have to be rebooted after adding a new device. Refer to the operating system User Manual.

Once the hard disk is operational and set to the desired mode, it is ready to be used on the SCSI bus.

POWERING DOWN THE HARD DISK



WARNING: Do not attempt to pull
the bandle further out while
the red wait LED flashes.
Movement of the disk
module could cause physical
damage to the bard disk.

Before the disk can be powered down, the disk module handle must be moved from the Fully In position to the In position.

The Power/Wait LED changes color from green to red and begins to flash indicating wait. There is also a single short tone, which is an audible acknowledgment that power was removed from the hard disk drive.

The flashing red light will remain for about 15 seconds, which is the time-down or spin-down period. The light then will go out

REMOVING THE DISK MODULE

When the red Power/Wait LED extinguishes, the green center Active/Remove LED will start to blink, indicating that the disk module can be safely removed from the docking base. Pull the handle Fully Out.

The handle is designed to require a firm pull in order to prevent accidental removal of the disk module. The module will disengage from the docking base and can now be removed.





CARRYING THE DISK MODULE

The handle can be used to carry the disk module. No special precautions are needed.

INSTALLING YOUR OWN HARD DISK DRIVE

Internal Access

OPENING THE ZX STATION

One of the many design features of the ZX Station is the ease of access to the inside of the processing unit. To open the ZX Station in the rack, perform the following steps:



Be sure the power switches on the front and back are off. Disconnect all the cables from the back of the ZX Station to their respective units.



Remove the four ovalhead Phillips screws on the corners of the front panel and sliding the ZX Station all the way out.



Slide the ZX Station out until reaching the safety stop.



Remove the four pancakehead Phillips screws on the bottom of the ZX Station (upper two and lower right two).



Remove the six panhead Phillips screws on the sides of the top lid.



Remove the two pancakehead Phillips screws on the top front of the ZX Station lid.



Disconnect cables to components inside ZX Station.



Carefully lower the front panel.



The entire inside and back of the front panel of the ZX Station is now accessible.

CLOSING THE ZX STATION

To close the ZX Station, reverse the above steps:

Maintenance

CLEAN FRONT PANEL

WARNING: Be sure to turn off the
power before performing any
maintenance on the ZX
Station

- Gently wipe the front panel of the ZX Station with a soft cloth.
- Remove finger marks and grease with a damp cloth and mild detergent. DO NOT use solvents or abrasives.
- Never use flammable cleaning material to clean the front panel of the ZX Station or other electrical apparatus.

Troubleshooting

FRONT PANEL

- · Power light does not illuminate
- Check that power cable is properly connected to 110 vac power supply.
- Check that front panel power switch is on
- Check that power switch on back of ZX Station next to power plug is on.
