Attaching the Jack Box



- Slide the Viewfinder backward to its fully extended position and then tilt it upward.
- 2 Insert the Jack box and slide it down until it locks with a click.

Things You Should Know

Charge the Battery Pack



Connect and plug in the cables as shown.

- POWER Lamp will light.
- Disconnect DC Cable if it is connected to AC Adaptor.

Attach the Battery as shown to charge.

• Charge lamps on the AC Adaptor will flash and then turn solid green to indicate current charge level. When all 3 lamps are constantly on, the battery is full charged. (approx. 1 hour 20 minutes) Expect approx. 1 hour of operation when fully charged.

BRemove the Battery.

Slide the Battery out and then lift up.

About the Charge Lamps

- The three Charge Lamps "50%", "80%" and "100%" flash and then remain lit one after another to indicate hpw mich the Battery has been charged. When all three lamps are lit, charging is finished.
- The Charge Lamp give a good approximate indication of the charging condition under normal ambient temperature. However, when charging at high or low temperature, it may differ considerably from the actual charging condition.
- When you charge two Batteries, charging starts from Battery 1. At this time, the Charge Lamps for Battery 2 show the remaining charge of Battery 2. (If the remaining charge is less than 50%, no ChargeLamp is lit.)

About the Flashing of the Charge Lamps

- The flashing <u>of all three Charge Lamps</u> indicates that the temperature of the Battery or the ambient temperature is too high or too low for charging. Charge the Battery at an ambient temperature between 10°C and 30°C.
- When the Charge Lamps areflashing slowly: The Battery is being charged, but charging takes longer than normally.
- When the Charge Lamps areflashing slowly: Charging is not possible. Remove the Battery once and wait a short time, then re-attach it again for charging.

Supplying Power

AC Adaptor



Insert the DC Cable into the Jack Box.

Connect the other end of the DC Cable to the AC Adaptor as shown.

3Plug in the AC Adaptor.

• The POWER Lamp lights up.

Note:

• When not in use, unplug the AC Adaptor from the AC outlet. (AC Adaptor consumes 1W of electric power when plugged into an AC outlet even when not in use.)

About the AC Adaptor

- When the 50% and 100% Charge Lamps flash alternately, or when the Charge Lamps do not light, remove and then reattach the Battery. Or, attach the Battery to the Palmcorder, use it for 10-20 minutes, and then re-attach the Battery to the AC Adaptor. If it still cannot be charged, consult with your dealer.
- When the Battery is hot, charging takes longer than normally.
- If you remove and re-attach the Battery during charging, the lit Charge Lamp may change, but this is normal.
- If you remove and re-attach the Battery during charging, the Charge Lamp may go off momentarily while the AC Adaptor is checking the change remaining in the Battery, but this is normal.

- Even if you connect the AC Cable (or the Car Adaptor) during charging, the Charge Lamps will keep flashing for a while and indicate the charging condition.
- If you use the AC Adaptor very close to a radio while listening to a broadcast (especially in the AM range), the reception may be distored by interference. Use the AC Adaptor more than 1 meter away from a radio.
- During use, the AC Adaptor may emit some sound, but this is normal.
- After use, be sure to disconnect the AC Cable from the AC outlet. (If it is left connected, approximately 1W of power will be consumed.)
- It may take a short time before the AC adaptor's POWER Lamp lights, but this is normal.
