Operation: 5 °C to 35 °C {41 °F to 95 °F} Storage: -20 °C to 60 °C {-4 °F to 140 °F}



Avoid Direct Sunlight on the LCD Panel

The LCD panel should not be exposed to direct sunlight or ultraviolet light.



Avoid Humidity, Liquids and Dust

Do not store or use the computer in locations exposed to high humidity, liquids (including rain) or dust.



Prevent Shock

Avoid subjecting the computer to severe vibrations or impact. Do not place the computer inside a car trunk.



Avoid Radio Frequency Interference

Do not place the computer near a television or radio receiver.



Avoiding low-temperature burns

Avoid more than casual contact with any heat producing area of the notebook computer, AC adaptor, and any option or accessory you use with it. Even low heat, if warmer than body temperature, can cause a burn, if the skin is exposed to the heat source for a long enough period of time.



Do not touch the AC plug and modem telephone cable when it starts thundering.



Keep SD memory cards and MultiMedia cards (both sold separately) away from infants and small children

Accidental swallowing will result in bodily injury. In the event of accidental swallowing, see a doctor immediately.

Handling



Avoid Magnetic Fields

Keep the computer away from magnets. Data stored on the hard disk may be lost.



Avoid Stacking

Do not place heavy objects on top of the computer.



Keep Small Objects Away

Do not insert paper clips or other small objects into the computer.



Do Not Disassemble the Computer

Do not attempt to disassemble your computer.



Avoid Excessive Force on the Display

Do not apply excessive downward force on the display.

Precautions (Battery Pack)

 Care should be exercised with regard to the following in order to avoid the possibility of overheating, fire or damage.



Avoid Heat

Do not throw the battery pack into a fire or expose it to excessive heat.



Keep Articles Away

Do not place the battery pack together with articles such as necklaces or hairpins when carrying or storing.



Do Not Disassemble

Do not insert sharp objects into the battery pack, expose it to bumps or shocks, deform, disassemble, or modify it.



Do Not Short

Do not short the positive (+) and negative (-) contacts.



Avoid Extreme Heat, Cold and Direct Sunlight

Do not charge, use or leave the battery pack for extended periods where it will be exposed to direct sunlight, in a hot place (in a car on a sunny day, for example), or in a cold place.



Do Not Use With Any Other Computer

The battery pack is rechargeable and was intended for the specified computer. Do not use it with a computer other than the one for which it was designed.



Do Not Put into a Microwave

Do not put the battery pack into a microwave oven or a pressurized chamber.



Stop Using

Should the battery emit an abnormal odor, become hot to the touch, become discolored, change shape, or become in any way different from normal, remove it from the computer and stop using it.

- Do not touch the terminals on the battery pack. The battery pack may no longer function properly if the contacts are dirty or damaged.
- Do not expose the battery pack to water, or allow it to become wet.

- If the battery pack will not be used for a long period of time (a month or more), charge or discharge (use) the battery pack until the remaining battery level becomes 30% to 40% and store it in a cool, dry place.
- This computer prevents overcharging of the battery by recharging only when the remaining power is less than approx. 95% of capacity.
- The battery pack is not charged when the computer is first purchased. Be sure to charge it before using it for the first time. When the AC adaptor is connected to the computer, charging begins automatically.
- Should the battery leak and the fluid get into your eyes, do not rub your eyes. Immediately flush your eyes with clear water and see a doctor for medical treatment as soon as possible.

NOTE

- The battery pack may become warm during recharging or normal use. This is completely normal.
- Recharging will not commence outside of the allowable temperature range (0 °C to 55 °C {32 °F to 131 °F}). (Reference "Battery Power") Once the allowable range requirement is satisfied, charging begins automatically. Note that the recharging time varies based on the usage conditions. (Recharging takes longer than usual when the temperature is 10 °C {50 °F} or less.)
- If the temperature is low, the operating time is shortened. Only use the computer within the allowable temperature range.
- The battery pack is a consumable item. If the amount of time the computer can be run off a particular battery pack becomes dramatically shorter and repeated recharging does not restore its performance, the battery pack should be replaced with a new one.
- When transporting a spare battery inside a package, briefcase, etc., it is recommended that it be placed in a plastic bag so that its contacts are protected.
- Always power off the computer when it is not in use.
 Leaving the computer on when the AC adaptor is not connected will exhaust the remaining battery capacity.







CAUTION

Read the steps below to help you learn what parts are included, and to gain an understanding of some basic computer-related operations.

1 Confirm the inclusion of all parts.

Make sure the parts shown in the figure have been supplied. If any of these items are missing or is not working properly, contact your technical support office (page 45).





Resetting the password


Windows XP has a function to reset a forgotten password.

To use this function, you need to create a password reset disk beforehand following the steps below.

- 1 Connect the USB floppy disk drive (optional: CF-VFDU03) to your computer.
- 2 Select [start] [Control Panel] [User Accounts].
- **3** Select [Prevent a forgotten password] from [Related Tasks] menu of the account you used to logon and create a password reset disk following the on-screen instructions.

Store the password reset disk in a safe place.

• Only the logon password for each account can be reset. The password set in the Setup Utility cannot be reset.



NOTE

• The power saving function is factory set, so if there is no input from a key, the touch pad or an external mouse (when one is connected) for a certain interval of time, the power to the LCD and hard disk may be turned off. The LCD will resume operation when the touch pad or an external mouse (when one is connected) is used or a key is pressed.

The power to the LCD may be turned off even when an application software is being installed. In this case, because it is conceivable that a selection dialog box will be shown, do not press **Space** or **Enter** to attempt to resume from this condition as doing so may trigger a selection, but instead, press a key unrelated to the direct triggering of a selection, like **Ctrl**.

In addition, when the computer is left alone, it automatically enters the standby or hibernation mode ("Standby/Hibernation Functions"). The computer will resume by sliding the power switch.

Enter Password []

If the screen on the left is displayed immediately after you turn on the power...

A password has been set to ensure the computer's security.

Enter your password*1 and press Enter . (Reference "Security Measures")

- When the correct password is input, the computer will start.
- When three incorrect password attempts or nothing is input for one minute, the computer will power off.
 - *1 Supervisor Password or User Password set in the Setup Utility (not the Windows password).

Starting Up/Shutting Down

Shutting Down (power off your computer)

- **1** Save important data and close each application.
- **2** Select [start] [Turn Off Computer].
- 3 Select [Turn Off].

Your computer will power off automatically.


- Restarting your computer (without shutting down): Select [Restart].
- To shut down using the keyboard:
 Press (♣), (U), and select [Turn Off] with (→) (♠) (♠) (♠), then press (Enter).

CAUTION

- Do not do the following during the shutdown/restart procedure.
 - Connecting or disconnecting the AC adaptor.
 - Touching the power switch.
 - Performing any keyboard, touch pad or external mouse operations.

When you leave the computer or interrupt your work...

If you use the "Standby" or "Hibernation" function, then when you turn on the power next time, the application software and files you were using before will be displayed, and you can restart the same operations. (Reference "Standby/Hibernation Functions")

Important Tips provides information on how to maximize use of the battery pack, which is necessary for computing away from your home or office.

How to access the Important Tips

Select on the desktop.

Important Tips can also be accessed from [start] - [All Programs] - [Panasonic] - [On-Line Manuals] - [Important Tips].

When the Reference Manual or Important Tips is accessed for the first time, the License Agreement of the Acrobat Reader may be displayed. If it is displayed, after reading the agreement, select [Accept] to access the Reference Manual or Important Tips.

NOTE]

- Illustrations may be difficult to view depending on the magnification. If the illustration is too small, magnify the display.

CAUTION

• RAM modules are extremely sensitive to static electricity. There are cases where static electricity generated by the human body has adversely affected such modules. When inserting or removing a RAM module, do not touch the terminals or internal components, insert objects other than the module, or allow foreign particles to enter. Doing so has been known to cause damage, fire or electric shock.

Maintenance

Display (LCD)

Avoid using water when cleaning the panel. Ingredients included in water may leave scratches and reduce readability of the screen.

<When cleaning dust/dirt>

Avoid rubbing off dust/dirt with cloth since it may leave scratch on the screen.

Sweep dust/dirt with fine brush, then wipe it with a dry soft cloth used for cleaning glasses.

<When cleaning oily surface>

Apply camera lens cleaner on a soft gauze and clean it with gentle force. Then, wipe with a dry soft cloth used for cleaning glasses.

When areas excluding the display/the touch pad become dirty:

Wipe these areas with a soft cloth, after applying water or detergent diluted with water to the soft cloth and firmly wringing out excess water.

CAUTION

- Do not use benzene, thinner, or rubbing alcohol. Doing so may adversely affect the surface, e.g., discoloration. In addition, do not use commercially-available household cleaners and cosmetics, as they may contain components harmful to the surface.
- Do not directly add or spray water or detergent. If liquid enters the inside of the computer, it may cause it to work improperly or be damaged.

Useful Information

Saving Data on the Hard Disk

- Do not expose your computer to shock.
 - Use care when handling your computer, shock may damage your hard disk or make your software applications and data unusable.
- Do not power off your computer while software applications are running or hard disk drive indicator
 is is on.
 - Properly shut Windows down to avoid problems.
- Save all valuable data to discs.
 - Backing up data to discs will limit damage should trouble occur to your computer or should you inadvertently change or erase data.
- Use the security function for all important data. (Reference "Security Measures" and "SD Memory Card Security Function")

Hard Disk Lock

When the Hard Disk Lock is set to [Enable], it is impossible to read/write data from/to the hard disk when the hard disk is installed in a different computer, since a password is also set for the hard disk. When the hard disk is returned to the original computer, you can read/write data as before. In this case, however, make the settings in the Setup Utility exactly the same as they were before the hard disk was removed. (Note that this Hard Disk Lock does not guarantee the complete protection of data.) (Reference "Security Measures")

When Using Peripheral Devices

Pay strict attention to the following points to avoid damage to the computer, peripheral devices, cables, etc. Also, in addition to following this manual and the Reference Manual, carefully read the instruction manuals for the peripheral devices being used.

- Use only peripheral devices that conform to the computer's specifications.
- Connect the devices properly, paying close attention to the condition and position of the connectors.
- If a connection cannot be made easily, do not apply undue force; check once more to confirm the condition and position of the connector (alignment of pins, etc.).
- If the connector has holding screws, fasten the screws firmly.
- Do not carry the computer with cables attached, and do not pull on the cables forcefully.

When Disposing of or Transferring Ownership of This Device

When disposing of or transferring ownership of this device, erase all data on the hard disk in order to prevent the theft of hard disk data. Even if you delete data or initialize the hard disk through normal Windows commands, data can still be read using special software. In order to erase all data, either have the data erased by a specialist (at a charge) or use the hard disk data erase utility (included) (page 42). (Note that this hard disk data erase utility does not guarantee that data will be completely erased.)

Also, note that if you transfer ownership of this device without deleting commercial software that you have installed to the hard disk, you may be in violation of the licensing agreement for that software.

When Changing Hard Disk Partitions

When using the hard disk backup function, divide into the partition when the backup area is created (page 38). If you divide up the hard disk before creating a backup area, the backup area cannot be created.

Security of the Computer

To improve the security of the computer, use the following measures.

- Use antivirus software (commercially available).
- Use Windows XP Internet Connection Firewall.
- Update Windows (below).
- Getting the newest information about security from the Website of Microsoft Corp. etc.

Using Antivirus Software

Especially in the following cases, we recommend you to perform a virus check.

- Be sure to use the most up-to-date antivirus software when checking for viruses.
- After booting your computer.
- After receiving data.

We recommend that you check data received on disks or from external sources, such as data downloaded from the network, Internet, e-mail, etc. (For compressed files, decompression may be required before running a check.)

Using Internet Connection Firewall

An Internet Connection Firewall protects a computer from unlawful access via the Internet etc. Make the settings by the following methods.

- **1** Select [start] [Control Panel] [Network and Internet Connections] [Network Connections].
- **2** Select the icon of the connection you want to protect, from LAN, a modem or a high-speed Internet category, with the right button, and select [Properties].
- **3** Select [Advanced], add the check mark to [Protect my computer and network by limiting or preventing access to this computer from the Internet] of [Internet Connection Firewall], and select [OK].

If there are two or more methods of connecting to the Internet, repeat steps **2-3** of the procedure for each connection.

NOTE

- Some network-related software and some online network games do not operate normally if the Internet Connection Firewall is enabled. Ask the software manufacturer about the Internet Connection Firewall in the case of using such software.
- For further details of the Internet Connection Firewall, select [start] [Help and Support] and input [Internet Connection Firewall] into [Search], and see the help displayed.

Windows Update

Windows Update enables you to update Windows on your computer by applying the latest patches and service packs for Windows.

Connect the Internet and perform it from [start] - [All programs] - [Windows Update].

Do not apply "Driver Updates" even if a message to update a driver appears. If a driver update is required, contact your technical support office (page 45).

- Be sure to perform Windows Update after reinstallation (page 34).
- The installed patches can be confirmed in [start] [Control Panel] [Add or Remove Programs].


Wireless LAN

- To prevent theft of data or unauthorized access to the hard disk via a wireless LAN. If you plan to use wireless LAN functions, we recommend that you do so only after making the appropriate security settings, such as for encryption.
- For instructions on settings for wireless LAN and cautions during use, select [start]-[Reference Manual], and refer to "Wireless LAN".
- Before using a wireless LAN, turn the wireless LAN on using the following method (at the time of purchase, the wireless LAN is set to [Off]).
 - 1 Double-click on the taskbar.
 - 2 Select your wireless LAN adaptor and select [General].
 - 3 Select [On] for [Switch radio].
 - 4 Select [OK].

DVD-ROM & CD-R/RW Drive



Before using the drive

When using the drive for the first time, slide the open lever (A) on the left side of the computer to open the disc cover after the computer has been powered on, and remove the protective sheet (B) from the lens area.

• Do not expose the DVD-ROM & CD-R/RW drive to excessive smoke that may leave a residue, e.g. oil smoke, or tobacco smoke. Doing so could shorten the life of the drive lens.

When opening/closing the disc cover

- When the computer is on, be sure to use the open lever on the left side of the computer or perform the ejecting operation through Windows.
 - When a using B's Recorder/B's CLiP: Reference "B's Recorder/B's CLiP"
- When closing the disc cover, press down near the power indicator **()** (position of the arrow) to ensure that the cover is locked.
- Do not access the drive until after the disc cover is closed and the DVD-ROM & CD-R/RW drive status indicator is off.
- To remove a disc when the disc cover cannot be opened or when the computer is powered off:
 - Insert a pointed object (e.g., the bent-out tip of a paper clip, or the tip of a ballpoint pen) into the emergency hole (C), and then move in the direction of the arrow.
- The disc cover can be opened up to an angle of 70 degrees. Do not force the cover open any further.
 - If a hand etc. touches the disc cover and accidentally opens wider than 70 degrees, pull it forward slowly until the stopper holds the cover in its proper position.
- Do not leave the disc cover in the open position or touch the lens.
 Under some conditions, dust may build up on the lens, or on a disc. This may result in a read or write malfunction.

List of Error Codes

When turning on the computer, if one of the following error codes or messages is displayed, follow the instructions shown below. If the problem persists, or if the error code or message displayed is not shown here, contact your technical support office (page 45).

Error Code/Message	Action
0211: Keyboard error	If an external keyboard or mouse is connected, disconnect these devices.
0251: System CMOS checksum bad - Default configuration used	An error has occurred in the memory that stores the Setup Utility settings. This error occurs when the memory content is changed through some inadvertent operation by a program or other function. Run the Setup Utility and load the default values, then change the settings to the appropriate values as needed. If the problem persists, the internal clock battery may need to be replaced. Contact your technical support office.
0271: Check date and time settings	 The date and time setting are incorrect. Run the Setup Utility and set the date and time correctly. If the problem persists, the internal clock battery may need to be replaced. Contact your technical support office.
0280: Previous boot incomplete - Default configuration used	Startup has failed repeatedly, so the Setup Utility settings have been returned to their default values, and the computer has been booted. Run the Setup Utility and load the default values, then change the settings to the appropriate values as needed.
Press <f1> to resume, <f2> to Setup</f2></f1>	• Write down the error details and press F2 to run the Setup Utility. Confirm the settings, and change the settings to the appropriate values as needed.
Operating System not found	 The OS is not properly installed on the floppy disk or the hard disk that you are trying to boot from. By backing up the data on your hard disk to a backup area, you can protect your data from loss or damage resulting from operational errors or other factors. Also, you can back up or restore hard disk contents using this computer alone, without having to use other media or peripheral devices.

At the time of purchase, the hard disk backup function is disabled. If you follow the procedure below to create a backup area, the hard disk backup function will be enabled, and you will be able to back up your data. Note, that once the backup function has been enabled, you will have to perform the reinstallation procedure to disable it again (page 34).

The hard disk backup function cannot back up or restore data properly if there is a problem with the hard disk when the data is backed up or restored. Note that if an error occurs while data is being restored, whether as a result of an unexpected malfunction, incorrect operation, or other reason, the data in the hard disk (data before restoration) may be lost.

Preparing

You will need the Product Recovery DVD-ROM (included).

Before Using a Hard Disk Backup Function

- Disconnect or remove all peripheral devices, SD memory cards, and MultiMedia Cards. Take
 care to disconnect the USB floppy disk drive, as the backup area may not be created properly
 while these devices are connected.
- Be sure the AC adaptor is connected to the computer.
- A backup area cannot be created if the hard disk is already divided into several partitions. Return
 the computer to its condition at the time of purchase (one partition only), and create the backup
 area.
- To divide the partition, make the selection when the backup area is created (page 39 step 7).
- If the partition configuration is changed (partitions created, size changed, etc.) after the backup area has been created, it will no longer be possible to execute the backup function. To change the configuration, it is necessary to return the computer to its condition at the time of purchase, and then create the backup area again.
- The hard disk backup function will only work for the internal hard disk. This function does not work with an external hard disk.
- Backup and restore functions will not operate if the hard disk has been damaged.
- Do not use the NTFS file system compression function, as this may result in insufficient capacity of the backup area.
- If the hard disk malfunction occurs, it will be impossible to read the data stored hard disk. We recommend that you also back up important data to a location other than the hard disk (an external hard disk or other media).
- Execute a disk error check using the following procedure.
 - 1 Display the [Local Disk(C:) properties]. Select [Local Disk(C:)] with the right button in [start] - [My Computer], and select [Properties].
 - 2 Select [Check Now] from [Tools].
 - **3** In [Check Disk], select [Start] without adding a check mark beside any of the items. If a message is displayed indicating that there is an error in the disk, display [Check Disk], and add a check mark for [Automatically fix file system errors] and [Scan for and attempt recovery of bad sectors], select [Start], and check for disk errors again.
- The hard disk backup function does not accommodate dynamic disks. Do not convert the hard disk to a dynamic disk.

NOTE

- Regarding backup area
 - Requires availability of at least half of the entire hard disk. Without sufficient space available, the backup area cannot be created.
 - When the backup area is created, the usable hard disk capacity will be reduced to less than half.
 - The backup area cannot be accessed from Windows. For this reason, backed up data cannot be copied to CD-R or other removable disk media.
 - When the hard disk backup function is executed, data in the backup area will be overwritten. If newly created or edited data is backed up later, data stored previously in the backup area will be lost.






