#### DESCRIPTION

The PVM™ 357 is actually an integrated SYSTEM for reproduction of drums and other musical instruments. The system consists of two parts — the tiny microphone and a compact preamp which includes a five-band graphic equalizer.

The PVM 357 microphone is a very small cardioid condenser attached to a miniature flexible arm. This microphone features a broad frequency response — and the ability to cleanly reproduce extremely loud sounds, as high as 148 dB SPL.

The very uniform directional pattern effectively rejects "bleed" from other instruments and monitors, to assure that reporduction remains clean and uncolored.

The compact PVM 357 preamp features an easily adjustable five-band graphic equalizer, which allows the performer to "zero in" on the desired sound — even to make quick changes for different effects.

An EQ bypass switch is included to make it easier to judge the effect — or to switch an effect in and out.

The preamp also features a "Trigger Out" connector for easy connection to a drum synthesizer or other device. This output is on a separate 1/4" jack and isolated from the balanced microphone output.

The PVM 357 system is readily powered by any 48-52 volt phantom supply through a normal balanced microphone cable. The PVM 357 microphone includes a 10' miniature cable with a small, but rugged, connector for interfacing with the preamp/EQ unit.


A drum mounting adapter is supplied for mounting the microphone to snares or toms. An adapter is also included for conveniently mounting the preamp/EQ to the bass drum rim, if desired.

The PVM 357 system includes a hard-shell case for convenient carrying or storage.


With its unique combination of features, exceptional versatility and striking performance the PVM 357 may well set the new standard for dum miking — and many other instrumental applications as well.




EQ Response Individual Sections (+6 and - 6 dB) Fig. 2





Summed Response (All +6 dB, All -6 dB))







#### PVM 357 HORIZONTAL POLAR PATTERNS 5 dB per division














## PEAVEY MICROPHONE LIMITED WARRANTY/REMEDY
