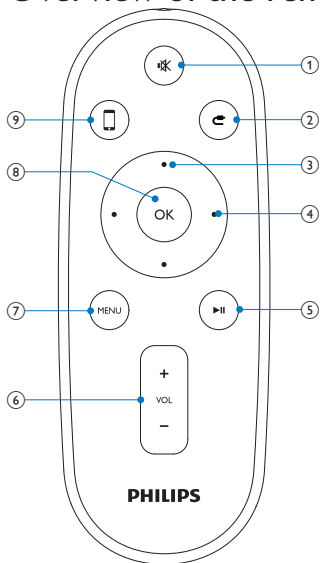

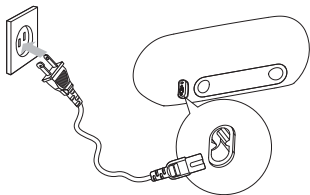
Connect power

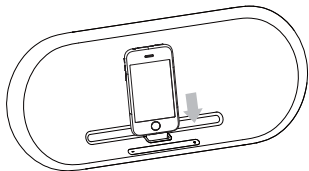

Load the iPod/iPhone
