

GAIN (1)

Varies the gain of the channel input stage to allow a wide input dynamic range. Proper adjustment of the input gain will maximize the signal to noise ratio.

HIGH EQ (2)

A shelving type of active tone control that varies the high (treble) frequency range ±15 dB.

LOW EQ (3)

A shelving type of active tone control that varies the low (bass) frequency range ±15 dB.

AUX 1 (4)

Adjusts the level of the channel signal added into the Aux 1 mix. This control is post fader.

AUX 2 (5)

Adjusts the level of the channel signal added into the Aux 2 mix. This control is post fader.

PAN (6)

Assigns the channel to any position in the Left-Right stereo field. For mono operation, the channel should be assigned to the Left or Right mix. On channels 7 - 14, this control functions as a balance control for the paired channels if a stereo signal is applied to the Left and Right input jacks. It is a pan control for mono inputs.

CHANNEL LEVEL (7)

Sets the level of the channel to the Left and Right mixes. The detent (channels 1 - 6) is at the 0 dB (unity gain; mid position) point to assure an optimum balance between noise and headroom.

STEREO RETURN 1 LEVEL (8)

Adjusts the level of the Stereo Return 1 that is added into the Left-Right mix.

STEREO RETURN 2 LEVEL (9)

Adjusts the level of the Stereo Return 2 that is added into the Left-Right mix.

TAPE INPUT LEVEL (10)

Adjusts the stereo level of the Tape signal added to the Left-Right mix.

LED METER ARRAYS (11)

Two 12 point LED arrays are provided to visually indicate the levels of the Left and Right mixes. The clip LED lights when the levels reach +12 dBV, 6 dBV below the actual clip level as a warning of loss of headroom.

MASTER (12)

This adjusts the master level for the Left and Right mix, and sets the overall output levels of the Left and Right output jacks.

HEADPHONE LEVEL (13)

Adjusts the level of the Left and Right signals to the headphone jack. This signal is independent of the Master Level Control. (pre-fader)

LINE INPUT (14)

High impedance channel input designed for unbalanced high level signals equipped with a 1/4" phone plug.

LOW Z MIC INPUT (15)

Channel input designed for use with a balanced low impedance mic or low level source equipped with an XLR connector.

PATCH (16)

A stereo jack that breaks the signal before EQ to allow for an external compressor or graphic EQ to be inserted into the channel. Tip = Send, Ring = Return.

STEREO LINE INPUT, LEFT/MONO (Channels 7, 9, 11, 13) (17)

A high impedance input for devices having a high level output and 1/4" phone plugs. Mono inputs should be connected to this input. It supplies a signal to both the Left and Right mix of corresponding channels, which can be positioned by the channel Pan control. If a stereo input is used, the Left output should be connected to this jack.

STEREO LINE INPUT, RIGHT (Channels 8, 10, 12, 14) (18)

A high impedance input for devices having a high level output and 1/4" phone plugs. When a stereo device is connected, the Right output from the device should be connected to this jack. (See Left/Mono Return.)

RETURN 1, LEFT/MONO (19)

Mono effect devices connected to the Aux 1 output may be returned at this point. This input supplies a mono signal to both the Left and Right mix if there is no plug connected to the Return 1 Right jack. When a stereo effects device is connected, its Left output should be returned to this jack.

RETURN 1, RIGHT (20)

When a stereo effect device is connected to the Aux 1 output, the Right output from the device should be returned to this jack. (See Left/Mono Return.)

RETURN 2, LEFT/MONO (21)

Mono effect devices connected to the Aux 2 output may be returned at this point. This input supplies a mono signal to both the Left and Right mix if there is no plug connected to the Return 2 Right jack. When a stereo effects device is connected, its Left output should be returned to this jack.

RETURN 2, RIGHT (22)

When a stereo effect device is connected to the Aux 2 output, the Right output from the device should be returned to this jack. (See Left/Mono Return.)

AUX 1 OUT (23)

Output of the Aux 1 mix to external effects or signal processing equipment. The level is set by the Aux 1 signals from the channels.

AUX 2 OUT (24)

Output of the Aux 2 mix to external effects or signal processing equipment. The level is set by the Aux 2 signals from the channels.

LEFT OUTPUT/RIGHT OUTPUT (25)

These are the outputs of the Left-Right mix that are adjusted by the Master fader.

TAPE INPUT JACKS (26)

Receives a line level stereo input from the output of a tape deck or CD player.

TAPE OUTPUT JACKS (27)


Provides stereo signal to the Left and Right input of a stereo tape deck. The level is a 10 dB attenuation of the Left and Right output signals.

POWER SWITCH and LED (28)

Press toward LED to turn on. LED will illuminate when power is on.

HEADPHONE JACK (29)

This stereo jack provides signal to drive stereo headphones. Tip = Left, Ring = Right.



PHANTOM POWER (30)

Press to enable 48 V phantom mic power to all input XLR connectors.
