

# HS-MP Series Mounting Plate

## Installation Instructions

## Introduction

The HS-MP series of mounting plates are for use with the DSC Concourse Home Systems modules and DSC Power and Maxsys security system products. The Concourse modules and kits include the mounting plates. To install DSC security products in Concourse cabinets one of these plates is required. A wide variety of Power and Maxsys products can be accommodated by the three plate sizes.


## **Contents of Package**

The package contains the following parts:

- Four HS-MP200 small plates, or
- Two HS-MP300 medium plates, or
- One HS-MP400 large plate.


## **Installation Instructions**

1. Insert the standoffs (not supplied) into the mounting plate as per Figure A, matching the hole pattern on the Concourse, Power or Maxsys module to be installed.





- 2. Align the module over the standoffs and snap into place.
- 3. Locate a suitable mounting location for the module inside the cabinet.
- 4. Align the two mounting tabs with the holes in wire raceway and insert as per Figure B.
- 5. Snap the module into place by pushing the opposite side towards the back of the cabinet.

Follow the wiring instruction included with the Concourse, Power or Maxsys module.
