Technical Considerations

Before you mount the adapter to a fixed location, consider the following:

- Determine optimal placement.
- Collect and document network information as required.
- Ensure the cable length from the Ethernet network source to the powered device does not exceed 100 meters.



Note: The unit is not a repeater and does not amplify the Ethernet data signal.




Caution: Observe the following requirements when mounting the Enterasys Single-Port Power Over Ethernet Adapter.

- Connect the unit to a grounding type AC outlet (100 -240) VAC), using the standard power cord or power supply supplied.
- Allow for easy access to disconnect the unit from the AC outlet, if necessary.
- Do not cover the unit or block the airflow with any other objects. Keep the unit away from excessive heat, humidity, vibration and dust.
- Installation must at all times conform to local regulations.
- There are no user serviceable parts inside the adapter. If support is needed, refer to "Getting Help" on page xvii.

Powering Up

Simply plug one end of the power cord or power supply into the unit, and the other end into a grounded AC power source. Units are typically connected to a power strip or other power outlet that may be cycled on and off. An uninterruptible power supply (UPS) may be used.

Description of LED Functions

Power-up Sequence

Upon power-up, all 3 LEDs will light for 2 seconds, as part of the self-test for the internal microprocessor software. After the end of the 2 seconds, the "ON" LED will illuminate green, signifying that the DC output voltage is available for powering a compliant load (to the 802.3af PoE standards).

Detection Sequence

Once a compliant load is attached to the output RJ45 connector, the green "CONNECT" LED will illuminate.

Should the load be non-compliant, then the LEDs will blink a code signifying the cause for non-detection.

Detection Failure Codes

- Incorrect resistive signature The green "CONNECT" and red "FAULT" LEDs will blink 3 times.
- Incorrect capacitive signature The green "ON" LED will 2. blink 3 times.
- Incorrect Voffset The green "CONNECT" and green "ON" 3. LEDs will blink 3 times.
- 4. Unstable current measurement The green "ON" LED will blink 3 times.
- Low voltage sensed during detection (overload) The red "FAULT" LED will blink 3 times.

After the LEDs blink 3 times the BL-69551ENT will continue to try to detect a valid load. Therefore, until the correct load is applied, the LEDs will continue to blink. If there is an open circuit connected to the output RJ45, then the LEDs will not blink but the BL-69551ENT will continue to try to detect a valid load.

Fault Sequence

Should there be a fault such as an overload or short circuit, then the red "FAULT" LED will illuminate. The red "FAULT" LED will illuminate for 2 seconds and then go off as the power supply tries to re-detect a valid load. If there is a problem in detecting, the LED will indicate what is wrong with the load as per the codes in the section above.
