

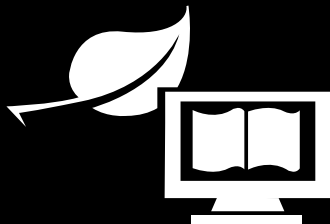

### Features

- 1.8 lb. (0.8 kg) load capacity for compact cameras or pocket video cameras
- Flexible legs can bend 360° to wrap around objects such as fences, tree branches, or chair legs
- Rubber non-slip feet for stability
- Protective foam shell around legs
- 1/4" mounting screw fits most cameras



Component	Description
Mounting screw	Secures your camera or camcorder to the tripod.
Ball head	Rotates to tilt camera horizontally and vertically.
Lock screw	Locks ball head in place.
Leg	Bends 360° to wrap around objects.
Non-slip foot	Provides extra grip on various surfaces.

## Using your tripod

- 1 Unscrew (turn counter-clockwise) the lock screw to release the ball head.
- 2 Align the bottom of your camera with the tripod mounting screw, then secure your camera by rotating the ball head counter-clockwise. Make sure that the screw is tight.
- 3 Move the ball head to point the camera into position, then screw (turn clockwise) the lock screw against the ball head to lock it in place.
- 4 Wrap all three tripod legs completely around a secure object or place on the floor or a tabletop.

**Caution:** Not wrapping the legs completely around an object, or attaching to an unsteady object, could result in damage to the tripod or equipment mounted on the tripod.

- 5 To remove your camera from the tripod, unscrew the lock screw to release the ball head, then hold the camera in place and rotate the ball head clockwise.

## Important safety instructions

- Do not store or expose your tripod to excessive heat or cold, or use near any flame or fire.
- Do not oil or grease any part of the tripod.
- Do not use any solvents or thinners to clean your tripod. Use only a mild detergent and wipe dry with a soft, lint-free cloth.
- Do not exceed the load limit (1.8 lb or 0.8 kg) of this product.
