Assembly Instructions

Step1

1.Use 4pcs screw (M6x15) to fix the left leg stand with the table frame; 2.Use 4pcs screw (M6x15) to fix the right leg stand with the table frame.



Step2

Use 4pcs screw (M6x15) to fix the fire wood bottom and the two leg stands.



Step 3

- 1. Use 1pc screw (M5x10) and 1pc M5 nut to fix the vent door under the bowl. Make sure the vent door can be operated smoothly.
- 2. Use 4pcs M6x10 screw =4pcs and 4pcs 6 mm washers to fix the two bowl's handles in the respective holes.



Step4

Fix M6 ring screw, M6 nut and the cover.

Step 5

- 1. Assemble the stand.
- 2. Place the fire bowl into the stand.
- 3. Place wood grate and cooking grate in fire bowl.
- Place table top on the fire bowl. Note: Please rotate the table top at 90 degrees if the table top does not sit flush in the fire bowl.
- 5. Place cover on table top.
- 6. Use fire tool to move cover.



Step 6 Fully assembled product.
