Cautions

- Avoid-using or placing this unit near sources of heat. Do not leave it in an automobile exposed to direct sunlight for a long period of time with the doors and windows closed, as this may deform the cabinet.
- If the set is not used for a long period of time, remove all the batteries to prevent potential damage due to possible battery leakage.

Listening caution





Do not play your headphones or earphones at a high volume. Hearing experts advise against continuous extended play.

If you experience a ringing in your ears, reduce volume or discontinue use. Do not use while operating a motorized vehicle. It may create a traffic hazard and is illegal in many areas.

You should use extreme caution or temporarily discontinue use in potentially hazardous situations.

Even if your headphones or earphones is an openair type designed to let you hear outside sounds, don't turn up the volume so high that you can't hear what's around you.

Sound can be deceiving. Over time your hearing "comfort level" adapts to higher volumes of sound. So what sounds "normal" can actually be loud and harmful to your hearing.

Guard against this by setting your equipment at a safe level BEFORE your hearing adapts.

To establish a safe level:

- Start your volume control at a low setting.
- Slowly increase the sound until you can hear it comfortably and clearly, and without distortion.

Once you have established a comfortable sound level:

Set the dial and leave it there.

Cassette tapes

Improper tape storage

You can damage tape if you store it in the following ways:

- In high temperature or high humidity areas
- In a strong magnetic field (near a speaker, on top of a TV, etc.)
- In direct sunlight

Cassette tapes exceeding 90 minutes

These tapes are handy for their long playback and recording time but be careful about repeatedly stopping and starting, rewinding and fast forwarding these tapes in short intervals as they are thin, tend to stretch and may become entangled in the deck mechanism.

Before Operation



Power source

Insert 2 AA size (R6/LR6 or equivalent, not included) batteries.

Batteries installed with incorrect polarities may leak and damage this unit.

Replace with fresh batteries of the same kind, observing polarity.

Battery life

When the batteries are weak, the tape speed will slow down, the sound will become distorted, and the volume will decrease.

Connecting the headphones B

Plug the included stereo headphones into the $\boldsymbol{\Omega}$ jack.

Tape Playback



Follow steps 1-4.

Play will be continued, looping forward and reverse side, until STOP is pressed. (Auto reverse)
You can use normal type of tapes only.

To stop playback Press STOP.

To fast forward and rewind

Press one of the **FAST** buttons ($\blacktriangleleft \bullet or \triangleright \bullet$). The tape will rapidly move in the direction of the arrow.

To change the tape direction

Press DIR to select the playback side, "FWD" (forward) or "REV" (reverse).

Notes:

- Do not open the cassette compartment cover during tape operation.
- If the SELECTOR is set to "RADIO" during tape operation, the button will not be released even though the motor has stopped. In this case, press STOP to release the button.
- •Between functions (during play, fast forward or rewind), always press **STOP** first to avoid jamming the tape.
- •When the tape reaches the end after fast forward or rewind, press **STOP** to release the **FAST** button.

Listening to the Radio

Changing the Tone



Follow steps 1-4.

To stop the radio

Set the SELECTOR to "TAPE OFF".

FM sensitivity selector

Normally set the **FM SENS** selector to "**DX**". When the FM reception is impaired, or there is interference from a powerful station, set the selector to "**LOCAL**".

• This selector does not function for AM reception.

Antennas

FM:

Since the headphones cord serves as the FM antenna, be sure to use it extended, not coiled. AM:

The built-in ferrite core AM antenna is directional. Turn the unit to obtain optimum reception. •Be sure to have the set in a horizontal position.



3 BAND EQUALIZER (TREBLE/MID/BASS)

Positioning the control to the "**HIGH**" side will amplify the corresponding controls: the "**LOW**" side will attenuate it.

XBS (Extra Bass System) Control

Set this control to "**ON**" to boost the dynamic bass range. You can enjoy the dynamic bass sound.

Maintenance



Head care

To ensure good sound quality for tape operation, be sure to clean the head after approximately every 10 hours of use with a cotton swab dampened with a little alcohol.

It is recommended that the head assembly be demagnetized if distortion or poor sound quality persists after cleaning the heads. Demagnetize them using a demagnetizer available from an audio store.

Main unit

Do not clean the plastic cabinet with benzine or thinner. Clean it with a cloth, dampened in a mild solution of soap and water. Avoid excessive moisture.

Avoid spray aerosol type cleaner. Some cleaners contain corrosive chemicals that may cause internal damage and cabinet deformation.

Troubleshooting Guide

Before requesting service for this unit, check the chart below for a possible cause of the problem you are experiencing. Some simple checks or a minor adjustment on your part may eliminate the problem and restore proper operation.

Problem	Checkpoint	Remedy
No operations.	Have the batteries been installed with their polarities (\oplus, \ominus) reversed?	Install them with their polarities (\oplus , \ominus) aligned properly.
No sounds.	Is the headphones plug connected to the headphones jack?	Plug the headphones plug into the jack.
No sounds during the tape playback.	Is the SELECTOR set to "RADIO"?	Set the SELECTOR to "TAPE
