DTMF Control Interface

Use your mobile phone to remotely turn on lights, adjust air conditioning, and arm/disarm security. Using standard Dual-Tone Multi-Frequency (DTMF) signals, the CEN-TIA affords telephone keypad control of any automation system function, providing a prompt-driven user-interface that is simple to use. Configuration software provided with the CEN-TIA makes it easy to set up a menu of friendly voice commands using the preloaded voice prompts, or your own custom audio files, for personalized remote control of your home or office. The CEN-TIA can also dial out to your mobile phone to alert you to an alarm condition or other system event.

Audio Signal Generator

Loaded with your own custom WAV or MP3 audio files, the CEN-TIA can be used to generate high-quality door chimes and alarm sounds, and even create unique telephone ring tones to identify known callers based on Caller ID. With memory capacity expandable up to 1 GB, the CEN-TIA can easily support several hours of full-frequency stereo audio files.

Caller ID

See who is calling before you answer by displaying Caller ID (CID) information on every touchpanel. Manage missed calls easily with complete caller information and management options displayed on the touchpanel screen.

Telephone Paging

The CEN-TIA adds telephone paging capability to any Crestron Home[®] audio distribution system, allowing sophisticated zone-paging from any telephone to room speakers throughout the house.

Speakerphone

Enable speakerphone capability on your Crestron[®] touchpanel. The CEN-TIA connects directly to a standard phone line, or to your phone system's analog extension port to provide a single-line, push-to-talk half-duplex speakerphone interface for any touchpanel with built-in microphone and speakers. Integrated with the C2N-IADS30x24 Intercom Distribution Switcher, the CEN-TIA can enable speakerphone capabilities for multiple touchpanels throughout the house.


Outlook and Palm Address Book Import Compatibility



Industry Compliance

NOTE: This equipment meets the applicable Industry Canada Terminal Equipment Technical Specifications. This is confirmed by the registration number. The abbreviations, IC, before the registration number signifies that registration was performed based on a Declaration of Conformity indicating that Industry Canada technical specifications were met. It does not imply that Industry Canada approved the equipment.

NOTE: The Ringer Equivalence Number (REN) for this terminal equipment is 0.1A. The REN assigned to each terminal equipment provides an indication of the maximum number of terminals allowed to be connected to a telephone interface. The termination on an interface may consist of any combination of devices subject only to the requirement that the sum of the Ringer Equivalence Numbers of all the devices does not exceed five.

This equipment complies with Part 68 of the FCC rules and the requirements adopted by the ACTA. On the bottom of the unit is a label that contains, among other information, a product identifier in the format US:AAAEQ##TXXXX. If requested, this number must be provided to the telephone company.

Applicable connector jack Universal Service Order Codes ("USOC") for the Equipment is RJ11C.

A plug and jack used to connect this equipment to the premises wiring and telephone network must comply with the applicable FCC Part 68 rules and requirements adopted by the ACTA. A compliant telephone cord and modular plug is provided with this product. It is designed to be connected to a compatible modular jack that is also compliant.

The REN is used to determine the number of devices that may be connected to a telephone line. Excessive RENs on a telephone line may result in the devices not ringing in response to an incoming call. In most but not all areas, the sum of RENs should not exceed five (5.0). To be certain of the number of devices that may be connected to a line, as determined by the total RENs, contact the local telephone company. For products approved after July 23, 2001, the REN for this product is part of the product identifier that has the format US:AAAEQ##TXXXX. The digits represented by ## are the REN without a decimal point (*e.g.*, 03 is a REN of 0.3).

If this CEN-TIA causes harm to the telephone network, the telephone company will notify you in advance that temporary discontinuance of service may be required. But if advance notice isn't practical, the telephone company will notify the customer as soon as possible. Also, you will be advised of your right to file a complaint with the FCC if you believe it is necessary.

The telephone company may make changes in its facilities, equipment, operations or procedures that could affect the operation of the equipment. If this happens the telephone company will provide advance notice in order for you to make necessary modifications to maintain uninterrupted service.

If trouble is experienced with this CEN-TIA, for repair or warranty information, please contact Crestron customer service (refer to "Further Inquiries" on page 25. If the equipment is causing harm to the telephone network, the telephone company may request that you disconnect the equipment until the problem is resolved.

Connection to party line service is subject to state tariffs. Contact the state public utility commission, public service commission or corporation commission for information.

If your home has specially wired alarm equipment connected to the telephone line, ensure the installation of this equipment does not disable your alarm equipment. If you have questions about what will disable alarm equipment, consult your telephone company or a qualified installer.

WHEN PROGRAMMING EMERGENCY NUMBERS AND(OR) MAKING TEST CALLS TO EMERGENCY NUMBERS:

- 3. Remain on the line and briefly explain to the dispatcher the reason for the call.
- 4. Perform such activities in the off-peak hours, such as early morning or late evenings.

As of the date of manufacture, the CEN-TIA has been tested and found to comply with specifications for CE marking and standards per EMC and Radiocommunications Compliance Labelling.



NOTE: This device complies with part 15 of the FCC rules. Operation is subject to the following two conditions: (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference in a residential installation. This equipment generates, uses and can radiate radio frequency energy and, if not installed and used in accordance with the instructions, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. Setup

Network Wiring

When wiring the network, consider the following:

- Use Crestron Certified Wire.
- Use Crestron power supplies for Crestron equipment.
- Provide sufficient power to the system.

CAUTION: Insufficient power can lead to unpredictable results or damage to the equipment. Please use the Crestron Power Calculator to help calculate how much power is needed for the system (http://www.crestron.com/calculators).

• For larger networks, Use a Cresnet Hub/Repeater (CNXHUB) to maintain signal quality

The CEN-TIA uses Cresnet, USB and high-speed Ethernet for programmatic interface with Crestron's Toolbox application. Please refer to the Toolbox help file.

NOTE: The CEN-TIA is shipped with DHCP enabled (no default IP address). If it is desirable to manually set the IP address of the CEN-TIA (DHCP disabled) by using the Text Console in Toolbox. Refer to the Toolbox help file for further details.

NOTE: The CEN-TIA can only be set up with the CEN-TIA Menu Builder tool that is included in Toolbox version 1.04.13 and later.

NOTE: The Ethernet port on the CEN-TIA does not support Voice Over IP (VOIP).

Identity Code

The Net ID of the CEN-TIA has been factory set to 49. The Net IDs of multiple CEN-TIA devices in the same system must be unique if they are connected to the same Cresnet. Net IDs are changed from a personal computer (PC) via the Crestron Toolbox. When setting the Net ID, consider the following:


- The Net ID of each unit must match an ID code specified in the SIMPL Windows program.







The CEN-TIA's audio connections support both balanced and unbalanced line-level audio. These connectors are wired as shown in the following illustrations.

Crestron SystemBuilder is the easiest method of programming but does not offer as much flexibility as SIMPL Windows. For additional details, download SystemBuilder from the Crestron website and examine the extensive help file.

Programming with Crestron Toolbox CEN-TIA Menu Builder

The CEN-TIA Menu Builder tool in Toolbox is required to set up the internal menus, events and commands that determine how the CEN-TIA responds to your telephone system (i.e., incoming calls, DTMF inputs from a telephone handset, touchpanel inputs, etc.). For details about using the CEN-TIA Menu Builder tool, refer to the Toolbox help file.

Programming with SIMPL Windows

NOTE: While SIMPL Windows can be used to program the CEN-TIA as it relates to a Crestron network with a control system, it is recommended to use the Toolbox CEN-TIA Menu Builder for configuring the device.

SIMPL Windows is Crestron's premier software for programming Crestron control systems. It is organized into two separate, but equally important "Managers".


Configuration Manager

Configuration Manager is the view where programmers "build" a Crestron control system by selecting hardware from the *Device Library*.


NOTE: The CEN-TIA can be used as both a Cresnet and Ethernet device. As a Cresnet device, it can simply be added to an appropriate control system such as the PRO2. As an Ethernet device, it must be added after an Ethernet card such as the C2ENET-1 is configured into the system.


• To incorporate the CEN-TIA into the system as an Ethernet device, drag the CEN-TIA (Ethernet) from the Ethernet Control Modules | Ethernet Audio Modules folder of the *Device Library* and drop it in the *System Views*.

Locating the Ethernet CEN-TIA in the Device Library




• To incorporate the CEN-TIA into the system as a Cresnet device, drag the CEN-TIA (Cresnet) from the Cresnet Control Modules | Cresnet Audio Modules folder of the *Device Library* and drop it in the *System Views*.





• The system tree of the control system displays the devices in their appropriate slots with default IP ID or Net ID as shown in the following illustration.

• The initial Cresnet CEN-TIA will take ID 49. Additional Cresnet CEN-TIA devices would be assigned the lowest legal unused Cresnet ID (e.g., 03 if unused). The initial Ethernet CEN-TIA will take IP ID 03. If an additional Ethernet CEN-TIA is added the IP ID of that unit would be 04.

NOTE: In the case of the Ethernet CEN-TIA, the IP ID must match the IP ID in the IP table.

• If necessary, double click a device to open the "Device Settings" window and change the IP ID or Net ID, as shown in the following figures.

Programming Manager

Programming Manager is the view where programmers "program" a Crestron control system by assigning signals to symbols. The symbol can be viewed by double clicking on the icon or dragging it into *Detail View*. A description of the CEN-TIA symbol and for each signal in the symbol is described in the SIMPL Windows help file (**F1**).

Example Program

An example program for the CEN-TIA is available from the "Example Program" section of the Crestron website (<u>http://www.crestron.com/exampleprograms</u>).

Uploading and Upgrading

Crestron recommends using the latest programming software and that each device contains the latest firmware to take advantage of the most recently released features. However, before attempting to upload or upgrade, it is necessary to establish communication. Once communication has been established, files (for example, programs or firmware) can be transferred to the control system (and/or device). Finally, program checks can be performed (such as changing the device ID or creating an IP table) to ensure proper functioning.

Establishing Communication

Use Crestron Toolbox for communicating with the CEN-TIA. Refer to the Crestron Toolbox help file for details. There are three methods of communication.

Direct Serial Communication


Direct USB Communication



- CEN-TIA connects to PC running Toolbox via the USB port. Note that Cresnet power must still be applied.
- Establish communication between the PC and the CEN-TIA. The first time communication is established, Windows will launch the Found New Hardware Wizard.
- Click the **No**, **not this time** radio button and then click **Next**.

- CEN-TIA connects to control system via Cresnet.
- Establish communications between the PC and the control system as described in the latest version of the 2-Series Reference Guide (Doc. 6256) which is available from the Crestron website (http://www.crestron.com/manuals).

TCP/IP Communication

Ethernet Communication



- Establish direct USB communication between CEN-TIA and PC.
- DHCP is enabled by default on the CEN-TIA. If you have to disable it and manually establish an IP address, do so using Crestron Toolbox (**Functions | Ethernet Addressing**).
- Confirm Ethernet connections between CEN-TIA and PC. If connecting through a hub or router, use CAT5 straight through cables with 8-pin RJ-45 connectors. Alternatively, Use a CAT5 crossover cable to connect the two LAN ports directly, without using a hub or router.
- Use the Address Book in the Crestron Toolbox to create an entry for the CEN-TIA with the CEN-TIA's TCP/IP communication parameters.
- Display the "System Info" window (click the **b** icon) and select the CEN-TIA entry.
- Use the Crestron Toolbox to create the CEN-TIA IP table.
 - \Rightarrow Select Functions | IP Table Setup.
 - \Rightarrow Either add, modify, or delete entries in the IP table. The CEN-TIA can have only one IP table entry.
 - \Rightarrow A defined IP table can be saved to a file or sent to the device.
- Edit the control system's IP table to include an entry for the CEN-TIA. The entry should list the CEN-TIA's IP ID (specified on the CEN-TIA's IP table) and the internal gateway IP address 127.0.0.1.

Programs and Firmware

Program or firmware files may be distributed from programmers to installers or from Crestron to dealers. Firmware upgrades are available from the Crestron website as new features are developed after product releases. One has the option to upload programs and projects via the programming software or to upload and upgrade via the Crestron Toolbox. For details on uploading and upgrading, refer to the SIMPL Windows help file or the Crestron Toolbox help file.

If a SIMPL Windows program is provided, it can be uploaded to the control system using SIMPL Windows or Crestron Toolbox.

If a CEN-TIA Menu Builder Project is provided or created, it can be uploaded to the device using the CEN-TIA Menu Builder tool in Crestron Toolbox.

Check the Crestron website to find the latest firmware. (New users may be required to register to obtain access to certain areas of the site, including the FTP site.)

Upgrade CEN-TIA firmware via Crestron Toolbox.

- Establish serial or TCP/IP communications with the CEN-TIA and display the "System Info" window.
- Select Functions | Firmware... to upgrade the CEN-TIA firmware.

Program Checks

Actions that can be performed on the CEN-TIA vary depending on whether it is connected via Cresnet or Ethernet.

Cresnet Connections For Cresnet connections, using Crestron Toolbox, display the network device tree (Tools | Network Device Tree) to show all network devices connected to the control system. Right-click on the CEN-TIA to display actions that can be performed on the CEN-TIA.

For Ethernet connections, display the "System Info window (click the **Functions** menu to display actions that can be performed on the CEN-TIA.

Be sure to use the Crestron Toolbox to create the CEN-TIA IP table.

- Select Functions | IP Table Setup.
- Add, modify or delete entries in the IP table. The CEN-TIA can have only one IP table entry.
- A defined IP table can be saved to a file or sent to the device.

Edit the control system's IP table to include an entry for the CEN-TIA. The entry should list the CEN-TIA's IP ID (specified on the CEN-TIA's IP table) and the internal gateway IP address 127.0.0.1.

Operation

The CEN-TIA uses audio messages as voice prompts and responses. These files can be WAV or MP3 files. Pre-recorded message files can be downloaded from Crestron's website (<u>ftp://ftp.crestron.com</u>).

A Cresnet system with the CEN-TIA may be programmed to respond to incoming telephone tones or a sequence of tones. For example, pressing 1 from a telephone (after connecting to the system) may be used to activate an air conditioning system and the CEN-TIA would respond with "Command accepted, air conditioning is on". The system may also be programmed to dial-out and play a recorded message when a specific input, such as from a security system, is received. By using CID information, the system can be programmed to allow access from only a specific telephone to perform various functions or play customized greetings depending on the number calling.

Refer to the Toolbox help file for details on setting up the CEN-TIA to perform these and many other functions.

Troubleshooting

The following table provides corrective action for possible trouble situations. If further assistance is required, please contact a Crestron customer service representative.

Device does not function.	Device is not communicating with the network.	Use Crestron Toolbox to poll the network. Verify network connection to the device.
	Device is not receiving power from a Crestron power source.	Use the provided Crestron power source. Verify connections.
	Device is not receiving sufficient power.	Use the Crestron Power Calculator to help calculate how much power is needed for the system.
	Device Net ID or IP ID does not match control system ID setting.	Use Crestron Toolbox or SIMPL to change the Net ID or IP ID.
	Control system not configured properly.	Determine correct control system configuration and make appropriate changes.
USB connection stops responding.	USB connection terminated without first stopping the USB driver.	Right click on the Safely Remove Hardware icon in the System Tray. Select Generic Crestron Console V2 device and click the stop button. Reconnect via Toolbox using the USB connection.
Audio output is distorted.	Mixer settings and/or audio source levels are too high.	Reduce audio output levels until distortion disappears.
Device does not perform the tasks programmed using CEN-TIA Menu Builder tool.	Correct CEN-TIA Menu Builder project file not loaded or incorrectly configured.	Check the CEN-TIA Menu Builder project file and make necessary changes. Upload correct file if necessary.
CEN-TIA functions properly but feedback indicator(s) do(es) not illuminate.	Feedback signal names incorrect in SIMPL Windows program.	Verify SIMPL Windows program for feedback signal names.

Check Network Wiring

Use the Right Wire	In order to ensure optimum performance over the full range of your installation topology, Crestron Certified Wire, and only Crestron Certified Wire, may be used. Failure to do so may incur additional charges if support is required to identify performance deficiencies because of using improper wire.
Calculate Power	CAUTION: Use only Crestron power supplies for Crestron equipment. Failure to do so could cause equipment damage or void the Crestron warranty.
	CAUTION: Provide sufficient power to the system. Insufficient power can lead to unpredictable results or damage to the equipment. Please use the Crestron Power Calculator to help calculate how much power is needed for the system (http://www.crestron.com/calculators).
	When calculating the length of wire for a particular Cresnet run, the wire gauge and the Cresnet power usage of each network unit to be connected must be taken into consideration. Use Crestron Certified Wire only. If Cresnet units are to be daisy- chained on the run, the Cresnet power usage of each network unit to be daisy-chained must be added together to determine the Cresnet power usage of the entire chain. If the unit is a home-run from a Crestron system power supply network port, the Cresnet power usage of that unit is the Cresnet power usage of the entire run. The wire gauge and the Cresnet power usage of the run should be used in the following equation to calculate the cable length value on the equation's left side.
	Cable Length Equation
	L < $\frac{40,000}{R \times P}$ Where: L = Length of run (or chain) in feet R = 6 Ohms (Crestron Certified Wire: 18 AWG (0.75 MM ²)) or 1.6 Ohms (Cresnet HP: 12 AWG (4 MM ²)) P = Cresnet power usage of entire run (or chain)
	Make sure the cable length value is less than the value calculated on the right side of the equation. For example, a Cresnet run using 18 AWG Crestron Certified Wire and drawing 20 watts should not have a length of run more than 333 feet. If Cresnet HP is used for the same run, its length could extend to 1250 feet.
	NOTE: All Crestron certified Cresnet wiring must consist of two twisted pairs. One twisted pair is the +24V conductor and the GND conductor, and the other twisted pair is the Y conductor and the Z conductor.
Strip and Tin Wire	When daisy-chaining Cresnet units, strip the ends of the wires carefully to avoid nicking the conductors. Twist together the ends of the wires that share a pin on the network connector, and tin the twisted connection. Apply solder only to the ends of the twisted wires. Avoid tinning too far up the wires or the end becomes brittle. Insert the tinned connection into the Cresnet connector and tighten the retaining screw. Repeat the procedure for the other three conductors.
Add Hubs	For larger networks (i.e., greater than 28 network devices), it may become necessary to add a Cresnet Hub/Repeater (CNXHUB) to maintain signal quality throughout the network. Also, for networks with lengthy cable runs, it may be necessary to add a Hub/Repeater after only 20 devices.
