## The summary for the proper installation of the water filtration device


1. Close main water supply valve to separate the faucet.



2. Wind the teflon tape on the adaptor and fit it to the pipe.



Do not turn the water pipe.



3. Connect the faucet with the adaptor.




Shall install the adaptor with connector on the cold water pipe.




4. Connect 1/4 inch orange tubing with the connector on the adaptor.



Flush water through each filter at least 5 minutes before Connection.



5. Open the feed valve to supply water to the filtration system.



## INSTALLATION PRECAUTIONS

## Please check before use!



#### This product is for 120 V~ 60 Hz only.

Please connect the power plug to a dedicated grounded electrical outlet for  $120 \, \text{V} \sim 60 \, \text{Hz}$ . The water filtration device works normally only when the electricity is connected.



- Open the main water supply valve.
  - The main water must be supplied to operate the water filtration device normally.
- · After installing the product

Get rid of the saved water above the full water in the inner water tank 2 times or more to use.

· When the indicator in the indication part is turned off

When the indicator in the indication part is turned off, check if the power supply was stopped due to the power failure or other cause.

· Regularly filter replacement

It is important to replace the filter regularly to drink the pure water. If the filter is overused beyond its service life, the performance of the water filtration device deteriorate, Do not miss the filter replacement cycle.

· When you didn't use for a long time

If you saved the water for a long time or you didn't use, drain the water inside of the water filtration device completely and remove the newly filtered water one time to use.

When you don't want to use for a long time

Close the main water supply valve and unplug.



While cleaning the electrolysis vessel, the indicator is turned on.

## 1 Cooling mode selection button

Press this button to select or deselect cooling mode. This button is turned on when cooling mode is selected.



#### 2 Ion water button

Press this button to extract ionized water. If you press this button, the button is turned on.



## 3 Strong alkaline water button

Press this button to extract strong alkaline water. If you press this button, the button is turned on.



## 4 Weak alkaline water button

Press this button to extract weak alkaline water. If you press this button, the button is turned on.



#### 5 Cold ion water button

Press this button to extract cold ionized water. If you press this button, the button is turned on.



## 6 Continuous extraction button

Press this button to extract water continuously.

#### To use the cold water function


Press the cold mode button and confirm that the cold mode button is turned on. If you want to turn off cold mode, press and hold the button for about 3 seconds or more.

\* You can drink cold ion water in about two hours after turning the cold mode.

### **Electrolysis vessel cleaning function**

The auto electrolysis vessel cleaning function is provided to keep the vessel clean and protect the product. During electrolysis vessel cleaning, the cleaning indicator is turned on.

- ① If no ionized water is extracted 1 minute after ionized water is extracted, the vessel is cleaned automatically.
- ② If the stop period exceeds 7 hours after water is extracted, the vessel is cleaned automatically.
- ③ If about 30 minutes has passed after the power is turned on and then cool mode is turned on, the vessel is cleaned automatically.







## **HOW TO USE**

## To drink cold ion water

Push high or low alkaline button. Then push cold ion water button. You can have cold ion water by push extraction lever of cold ion water.





Safety interruption feature: extraction stops automatically after 1 minute continuous extraction.


Tips If low level lamp is on, cold lon water is not extracted.

lon water and cold ion water button is canceled automatically 10 seconds after extraction.

According to environment or user's drinking habit, the first cup maybe not cold enough. but it is not product break down. However, you can have cold water from second cup.

## To drink ion water

Choose high or low alkaline button. Then push ion water button. You can have ion water by push extraction lever of ion water.





Safety interruption feature: extraction stops automatically after 1 minute continuous extraction.

If low level lamp is on, cold lon water is not extracted.

lon water and cold ion water button is canceled automatically 10 seconds after extraction.

## To drink ambient water

You can have ambient water by push ambient water lever.



Safety interruption feature: if pushing the lever for 2 minutes continuously, extraction stops automatically.



## To extract continuosly

To extract ionized water continuously, press the strong or weak alkaline button. Press the lon water or cold mode button. (Make sure to confirm that the required ion water selection button is turned on.) If you press and hold the continuous extraction button for about 2 seconds, you can receive the selected ion water for about 1 minute.

When extracting water continuously, check if the ion water and cold mode buttons are turned off. (If you press a button that has been turned on again, the button is turned off.) If you press and hold the continuous extraction button for about 2 seconds, you can receive water for about 2 minutes and 30 seconds.



One more push on continuous extraction button stops continuous extraction.

lon water and cold ion water button is automatically canceled after 10 seconds.

- When the low water level indicator is turned on, the ion or cold ion water is not extracted.





## Be cautious!

#### ■ Water filtration device installation place 1

Please install the water filtration system not at a rough place, a damp place, a place where the unit is exposed to the direct sunlight, a place where dust is present, or a place that the water drops.



#### ■ Water filtration device installation place 2

Please install at the place where it is 10 cm or more off from the wall and the bottom is flat and firm.



#### After installing the water filtration system

Filtered water: Fill the water tank with the filtrated water and remove the water twice or more if necessary after installing it.

Ion water: Fill the water tank with the ionized water and remove the water twice or more if necessary after installing it.

Removing moisture: Remove moisture and dust from the operating, display and connecting parts of the front cover.



### ■ Cold water plumbing

Please connect to the cold water pipe necessarily. (If you connect to the warm water pipe, the filter can be damaged.)



#### ■ Movement and installation

When the position is moved, connect the power cord when 30 minutes passes after installing.



To maintain optimal product performance, consult a Coway engineer for the detailed installation methods.



There may be some water remaining inside of the filter which was used to test the product during inspection process at the factory.

Please feel at easy and use as it isn't the used product.



## **CLEANING METHOD**

## Storage tank

 Turn it off by pressing the cold mode button at the front panel of the product for about 3 seconds and unplug the power cord. Close the main water supply valve.



Take care that water does not enter the product other than through the water hose.




Please drain and store the water inside of the water filtration device completely using the draining hose.




Please drain and store the water inside of the water filtration device completely using the draining hose.



3. Slide the top cover of the product backwards, open the fixing latches of the internal water tank, and then open the cover.



4. Separate the ceramic filter from the bottom of the cover of the internal water tank and use the stored water to clean it.



Please wipe the surface of the storage tank with a soft cloth.



 Drain the water completely using the draining hose after washing out the internal water tank with the stored water.





You can drain the water within the internal water tank completely by lowering the draining part cover at the front and connecting the draining hose (the continuous extraction hose).

7. After installing the ceramic filter at the bottom of the cover of the internal water tank, close the internal water tank cover. Lock the fixing latches of the internal water tank and close the cover.









Because locking the fixing latch of the internal water tank incorrectly may cause the alien substances or bacteria to enter, please make sure that the fixing latches are locked correctly.

## **CLEANING METHOD**

8. Close the top cover, plug in the power cord and open the water supply valve.



⚠ Close the storage tank cover completely.

A worm or a foreign body can be entered.



Mhen you clean the storage tank, don't use the medicine or the detergent.

If you don't clean the medicine or the detergent cleanly, it can be harmful to the body.




1. Gutter separation method

## **FILTER REPLACEMENT**

#### **■** Filter

The life of the water filtration system is the filter. It it isn't the legitimated filter or you use too long even if it is the legitimated filter, the filter performance can be lowered.

Please change to the legitimated filter according to the replacement cycle.



#### **■** Filter replacement cycle

If the filter is not regularly replaced, it may degrade the water quality from the product. The filter replacement cycle depending on the main water quality can be shortened rater than the expected replacement cycle.

\* The period for the filter exchange is made based on 10 L use in a day for house use(4 people based) and 20 L use for business.

## ■ About filter replacement cycle


The filter replacement cycle described above is not the filter quality warranty period but the expected cycle (life) that the filter shows its original performance.

Therefore, the filter replacement cycle may be reduced for the area with the poor water quality or more application.



## FILTER REPLACEMENT METHOD


1. Close the main water supply valve after unplugging the power cord and drain the water inside of the internal water tank of the water filtration device (see p19).



2. Open the top cover and loosen the fixing screw at the top of the product. Open the front cover and disconnect the connected cable completely.



- Open the top cover by sliding it backwards.
- Hold and pull the front cover in the direction of 1. Pull the front cover in the direction of 3 while sliding the front cover in the direction of 2 to unlock the latch in the center on the left. Unlock the latch on the right according to the same method. Then the front cover is separated completely.



3. After separating the fitting connected to the filter to replace, please replace the filter.(Separate the fitting using the proper tool.)





By changing the filter and connecting the fitting and the hose precisely, check that there is no leakage and drain the first filtered water necessarily.

4. Connect all the cables and close the front cover making sure to align the groove. Fasten the fixing screw of the top of the product with a screw driver and close the top cover.





Please be sure to use a new filter after cleansing.

- Plus sediment filter: Install after cleaning with the main water for about 3 minutes.
- Pre-carbon/Fine post carbon/Inno-sense filter: Please assemble it after cleansing
   it with the water passed through
   the plus sediment filter for about 3
   minutes.
- Membrane filter: Please assemble it after cleansing it with the water passed through the plus-sediment filter and the pre-carbon filter for about 3 minutes.

## **TROUBLESHOOTING**

The water filtration device may operate abnormally due to minor causes not because of the product malfunction but because of the fact that the user is not familiar with the product use. In such a case, problems can be solved easily even without the help from the Service Center by checking the following items. If you can't solve the problem after checking the following items, please call the Service Center.


