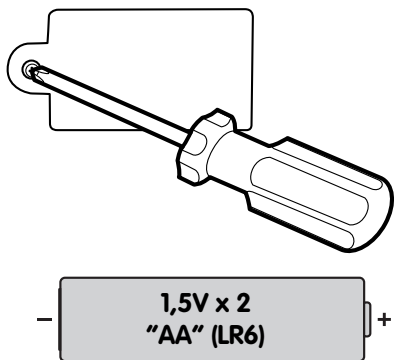
Requires two "AA" batteries (included).

Tool required for battery replacement:
Phillips screwdriver (not included).

This product is not intended for use in water.

Battery Replacement



For best performance, we recommend replacing the batteries that came with this toy with two, new “AA” (LR6) alkaline batteries.

- Locate the battery compartment on the bottom of the toy.
- Loosen the screw in the battery compartment door with a Phillips screwdriver. Remove the door.
- Insert two “AA” (LR6) **alkaline** batteries.
- Replace the battery compartment door and tighten the screw. Do not over-tighten.
- If this toy begins to operate erratically, you may need to reset the electronics. Slide the power off and then back on.
- When sound becomes faint or stop, it's time for an adult to change the batteries!



- Protect the environment by not disposing of this product with household waste (2002/96/EC). Check your local authority for recycling advice and facilities (Europe only).

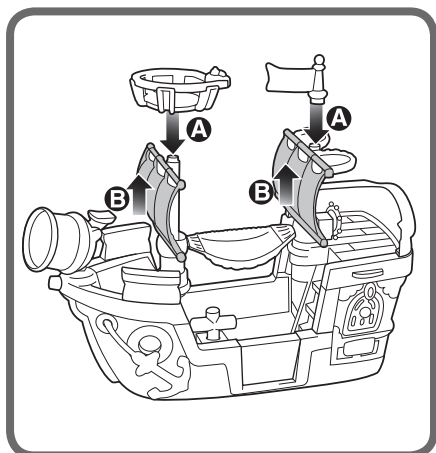
Battery Safety Information

In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product.

To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
- If removable, rechargeable batteries are used, they are only to be charged under adult supervision.

Assembly



- Fit the flag and crow's nest onto the top of each mast **A**.
- Pull up the masts **B**.

Fire!



- Press the lever to fire the cannon.
IMPORTANT: Do not aim at eyes or face. Only use projectiles supplied with this toy. Do not fire at point blank range.

Yo-Ho-Ho!



- Slide the power switch on the bottom of the ship ON ●.
- Set the parrot on the perch. Press down for music and sound effects.
- When you're finished playing with the toy, slide the power switch OFF ○.

Care

- Wipe this toy with a clean cloth dampened with a mild soap and water solution. Do not immerse.
- This toy has no consumer serviceable parts. Do not take this toy apart.
