Safety Precautions and Potential Hazards

General

Before you start installing and working with the reader, you should read the safety precautions and regulations shown in this chapter.

Operator Qualification

Please note that the operation with Multifunctional Food Safety Analyzer should be carried out only by the inspector who has undergone necessary training provided by the sales agent.

Service Technician Qualification

To install, maintain and repair the instrument, a service technician has to be trained on the instrument by the manufacturer or their representative. A service technician is also expected to be familiar with the normal operation of the instrument as described in the User's manual and the special operations as described in the service manual.

Electrical

To use analyser safely, pay attention to the following items:

To prevent the risk of electrical shock and/or damage to the instrument, **Operator** should not open the cover of the instrument. Only authorized personnel, for example, **service technicians**, may open the instrument to perform maintenance or repair.

Touching the main board when the power is on may cause severe injury or death. Any problem, please ask for helps from your supplier.

Mechanical

There is no risk presented by the mechanical parts of the instrument when the instrument is closed. If the covers of the instruments are removed, mechanical parts could cause personal injury or the instrument may be damaged if the following advice is not being considered: DO NOT wear loose garments or jewellery that could catch in mechanisms. DO NOT put your fingers/hands into the pathway or any part while the instrument is in operation. DO NOT attempt mechanical repair unless the instrument is not in operation or OFF.

Lamp

The source lamp becomes extremely hot during operation; never touch the lamp when it is on! If the lamp needs to be changed, always switch off the lamp by switching off the instrument and then wait until the lamp has cooled down.

Chemical

The operator is responsible for taking all necessary precautions against hazards associated

with the use of clinical laboratory chemicals. Specific recommendations for each reagent used with the Reader are normally found on the manufacturer's package inserts or the on the product information sheets for each chemical. Wipe up any reagent spillage on the instrument immediately.

Biohazardous Materials

As with all vitro diagnostic equipment, sample samples that are assayed on this system, as well as all waste from the waste container, should be treated as the potentially biohasardous. All materials and mechanical components associated with the sampling and waste system should be handled according to your facility's biohazard procedure. Use the personal protective equipment recommended by your facility when handling any of these components. Detailed recommendations:

- Samples

Treat all samples as potentially biohaazardous and infectious. If any sample is spit on the instrument, utilize the correct personal protective equipment (PPE- gloves, lab coat, etc...), wipe it up immediately and clean the contaminated with a disinfectant.

- Waste solutions and solid wastes

Avoid direct contact with waste solution and/or solid waste. Both should be handled as potentially biohazardous.

Dispose of waste solution and/or solid waste according to the relevant governmental regulations.

Consult the reagent manufacturer for information on the concentrations of heavy metals and other toxic constituents in each reagent.

- Biohazardous parts

Avoid direct contact with the micropplate. Treat these parts as potentially biohazardous and /or infectious

- Reagents

Avoid direct body-contact with reagents. Direct body-contact may result in irritation or damage to your skin. Refer to the manufacturer's reagent kit box and package inserts, or product information sheets for specific instructions.

Avoid direct body-contact with cleaning solution. Direct body-contact amy result in skin irritation or damage. Refer to the manufacturer's kit box and package inserts, or product information sheets for specific instructions.

Additional Precautions

- Flammables

Avoid using dangerous flammable material around the instrument.

- Accuracy/Precision of the Measured Results

For proper use of the instrument, measure control samples and monitor the instrument during the operation.

An incorrectly measured result may lead to an error in diagnosis, thereby posing a danger to the sample.

Treat all reagents according to the manufacturer's recommendations. Refer to the reagent kit box and package inserts, or product information sheets for specific instructions.

Make sure that the sample/reagent mixture does not contain any blood clots, dust or other insoluble contaminants. If insoluble contaminants are contained in the sample, correct measuring values may not be obtained.

Application

The instrument is designed for multifunctional food safety analyzer, involve pesticide residue detection, veterinary drug residues detection, antibiotic residues detection, organic pollutants measurement, natural toxins measurement, aquatic safety monitoring, and analysis of biological contaminants etc.

Please note that other types of analysis may not be applicable to the instrument.

- Operation and Maintenance

During operation and maintenance of the instrument, proceed according to the instructors and do not touch any parts of the instrument other than those specified.

Never leave a Reagents/sample mixture in the microplate for longer than necessary. Always clean the microplate after a batch of measurement and keep the microplate cleanliness when not in use.

Verify the front covers closed while the instrument in operation.

Avoid touching the mechanism, such as the sipper mechanism inside the instrument, while the instrument is operating. This may cause operation stop or damage the instrument.

1. INSTALLATION

1.1 Unpacking

Unpack FSA-1510 carefully and check for any damage that may have been caused during transportation.

check the components::

- FSA-1510 instrument
- 1 Operator's manual
- 1 Packing list
- Accessories: panel pen, power cable, print cable, RS-232 serial cable, lamp, fuses

Keep the original package for future transportation

Notice: report any damage or missing to your local representative.

1.2 Environmental Requirements

Locate FSA-1510 to avoid exposure to excess dust, vibrations, strong magnetic fields, direct sunlight, draft, excessive moisture or large temperature fluctuations.

Leave sufficient clearance (10 cm) at both sides of the unit for adequate air circulation.

Notice: instrument be operated within an ambient temperature range of $0 \, \text{C-40} \, \text{C}$ and humidity $\leq 85 \, \text{\%}$.

1.3 Electrical Setup

Power requirements

- a.c.110-220V±10%
- 50-60±1Hz
- 120W

warning:

- Ac power plug must be grounded at the main socket.
- The circuit used should be substantially free of large voltage transients such as large pumps, large centrifuges etc.
- If found smog, strange sound in instrument, please turn instrument off immediately and contact your dealer

Connect the supplied power cable to the rear of the instrument as shown. Plug the other end of the power cable into an AC outlet.

1.4 External Printer Connection


With both the instrument and the external printer off, connect the parallel cable to the rear of the instrument. Plug the other end of the parallel cable into the printer. Then plug power cable into printer. Install printer paper if needed.




3.1 Touch Panel & Pen

FSA-1510 has a touch panel; you can operator the instrument by pen.

warning: please use the pen to touch the panel.

Notice: You also can use a RS-232 mouse to operate the instrument.

3.2 Digital Number Keyboard




5. Program

The FSA-1510 multifunctional food safety analyzer can set 100 test items, including 22 fixed items, which involve Food security analysis, pesticide residue detection, veterinary drug residues detection, antibiotic residues detection, organic pollutants measurement, natural toxins measurement, aquatic safety monitoring, and analysis of biological contaminants etc. 22 fixed items including: Pesticide Residues, Total Organophosphate Pesticides, Carbamate pesticides(Carbofuran), Herbicides Pesticides(Butachlor), Clenobuterol Hydrochloride, Ractopamine, Malachite green, Aflatoxin, Chloramphenicol, Diethylstilbestrol, Furaltadone, Sudan, Enrofloxacin, Nitrofurazone, Nitrofurantoin, Furazolidone, Sulfaquinoxaline, Sulfamethazine, Sulfadoxinemethoxy-pyrimidine, Methyl testosterone, five kinds of Residue of Sulfonamides(Sulfa 5 residues), three kinds of Residue of Sulfonamides(Sulfa 3 residues).

5.1 Mode setting

FSA-1510 support 9 calculation modes:

5.1.1 ABS mode

FSA-1510 only display and print out absorbance of samples.

5.1.2 Cut-Off mode

Cut-Off formula: $Cov = X \times NC + Y \times PC + Fac$

Abs

In this cut-off mode, where NC is the mean of the negative controls, PC is the mean of the positive controls, Cov is the cutoff absorbance .X, Y, Fac are coefficients that have any positive and negative numerical value (including 0 and 1) e.g. sample OD/NC≥2.1 is positive, that X=2.1, Y=0, Fac=0.


In regular cutoff mode, FSA-1510 award that sample is positive if sample OD/Cov>1.

5.1.3 Calculation mode

1) Single standard mode: A single calibrator material of known concentration is used so that concentrations of unknown samples may be calculated according to Beer's Law.



2) point to point mode: you can set 2-8 standards, the resulting calibrator curve is a series of lines connecting the calibrator points, which may be entered in ascending or descending order of absorbance.



- 3) %ABS: You can set 2-8 standards. The highest absorbance standard will be assigned a value of 100, and each sample and standard is reported as a percent of the absorbance of the highest calibrator. The resulting calibrator curve is a series of lines connecting the calibrator points, which may be entered in ascending or descending order of absorbance.
- 4) Linear regression mode: You can set 2-8 standards. This is a multi-point standard mode that calculates a best fit linear equation based upon the standard points.

Equations: Y = kX + b: This is used when the absorbance and the concentration is linear.



5) Index regression mode: You can set 2-8 standards. Equation: $Y = ke^{bX}$; This is used

when the natural log of the absorbance is plotted against the concentration.

- 6) Logarithm regression mode: you can set 2-8 standards. Equation: Y = kLnX + b; This is used when the natural log of the concentration is plotted against the absorbance
- 7) Exponent regression mode: You can set 2-8 standards. Equation: $Y = kX^b$; This is used when the natural log of the absorbance is plotted against the natural log of the concentration.
 - 8) Percent Logarithm regression mode: You can set 2-8 standards. Equation: (A/A0%=klogC+b); This is used when the natural log of the absorbance is plotted against the natural log of the concentration.


5.1.4 Calculation mode

Enzyme inhibition rate(Two point) and Kinetics, Calculation of inhibition ratio Inhibition ratio (%) = $(\triangle AC - \triangle AS)/ \triangle AC \times 100\%$

△AC: Absorbance difference of blank△AS: Absorbance difference of sample

5.2 Edit Program Setting


Select existed program (it will be marked), press "Edit" button, it displays the following windows:




- Program: program name, don't input the name existed.
- Reagent: Input reagent name, you can ignore it.
- Wavelength
- calibration mode
- Double sample: If select it, samples must be pipetted into consecutive two wells, the mean absorbance reading will be used to calculate a single concentration.
- Double blank: If select it, blank must be pipetted into consecutive two wells, the mean absorbance reading will be used to calculate a single concentration.
- Blank: You can set range of the blank abs. If blank absorbance out of range, system will display: "blank abs is out of range."

You can press button, come to next windows, or press dutton, come back this windows, you can press "cancel" button, exit program configuration windows.

1) Standards mode setting windows:



- Standard number: you can select up to 8.
- Concentration unit: you can select it from listing.
- Double standards: if select it, standards must be pipetted into consecutive two wells, the mean absorbance reading will be used to calculate a single concentration
- Standard conc.: double point standard conc. Listing, you can input standard concentration.




Notice: Standards may be entered in ascending order of absorbance.

Standard 1 is the lowest concentration.

2) Cut-Off mode setting windows:

The new software of FSA-1510 supports the user-defined formula. The following figure is showing.



Math list: +, -, *, /, %, (,).

Control: NC, NC, NC1, NC2, NC3, NC4, NC5, NCx, PC, PC1, PC2, PC3, PC4, PC5, PCx, CR, CR1, CR2, CR3, CR4, CR5, CRx, BLK.

Logic list: >, <, <=, >=, AND, OR, = =.

Type: Cut-off, Val1, Val2, Val3, Val4, Val5, Val6, Val7, Val8, and Val9.

Cut-off: formula Val: formula

Note: NC (PC, CR): Represents NCi and PCi when it acts as the range, other represents mean value (NCx, PCx and CRx)

NCx, PCx and CRx: mean value of Nci, PCi and CRi.

"*" can not be omitted, such as 1.2*NCx.

The "()" can not include the "AND, OR"

Invalid input: 0.12<NC<0.4

Valid input NC>0.12

NC<0.4

"NC" and "PC" should not used with "OR" and "AND"

"NC1<PC1 AND PC2<NCx" is permitted.

Manual calculation

Calculations must be made separately for each strip holder.

NC = Absorbance of the negative control

PC1 = Absorbance of the anti-HIV-1 positive control

PC2 = Absorbance of the anti-HIV-2 positive control

PC3 = Absorbance of the HIV-1 antigen positive control

Qualification of NC values

- 1 NC must be < 0.250 Eliminate any NC≥0.250.
- 2 Determine the mean (NCx) value of the remaining controls.
- 3 NC must be≤ 1.4NCx. Eliminate any NC> 1.4NCx and recalculate NCx.
- 4 NC must be≥ 0.6NCx. Eliminate any NC< 0.6NCx and recalculate NCx.
- 5 Repeat steps 3 and 4 until no more outlier is found.

Assay validity

An assay run is valid if

- 1 More than half the number of the negative controls remain;
- 2 PC1 NCx≥0.600;
- 3 PC2 NCx≥0.600(if used);
- 4 PC3 NCx≥0.400 (if used).

Cut-off value

If the test run is valid, calculate the cut-off value NCx +0.100.

A test sample is reactive if sample absorbance is≥cut-off value.

A test sample is no reactive if sample absorbance is <cut-off value.



- Double of controls: if select this, controls must be pipetted into consecutive two wells, the mean absorbance reading will be used to calculate a single concentration

Qualitative mode: In this option you can select regular cov, reverse cov, none.


- Regular cov: Samples with values higher than the positive cutoff are labeled as positive.
 Sample with values lower than the negative cutoff are labeled as negative. Any samples with values falling between the negative cutoff and the positive cutoff are labeled as equivocal.
- Reverse cov: Samples with values lower than the positive cutoff are labeled as positive.
 Sample with values higher than the negative cutoff are labeled as negative.
- None: you can select none if you don't award negative or positive.
 Normal range: please input the values with reagent instruction
 Press "Finished" button, come back program listing windows.

5.3 Creating program

Press "new" button to create a new program, and then input the parameters. If the program name has existed, system will warn: "program exists."

5.4 Deleting program


Select one program in program listing, press "delete" button, system display windows:




Press "Yes" button to delete program. Press "NO" button to cancel.

5.5 Standard

Standard test results and curve will be stored. Operator can review and print the results. Select one program in program listing, Press "standard" button, system display standard conc. and abs.

Notice: Old standards will be deleted if modifying program setting. (Wavelength, calculate mode, standard number, standard conc.etc.)


6. RUN THE TESTS

12. INSTRUMENT SERVICE

12.1 Maintenance

FSA-1510 is designed to be a maintenance free instrument. To insure optimum trouble free performance, the instrument should be kept dry and operated in an area free from excessive dust.

12.2 Cleaning The Instrument

- Keep working environment clean
- Use a slightly damp soft cloth to remove dirt or spills. For decontamination, 70% isopropanol is recommended.
- Use soft cloth to remove dirt or spills in LCD.

Notice: Use other chemicals or abrasive cleaners are not recommended.

12.3 Changing Part Of Instrument

12.3.1 Changing the fuses

- 1) Disconnect power cord from mains supply before replacing fuses.
- Open fuses box left in power, change fuses, close fuse box.
 Fuse specification: 250V/3.15A.
- 3) Turn the instrument on.

Notice: Use the same fuse for replacing.

12.3.2 Changing the lamp

- 1) Turn the instrument off, open instrument cover by unscrewing the one screw on the front of the instrument.
- 2) Remove four screws of the optical assembly cover. Remove the cover.
- 3) Lift up the lamp with the terminal socket. Pull the terminal socket from the lamp contacts.
- 4) Refit the terminal socket to the contacts of the new lamp (OSRAM64607, 6V/20W) .Place the new lamp in its place.
- 5) Close the optical assembly cover. Replace the screws.
- 6) Close the instrument cover. Turn FSA-1510 on again.



13. Spare parts replacement

13.1 Replacement of lamp


Loosen a screw in the middle of the front-end of the machine and lift the top cover of the machine. Loosen the screws of the two black light-masking boards on the right of the machine and remove the two light-masking boards. Loosen the fastening screw of the bulb and disconnect the power cord of the bulb. Replace it with a new bulb and restore the instrument.



13.2 Replacement of filter

STEP 1: Install filters

- 1. Turn off the instrument normally.
- 2. Remove the only one screw and open the cover of the Reader.



- 3. Remove the four screws and take off the big black cover
- 4. Use a small cross screwdriver to loosen the three screws, which fix the filter wheel.



- 5. Use the small alam key to remover these two screws.
- 6. Plug out the filter wheel motor and take out the filter wheel including filters.
- 7. Use a forceps to install filter (e.g.520nm) in #4. From #0 to # 3 are the fixed filters, it should be moved.



- 8. Finish the install of filters, then install filter wheel with motor correctly. Remember to screw the three screws to fix the filter wheel.
- 9. Install the black cover, connect the power cable and turn on the instrument.


13.3 Replacement of front-end board

Open the top cover of the machine and remove the light-masking board. Disconnect the power cord and signal cord of the front-end board and remove the fastening screw. Please note where the power cord and the small signal cord, which come from beneath the board, are connected before removing the old front-end board. Wedge the new front-end board in its proper position and connect the power cord and the small signal cord properly. Fix the screw in place. Note that the Hall module at the bottom right corner shall not stick up.




13.4 Replacement of small cart

Open the top cover of the machine and remove the light-masking board. Remove the two fastening screws under the fastening frame of the cart slideway on the right of the small cart. Remove the fastening frame of the slideway and remove the slideway. Loosen the belt's fastening screw at the top left corner of the small cart and turn the small cart by 180 degrees. Remove the small cart's fastening screw and replace the small cart with a new one. Fix the screw in place and turn the small cart by 180 degrees to restore it. Tighten the fastening screw to ajust the belt to a proper elasticity. Restore the slideway and the fastening frame.




13.5 Replacement of drive board

Open the top cover of the machine and remove the light-masking board. Remove the internal hexagonal screw used to fasten the working table and loosen the 3 screws used to fasten the optical fiber. Lift the working table with care and disconnect the wiring on the drive board. Remove the screws and replace the drive board with a new one. Restore the machine. (Note to protect the optical fiber during replacement; protect against static electricity; note not to confuse light-filtering plate motor cable with the 5pin power supply unit cable; note not to omit the insulative pad in installation.)



13.6 Replacement of LCD transfer board

Open the machine covers and remove the light-masking board. Disconnect the wiring on the transfer board and loosen the fastening screw. Replace it with a new board and restore the instrument.




13.7 Adjustment of the spring fixer for matching microplates

Because little difference among the different Microplates, it is allowed to adjust the position of spring fixer for matching the different Microplates.

- 1) Load the Microplate in the plate holder.
- 2) Remove the big screw in the front middle of the instrument then open the instrument upper cover.
- 3) Adjust the spring fixer's position for ensure that the plate holder could hold the Microplate properly.

Note: The tension of spring fixer—— No vibration of microplate when vibrating around the Microplate; Easy to load the Microplate; No sound from the spring fixer when loading the Microplate.

1. Install one side to holder first, see Figure 1



