The following work will be carried out by the Licensor, and delivered to Licensee as part of this agreement:

Training – Licensor shall train Licensee's employees in the use of software. Training shall take no more than five (5) work days and shall take place at Licensee's offices listed above.

Data Conversion – Licensor shall convert Licensee current files to populate the Cases and Writer tables. Conversion results depend on viability of current data and are not guaranteed.

Support:

Licensor shall repair at its expense any problems in the software that Licensee reports to Licensor, and that is due to incorrect coding in the part of Licensor. Licensor liability shall be limited to the repair and replacement of Licensor's software.

Updates

Licensor understand that updates to the software packages after the first year will be billed at 10% of the original licensing fees.

Term:

From execution hereof Licensee has the right to use the software without any time limit.

Payment:

END USER LICENSE AGREEMENT FOR eCandidus SOFTWARE.
