Connections

Turn off this unit and the other equipment before connection. Insert each plug fully. [Plug type: 3.5 mm ($^{1}\!/_{\!6}$ in.) stereo]

When the unit is connected to other equipment, adjust the volume on the connected equipment.



Note on CD-R and CD-RW

(CD-DA/MP3 only)

For CD-DA format, use a music disc and finalize[#] it after recording. The unit may not be able to play some discs due to the condition of the recording.
