## Form C - Notification

The current procedures for servicing Form C requires several steps, alternating between *WCM Center* and *World AMPS (WAMPS)*.

First, on a weekly basis, WCM affiliates offices should log on to *WCMCenter.com* and access *Contract Update CIR* under the *Legal* heading, to retrieve a list of all current contract activity (newly Executed, Amended, Terminated or Options Exercised).

Complete any of the below search parameters (country, week ending, status, contract number) to access the list. For example, use the *week ending* parameter to obtain a list of all new and amended contract agreements for each week since your last Form C servicing update.

Additionally, you can access a comprehensive list in reverse chronological order (starting with the most recent) by changing the *week ending* parameter to "All" and clicking the "Search" button.

A sample list is shown below. Each agreement is listed by update type (Amended, Executed. Option Exercised,

Terminated). An Adobe Acrobat icon (\*) will appear next to the contract number in which the imaged hard copy attachments are available and should be viewed.

- 1. Newly executed agreements will have the following attachments: Schedule "A" (if applicable) and supporting claim documentation, which are the first, second and signature pages of the agreement. Simply click on the Adobe Acrobat icon next to the corresponding contract number to view and/or print.
- 2. Revised/amended contracts (highlighted with an adjoining Adobe Acrobat icon) will contain newly added song listings. Simply click on the Adobe Acrobat icon next to the corresponding contract number to view and/or print.
- 3. All other amendments will <u>not</u> have an attachment needed for download.

3. Enter **16** on the below screen, *World AMPS Main Contract (CTMENUMC)*, to access the *Form C – Contract Brief Inquiry (UIMCS50-00)*.

On the below screen, enter the nine-character **contract number** (e.g. WB 12345 67) found on *Contract Update CIR Listing* on *WCM Center*. The last two digits are for sub-contract files, which are rarely used. The vast majority of contract numbers end with "00".

**TIP** It is not necessary to enter leading zeros! For example, for contract number WB 00001 00, you may simply enter **WB 1**. The last two digits are for sub-files, which are <u>rarely</u> used, but must be entered, if applicable, to access a sub-file brief.

After entering the desired contract number *World AMPS* will access the below screen, *Form C – Contract Summary* (*I*).

To view the latest contract update, enter option 52 (=Form C Rev. Notes).

To view "At Source" or "Not At Source" information, enter option 51 (=Form C Notes).

To view song titles for Life of Copyright Retention Listings for terminated agreements, press X (=Songs).

### HOW TO PRINT FORM C - CONTRACT BRIEF REPORT

To print a physical or hard copy of the Form C brief return to the *World AMPS Main Contract (CTMENUMC)* screen and enter **23** for *Reports Main Form C Contract*.

You can print several contract briefs or a range of contract briefs at one time. Type the contract number or numbers in the appropriate fields on the *Generate Contract Brief Report (URMCS50-00)* screen and press the **Enter** key when done.

If more than one contract number is entered and a coversheet is needed, the Amended Form C's will be held in one print job. Each amendment cover sheet will be an individual print job.

REMEMBER: You do not need to put in the leading zeros.

Please note the *Including the Cover Sheet:* <u>Y</u>(Y/N) field automatically defaults to **Y** for yes.

- 1. Change the default to N (for no) if you are printing Form C's for <u>NEW</u> executed agreements, or if you only need a copy of the Amended Form C and not a copy of the Amendment Notice.
- 2. Leave the default on **Y** (for yes) if you are printing an <u>Amended</u> Form C because this will generate the Amendment Notice, along with a copy of the Amended Form C. They will display as two separate print jobs: one for Form C and one for the Amendment Notice.

#### Sight Verify

A message will appear at the bottom of the screen asking you to "sight verify" the information entered. If the contract numbers are correct, press the **Enter** key again to confirm (the default is "Y"). If not, type **N** and press the **Enter** key to correct the numbers.

The final step is to release the "spooled" file from your Print Queue. This can be accomplished in three easy steps.

<u>Step 1</u>: Access the *Work with Printer Output* screen by returning to the *World AMPS System Functions* screen (function **80** on *World AMPS Main Menu*). Type **6** (=Work with printer output) and press the **Enter** key.
