End user license agreement

IMPORTANT-READ CAREFULLY: This Vianova Systems AS End-User License Agreement ("EULA") is a legal agreement between you (either an individual person or a single legal entity, who will be referred to in this EULA as "You") and Vianova Systems AS for the above-identified Vianova Systems AS software product that accompanies this EULA, including any associated media, printed materials and electronic documentation (the "Software Product"). The Software Product also includes any software updates, add-on components, stencils, templates, shapes, symbols, web services, documentation, training material, brochures and/or supplements that Vianova Systems AS may provide to You or make available to You, or that You obtain from the use of features or functionality of the Software Product, after the date you obtain your initial copy of the Software Product (whether by delivery of a CD or DVD or other media, permitting downloading from the Internet or a dedicated web site, or otherwise) to the extent that such items are not accompanied by a separate license agreement or terms of use. By installing, copying, downloading, accessing or otherwise using the Software Product, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install, access or use the Software Product; instead, you should return it to your place of purchase for a full refund.

SOFTWARE PRODUCT LICENSE

The Software Product and all its contents are protected by intellectual property laws and treaties. The Software Product is licensed, not sold.

1. GRANT OF LICENSE. This Section of the EULA describes Your general license rights to install and use the Software Product. It also describes a set of additional license rights. The license rights described in this Section are subject to all other terms and conditions of this EULA.

1.1 General License Grant to Install and Use Software Product. You may install and use one copy of the Software Product on a single computer, device, workstation, terminal, or other digital electronic or analog device ("Device"). You do not have the right to allow other people to access and use Your copy of the Software Product from Your Device unless You follow the restrictions described in the alternative license grant in the next paragraph. If You run a business or enterprise, You may install a second copy of the Software Product on a portable Device owned by You for the exclusive use of the person within Your business or enterprise who is the user of the primary copy of the Software Product, provided that such person only uses the second copy for business purposes, and provided that such installation and use otherwise comply with all the terms and conditions of this EULA.

1.2 Alternative License Grant for Storage/Network Use. As an alternative to the rights granted in the previous section, You may install a copy of the Software Product on a storage Device, such as a network server, and allow individuals within your business or enterprise to access and use the Software Product from other Devices over a private network, provided that you acquire and dedicate a license for the storage Device upon which the Software Product is installed and each separate Device from which the Software Product is accessed and used. This license does not give you a right to allow anyone to access or use the Software Product over the Internet. 1.6. Reservation of Rights. All rights not expressly granted are reserved by Vianova Systems AS.

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

2.1 Academic Edition Software. If the Software Product is identified as "Academic Edition" or "AE," you must be a "Qualified Educational User" to use the Software Product. If you are not a Qualified Educational User, you have no rights under this EULA. To determine whether you are a Qualified Educational User, please contact the Vianova Systems AS, P.O. Box 434, N-1302 Sandvika, Norway, or the Vianova Systems AS subsidiary serving your country/region.

2.2 Mandatory Activation. You may not be able to exercise Your rights to the Software Product under this EULA unless You register your copy of the Software Product in the manner described during the launch sequence.

2.3 Copy Protection. The Software Product may include copy protection technology to prevent the unauthorized copying of the Software Product or may require original media for use of the Software Product on the Device. It is illegal to make unauthorized copies of the Software Product or to circumvent any copy protection technology included in the Software Product.

2.4 Not for Resale Software. If the Software Product is labeled "Not For Resale" or "NFR," then, notwithstanding other sections of this EULA, your use of the Software Product is limited to use for demonstration, test, or evaluation purposes and you may not resell, or otherwise transfer for value, the Software Product.

2.8 No rental, leasing or commercial hosting. You may not rent, lease, lend or provide commercial hosting services to third parties with the Software Product.

2.9 Support Services. Vianova Systems AS may provide you with support services related to the Software Product ("Support Services"). Use of Support Services, if any, is governed by the Vianova Systems AS policies and programs described in the user manual, in "online" documentation, or in other Vianova Systems AS - provided materials. Any supplemental software code provided to you as part of the Support Services are considered part of the Software Product and subject to the terms and conditions of this EULA. You acknowledge and agree that Vianova Systems AS may use technical information you provide to Vianova Systems AS as part of the Support Services for its business purposes, including for product support and development. Vianova Systems AS will not utilize such technical information in a form that personally identifies you, if this is not agreed and permitted by you.

2.10 Termination. Without prejudice to any other rights, Vianova Systems AS may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the Software Product and return all of its component parts, HW locks etc. to Vianova Systems AS or its subsidiary serving your country/region.

3. UPGRADES.

3.1 Standard Software Product. If the Software Product is labeled as an upgrade, you must be properly licensed to use a product identified by Vianova Systems AS as being eligible for the upgrade in order to use the Software Product. Before you install

About the installation

This guide covers single installation and network installation of Novapoint.

To run the installation programs, insert the *Novapoint DVD* into your computer's DVD drive. The *Novapoint Launcher* starts automatically. If not, run the file *setup.exe* on the DVD drive.

The following steps is required to run Novapoint on a client computer

1. Install Novapoint
2. Install License Hardware Lock (USB HASH) *or* install Network License Manager on a license server
3. Retrieve and install the License Key file (.LIC) locally or get a license server name to use with Novapoint. See *How to License Novapoint* for details.

Upgrade from earlier versions

Novapoint 18.40 is a new product, not an upgraded variant of earlier versions.

You may have other versions of Novapoint installed on the same client computer, but they shall never run at the same time.

Such Side By Side installations makes it easier to gradually go from version to another.

System requirements

Before you install Novapoint on a stand-alone computer, make sure that your computer meets the minimum requirements. See the following table for hardware and software requirements.

Install Novapoint

Prepare for installation

You can take several preparatory steps to ensure that your installation of Novapoint is successful.

1. Make sure you have administrator permissions to the local machine where you shall Novapoint. You do not need to have domain administrator permissions.
2. Update the PC with the latest Windows updates.
3. Make sure all Windows updates are successfully (not failed).
4. Always do a restart before you do a major install. Windows may wait for a restart to finish previous installations and can block new installations.
5. Optional install Autodesk application to use with Novapoint and make sure this runs correct.
6. Make sure you can run with Administrator privileges on the client computer.
7. Close all running applications.
8. If you downloaded the DVD make sure you extract all files and folders (unzip) the installation to a locale folder on your PC and runs from the unzipped folder.

Install Novapoint

To install Novapoint on a stand-alone computer

1. Run Setup.exe from DVD or the unzipped folder of the installation.
2. Select Install from the Install Products page.
3. On the Welcome to the *InstallShield for Novapoint* page, click *Next*.
4. Review the Novapoint software license agreement. You must accept this agreement to complete the installation. To accept, click *I accept the terms in the license agreement*, and then click *Next*.
5. From the "Custom" selection, you can change the "Destination Folder" and if you want to install only "Site Tool program files".
To install only Site Tool program files select "This feature will not be installed" for "Novapoint program files".
When done click Next.
6. On the *Ready to Install the Program* page, click *Install* to begin the installation.
7. Wait until the installation is completed.
8. The *InstallShield Wizard Completed* is displayed when the installation is completed.
9. If the computer have a connection to the internet, check *Yes, check for program updates (recommended)*.
10. Click *Finish* to close the *Novapoint InstallShield Wizard*.
11. Update the PC with the latest Windows updates and restart the PC.
12. Install a license for Novapoint. See *How to license Novapoint* on the *Licensing Novapoint* page
13. Start Novapoint and select the AutoCAD and configuration to use.

First time startup configuration

The configuration dialog starts the first time Novapoint starts up or you have used the Reset User Settings to delete Registry values for Novapoint.

The selection is stored in the Current User area in the registry:

If you prefer to avoid the first time startup dialog to pop up, these values have to be set. The content varies based on the AutoCAD version and Novapoint configuration.

Uninstall Novapoint

Always uninstall Novapoint using the uninstall feature in Add / Remove programs. To uninstall Novapoint.

1. On the *Start* menu, click *Control Panel*.
2. In the Control Panel, double-click *Programs and Features*
3. In the *Uninstall or change a program* window, select *Novapoint 18.40* from the list, and then click *Uninstall*.
4. Follow the instructions.

Unattended installation

You may install Novapoint 18.40 from the command-line.

The Novapoint 18.40 installation files is found on the DVD in the folder "Install\Novapoint"

Install running from the command-line

The installation requires administrator privileges on the client computer

Syntax:

To install Novapoint using MSIEXEC.EXE use the following syntax:
msiexec /i "[PATH to Novapoint Install files]\Novapoint 18.40.msi" INSTALLDIR="c:\Program Files\Vianova\Novapoint\18.40" /qb

Note: Installing using the MSI-file will not install the setup prerequisites included in Setup.exe. Install prerequisites one by one prior to the installation of Novapoint MSI-file.

Prerequisites for Microsoft .NET and "Microsoft Visual C++" are installed if an AutoCAD 2016 product already is installed.

You may skip this part and only install the "Microsoft SQL Server Compact 3.5 Service Pack 2" part to use with Novapoint.

Novapoint 18.40 depends on the following prerequisites:

- Microsoft .NET Framework 3.5 SP1
- Microsoft .NET Framework 4.0 Full Update KB2468871
- Microsoft .NET Framework 4.5.1 Full

In Windows 8 can enabling or disabling .NET 2.0, 3.0, 3.5, 4.0 and 4.5 be done from Control Panel or Deployment Image Servicing and Management (DISM).
