Simple Search

Simple Search allows you to find the cases containing specified words or phrases. Simple search can be performed in :

Content, Titles, My Notes (Annotations) with different proximity options for more accurate results.



Progressive Search

Search within result

To narrow down your result list, check “Search within result” box and perform another search. You can combine simple search with advance search.

Saving searches

Click on Save Button to save the result set with any name for future reference if required. All the saved searches will be available in “My saved searches” on home page. Click on the name to retrieve the pre-saved query results.

Attach Keyword



Select a case/s by using check box on the Result list and click on Attach keyword. Add new keyword to the selected case/s or use existing keyword. You can also attach keyword while you are reading the case. The list of all the keywords is available on home page. You can retrieve the case/s by clicking on the desired keyword.

Text Viewer


Click on the case on the result list to read the text. There are various icons available on the text viewer page for easy navigation. Cross linking to Backward and Forward cases is available here.

Text viewer by default is set on “Context view”. This allows you to read only the relevant text which is in the proximity of 'X' words of your search term. By clicking the ‘Zoom’ link, you will be taken directly to the context within the Case so that you can read more from the entire text.

Annotations (your own notes)



On reading some Text, you may feel like making your own comments. Click on “My Notes” icon and write your notes on any case. You can copy and paste Text from the underlying text in the Box. The notes become searchable once they are saved.
