JURICERT REGISTRATION PROCESS	
Welcome to the Juricert Registration Process. Please read the following carefully before proceeding.	
There are seven steps in the Juricert Registration Process that you will complete on subsequent pages.	
1. On the first page you will be asked to select a registration category. You need to select a category to continue with your registration.	
2. On the second page, you will be asked to agree to certain terms and conditions. You must accept the terms and conditions to continue your registration.	
3. On the third page if you are a member of the 1 aw Bocklay of British Columbia and have NDT chosen to register for Trust Reports Online only you will be asked to enter your first and last names and your Law Society of British Columbia member number. All other registrants are asked to provide certain identification information. In either case, this will set up your registration information with Justicer and form the basis for printing your grigitration form in the next step.	
4. On the fourth page, you will be given an opportunity to review and edit the information you have entered. If you need to make a correction or add information, click Edit.	
5. On the fifth page, you will be asked to print your registration form. Clicking on the Print Registration Form button will open a new window and displayyour registration form for printing. Once you have completed printing of your registration form, you may close the new window that was opened when you clicked on Print Registration Form.	
6. Once you have closed your registration form window, your Juriced Identification Number will be displayed. For security reasons, this will be your only chance to record this number to apply for any pathor services or to complete your Trust Report Online. This number uniquely identifies you online and you should safeguard it against improper use by others.	
7. On the seventh page you will have the opportunity to select a partner service. You may quil the registration process at this point if you wish. Den't forget to complete your registration form and fax it to Auricent or your registration will not be complete. If you do select a partner, you will be asked to complete the requirements for that partner.	
If you are ready to proceed, click the CONTINUE button.
