#### What's New in This Release?

KC Release 5.1.1 includes:

- Fixes and additional features in the Conflict of Interest (COI) to meet functional equivalence to Coeus
- Critical fixes to other KC modules
- Upgrade of Rice to version 2.1.7

#### Notes:

- COI workflow: If an implementer applies Kuali Enterprise Workflow (KEW) to COI disclosures, please be aware that a Disapprove action in KEW will cause the disclosure document to be locked down and uneditable.
- The KC User Manual for Release 5.1.1 will be made available in about three weeks.

- The KC release packaging has been modified in a way that will change deployment procedures for implementers who use the precompiled war. There is no longer a hardcoded environment within the war and it should be passed via the web application container (for example, in the catalina.sh within the JAVA\_OPTS parameter as –Denvironment=ptd).

#### Important Technical Notes:

- iText 2.1.7 library is slated for removal in KC 5.2. Any implementer customizations or dependencies on this library should be removed.
- Workaround to import XML to Adobe Package (<u>KRACOEUS-6038</u>): The current implementation of saving the Grants.Gov XML requires the selection of forms to be printed before executing the Save XML action. The resulting zip document contains the XML and any related attachments needed for the selected forms. However, the XML content needs to be manipulated before it can be imported into the related Adobe Package. Implementers should use the workaround document attached to <u>KRACOEUS-6038</u> to build an XML document that can be imported into the Adobe Package.
- The required Oracle jdbc driver dependency within the project has changed from ojdbc14 to ojdbc6, because the older driver can cause issues with newer Oracle servers (and should not be used with a mismatched Java version, anyway). Be sure to update your local Maven repository with the appropriate driver, if you are building from source.
- The build process no longer allows for hardcoding the build.environment/environment into your resulting war file. If you desire to hardcode an environment code into a war rather than passing it through your



web application container, you can do so by adding an environment param within the kc-config-build.xml file along with the hardcoded value.

#### Known Issues with Upgrade Scripts:

- While upgrading MySQL, if the Rice server has already been upgraded separately to 2.1.7, the KC mysql install results in a few errors. Since this is not a common platform or procedure to upgrade KC, we will work with individual institutions that may see these.
- While upgrading Rice from 1.0.3.x to 2.x, an error is thrown by quartz on startup which reads something like "stream classdesc serial/VersionUID = 5807770268543892618, local class serial/VersionUID = 5096393175403095624". The fix for this is to delete all entries from the tables krsb\_qrtz\_blob\_triggers and krsb\_qrtz\_triggers and restart Tomcat or to extract the data from the quartz tables using the version of quartz installed in your current installation and import it back in using the version of quartz in the upgraded installation.
- While upgrading from versions older than Rice 2.1.7, null constraint violations might be thrown about existing pessimistic lock entries in the KRNS\_PESSIMISTIC\_LOCKS tables. Please delete all entries from this table before upgrading.
