I-4. Étiquette du produit

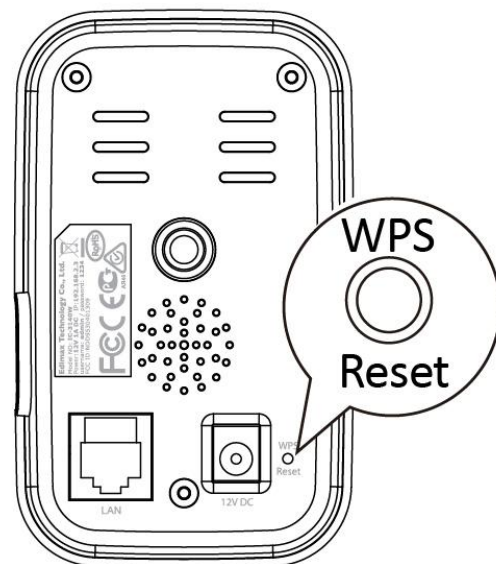

I-5. Réinitialiser

(Hereinafter, translation is included without limitation in the term "modification".) Each licensee is addressed as "you".
