- 4.Close the battery cover and replace the visor back on the camera.
- 5.Screw on mounting bracket to the camera to secure.
- 6.Choose a suitable location and mount the bracket to wall with the screws included to secure the camera.
- 7.Reposition the camera angle as desired.
