Installation




Failure to comply with the following could result in death or serious injury.

- Only use the specified attachments or accessories.


Install the BKW-SUR bracket and wall mount

- 1. Using a 5 mm Allen key, remove the 6 mm socket head cap screw, washer, and lock washer (A) from the bracket.
- 2. Using a 3 mm Allen key, loosen (do not remove) the 4 mm socket head cap screw (B) until the two bracket halves slide apart.




3. Remove the four M8 bolts and lock washers from the back of the LS3S speaker.






- 4. Position the speaker mounting half of the bracket on the back of the LS3S speaker and align it with the four mounting holes.
- 5. Secure the speaker mounting half of the bracket to the speaker with the four M8 bolts and lock washers removed in step 3.






6. Attach the wall mount to the wall using appropriately sized lag bolts (not included in the box) according to laws and regulations applicable to the venue.






7. Place the speaker mounting half of the bracket against the wall mount and align the bracket holes.



- 8. Using a 5 mm Allen key, install the 6 mm socket head cap screw, washer, and lock washer (A) removed in step 1. Tighten the screw until it is snug.
- 9. Using a 3 mm Allen key, tighten the 4 mm socket head cap screw (B) until the two bracket halves are secure (no play or sliding between the two halves).
