TROUBLESHOOTING

If no power is coming out from the 12V socket or the LED light is not charging, unscrew the tip of the 12V socket head. (NOTE: Do not attempt to remove or unscrew the LED light). Check the fuse inside. If the fuse is burned out, please replace it with a new one with the same amperage indicated. The replacement fuse can be purchased from your local electronics store.

NOTE

The DC outlet (cigarette lighter socket) on the unit can be used to hold up to a 75 Watt load.

WARNING

Using more than 75 Watts will damage the unit and void the warranty.

WAGAN Corporation will, at its option, replace or repair the defective part.

A Returned Merchandise Authorization number (RMA#) is REQUIRED when sending in any defective item.
