# **Warranty**

#### SCOPE OF THE WARRANTY

Subject to legal provisions, the responsibility of SECU4 under this warranty is limited to the provisions set out below: SECU4 warrants that this product is safe from material and manufacturing defects under normal conditions of use for a period of TWO (2) YEARS from the date of end-user purchase. If a product defect is encountered within the warranty period and a valid claim is lodged, SECU4 will replace the product with either a new complete unit or with a new accessory if the default found is limited to an ancillary product.

When a product or an accessory is replaced, it becomes the property of the buyer and the product or accessory exchanged becomes the property of SECU4. The warranty accorded to the exchanged product will not exceed the original warranty.

#### **EXCLUSIONS AND LIMITATIONS**

This limited warranty applies only to hardware products manufactured by or on behalf of SECU4 which can be identified by the trademark, trade name or SECU4 logo which is affixed on them. The software distributed by SECU4 without or under the trade name SECU4 (including, but not limited to, system software) is not covered by this limited warranty. Kindly refer to the accompanying software license agreement accompanying the software for details of your rights concerning its use.

SECU4 does not warranty that the operation of the product will be uninterrupted or error-free. SECU4 is not liable for damage resulting from non-compliance with usage guidelines of the product.

# Introduction

SECU4Bags $^{\text{TM}}$  is a mobile alarm system for protection of your valuables such as wallets, bags, laptops, etc.

SECU4Bags  $^{\text{TM}}$  works via an application downloaded to your mobile phone\* equipped with Bluetooth  $^{\odot}$  functionality.

# **Security information**

- ► The maximum sound level of the alarm is higher than 100db. Under no circumstances should SECU4Bags™ be brought too close to your ear. It is likely to inflict irreversible damage to your hearing.
- ► Abide by the laws and local restrictions on the use of SECU4Bags™ e.g. in planes or in hospitals.
- ▶ Under no circumstances should SECU4Bags™ housing card be opened. The batteries included can cause significant damage to your health.
- $\blacktriangleright$  Do not let the children handle your SECU4Bags  $^{\!\top\!\!}$  without close surveillance.

# **Quick start**

## 1 Compatibility test and software installation

Test your mobile phone's\* compatibility using its wireless Internet connection.

**NOTE:** Where available, the dedicated application can be downloaded from your smartphone's application store. Search for "SECU4Bags™"

**NOTE:** If your mobile phone\* does not have wireless Internet access, proceed to step 1.4.

#### 1.1 Compatibility test via SMS (for EU)

- ► Send an SMS from your mobile phone\* with the short text "BAGS" to +44 762 480 0482.
- ▶ Open the link received to test the compatibility.
- ▶ If your mobile phone IS compatible, a FREE application will download automatically via your wireless Internet connection (local cellular data transfer rates apply).

## 1.2 Compatibility test via INTERNET

- ▶ Open your mobile phone's\* Internet browser.
- ▶ In the address bar enter the following link : http://t.secu4.com.
- ▶ Press Send/Enter/Get Link to access the http://t.secu4.com website.
- The http://t.secu4.com mobile phone\* testing site will then verify if your mobile phone\* is compatible with your SECU4Bags™.
- ► Your SECU4Bags™ will NOT work with your mobile phone\* if your screen displays "Unfortunately your mobile phone\* is not compatible".
- ▶ If your mobile phone\* IS compatible, a FREE application will download automatically via your wireless Internet connection (local cellular data transfer rates apply).
- ▶ The SECU4Bags™ application will appear in your product Application Menu.
- ▶ Proceed to step 2 (setting up the card).

- ▶ Follow the instructions of the website.

# 2 Setting up your SECU4Bags™

#### **Before first use - IMPORTANT**

- ► Charge your SECU4Bags<sup>™</sup> on your computer via the USB cable included or by using the travel USB socket charger (use the one supplied with your mobile phone or purchase separately).
- ▶ The top light 🖎 flashes. The charging time is approximately 3 hours.
- During the initial charge, it is advised not to disconnect your SECU4Bags™ before the flashing light \(\sigma\) completely switches itself off.

# Activation of your SECU4Bags™

- ▶ Press the on/off side button of for 1 second.
- ▶ The bottom icon ••) illuminates.
- ► To switch off your SECU4Bags<sup>™</sup>, keep the on/off side button pressed for 3 to 5 seconds.

# 3 Activation of the protection

#### On your SECU4Bags™

- ▶ Press your SECU4Bags™ on/off side button of for 1 second.
- ► The icon illuminates.

#### On your mobile phone\*

▶ Open the mobile phone application "SECU4Bags™". Accept the Bluetooth® permission request.

Note 1: If your Bluetooth® is already turned on, there won't be a Bluetooth® request

Note 2: If you encounter a problem, refer to the user manual of your mobile phone\* or on the SECU4 website **www.secu4.com**.

- ► Click on the welcome screen of the application.
- ▶ The application looks for your SECU4Bags™ via Bluetooth® wireless technology.
- ► Enter the pairing code "0000".

Note 1: The search time for your SECU4Bags<sup>™</sup> can take up to 1 minute.

Note 2: If your SECU4Bags<sup>™</sup> is not recognised, ensure that it is turned on and operating.

Note 3: If several SECU4Bags<sup>™</sup> cards are located within a close range, make sure that no other SECU4Bags<sup>™</sup> is turned on at the same time.

Note 4: You only need to pair your SECU4Bags  $^{\!\top\!\!}$  and your mobile phone\* once.

- ▶ The icon )) on your SECU4Bags™ blinks.
- ▶ Click on the "Start protection" application icon on your mobile phone\*.
- ▶ The icon ◆ on your SECU4Bags™ blinks.
- ▶ The protection is active, the "Protecting" icon appears on your mobile phone\*.
- ► Slip your SECU4Bags<sup>™</sup> into the object you want to protect and keep your mobile phone\* near you.

#### Notes:

- Do not put your mobile phone\* in the protected object.
- Avoid inserting your SECU4Bags™ inside metal objects or very close to objects that could disrupt the Bluetooth® signal emission (key, magnet, etc.).

The object in which you have inserted your SECU4Bags<sup>™</sup> is now protected. The default protection parameters are:

Protection zone: distance = middle (about 10 to 15 meters, 33 to 50 feet)

Alarm time delay: 5 seconds

Alarm volume level on your SECU4Bags™: level 3 (~80dB)

Alarm on your mobile phone\*: ringing and vibrating

If your protected object is moved out of the protection zone, your mobile phone\* will ring and/or vibrate and display an alarm icon  $\bigcirc$ . You will then have a few seconds to react and return to the protection zone. After that delay and if enalbled, the alarm be activated on your SECU4Bags $^{\text{TM}}$  and protect the object in which it is inserted.

If the alarm goes off by mistake you can disable it by pressing the alarm icon **o** on your mobile phone\* when you are inside the protection zone.

If your SECU4Bags™ alarm goes off, it will be automatically turned off when you re-enter the protection zone.

Tap the icon **ひ** on your mobile phone\* to exit the application. Your SECU4Bags™ will then automatically turn itself off.

## **IMPORTANT!**

- 1. For optimal performance keep your SECU4Bags™ more than 20cm away from your mobile phone\*.
- 2. Do not use your SECU4Bags™ when the battery is exhausted. Its effectiveness is reduced and the frequency of false alarms increases.
- 3. Do not use your SECU4Bags™ in airplanes or other places that require your mobile phone\* to be switched off.
- 4. During surveillance of persons, set the alarm volume to a minimum or to silent.

# Symbols on your SECU4Bags™



# 1. On/off top button

- ► Press this button for 1 second to activate your SECU4Bags™.
- ▶ Press for 3 to 5 seconds to turn it off.

## 2. Charge via USB port

▶ Connect the USB cable provided with your SECU4Bags™ on a computer or a travel charger. Recharge the batteries system until the battery blinking light goes out.

#### 3. Batteries

- ► → (Fast flash) Battery level is low! Recharge your SECU4Bags™ as soon as possible.
- ► → (Slow flash) SECU4Bags™ is on charge.
- ► □ (No flashing light) The recharge of your SECU4Bags™ is complete. Refer to the SECU4Bags™ battery level indicator on your mobile phone\* to check the current battery level of your SECU4Bags™ card.

#### 4. Protection/Alarm

- ► ★ SECU4Bags™ is in protection mode.
- ► ★ SECU4Bags™ is in alarm mode.

#### 5. Activation/Connection

- ▶ ★ SECU4Bags™ is on.
- ► ★ SECU4Bags™ is connected to the mobile phone\*.

# **Application icons**

SECU4Bags™ is connected. By tapping on this icon, you can start the protection.

Object under surveillance. By tapping on this icon, you can stop the protection.

In case of an alert, you are warned by this icon. You can stop the alarm by tapping on this icon.

#### Settings icons (click on the icons to select the various possible settings):

Protection distance: near, middle, far.

Time delay for alarm activation on your SECU4Bags™ following the receipt of an alert on the mobile phone: 1 to 15 sec.

Sound level of the alarm: choice of 5 different levels.

Type of alarm on your mobile phone\*: ringing and vibrating, or vibrating only.
