Needs Assessment Tool

The **Needs Assessment Tool (NAT)** was developed by the Riverside County Office of Education (COE) to assist local educational agencies (LEA) in conducting a local needs assessment based upon required and locally identified metrics included in the Local Control and Accountability Plan (LCAP). The local needs assessment is an essential LCAP building block and the NAT provides a foundation for the meaningful engagement of stakeholders and the development of goals and actions based on measurable student outcomes. The NAT allows LEAs to gather and display data for an individual school, program, or for an entire district, charter, or county office of education. Additionally, it allows LEAs to display trend data for each identified subgroup simplifying the identification of significant areas of need.

This manual, written by School Services of California, Inc., in cooperation with the Riverside COE, has been developed to assist you in utilizing the NAT. The NAT is a Microsoft Excel file with two workbooks: data (Data tab) and report (Report tab). All of the data/information is entered into the Data tab. No inputs should be entered directly into the Report tab. In addition, no cells, rows, or columns should be deleted as that will result in an error message on the Report tab. The following provides instructions on how to input data into the Data tab and how to analyze the data on the Report tab.

Entering Data

All of the information necessary for the Data tab should be readily accessible through your district's existing systems; however, most of the information can also be found online. Please see Appendix A: Data Sources for instructions on where and how to access the information available online.

Please note that while the NAT is set up to have information entered and displayed by subgroup, in addition to district- and state-wide, not all data is available by subgroup or for the state. For those metrics for which information is not available, the input boxes have been crossed out.

- 1. Click on the Data tab to begin.
- 2. The columns contain state and district data for comparison, along with the district's significant subgroups.
 - a. Extra columns have been included to allow you to enter additional subgroups relevant for your district. Simply select the cell that states "District Identified Subgroup" and replace the text with the title of your subgroup.
 - b. Subgroups that are not relevant to your district should be left blank and not deleted. Deleting columns will cause error messages to appear on the Report tab.

- c. However, if you find that you have an additional district identified subgroup, you can replace existing subgroups with district identified subgroups by simply typing the name of the district identified subgroup over the prepopulated subgroup.
- 3. The rows contain metrics that are being tracked by the district grouped by state priority. Those metrics with asterisks are required by the Education Code. The remaining metrics have been provided as examples or have been used by various districts across the state. Each metric encompasses three rows representing three prior years.
 - a. Extra rows have been included to allow you to enter additional district identified metrics. Simply select the cell that states "District Identified" and replace the text with the title of the district identified metric. Remember that for each metric, you will have three rows of information to add.
 - b. Non-state required metrics that are not relevant to your district should be left blank and not deleted. Deleting rows will cause error messages to appear on the Report tab.
 - c. However, if you find that you have additional district defined metrics, you can replace non-state required metrics with district defined metrics by simply typing the name of the district defined metric over the prepopulated metric.
- 4. All information must be entered into the Data tab. You can either cut and paste the information from other sources or manually enter the data. If you will be manually entering the data, you have two options:
 - a. You can manually enter data in the cells; or
 - b. You can utilize the data entry form by clicking on the DATA ENTRY button to the right of the columns containing the subgroups.
 - i. A form window will open which contains a page for each row (e.g., metric). To enter information, simply type in the required information.
 - ii. The tab key will allow you to move from one cell (e.g., subgroup) to the next.
 - iii. There are three ways to navigate between the metrics: 1. Hit the enter key; 2. Use the arrow down arrow to advance to the next metric or the up arrow to go back to a previous metric; or 3. Use the "Find Prev" and "Find Next" buttons to navigate between metrics.
 - iv. Once you have finished with all of the metrics, click on the "Close" button.
- 5. Be aware of the format in which data is entered. All percentages should be entered in whole number and not decimal format (i.e., enter 32.5% as 32.5 not .325).

6. Now that all of the data has been entered, click on the Report tab.

Reading the Report

- 1. As with the Data tab, the columns contain state and district data for comparison, along with the district's significant subgroups.
 - a. If you entered any additional district identified subgroups, they will be displayed in the columns to the right of the prepopulated subgroups.
 - b. If there are subgroups that are not relevant to your district and were left blank in the Data tab, you can hide those columns so that they do not appear in you report. Once again, do not delete the columns as this will cause error messages to appear.
 - i. In order to hide a column, simply right click on the column letter along the top of the workbook and select "Hide" from the menu.
- 2. As with the Data tab, the rows contain metrics that are being tracked by the district grouped by LCAP category (e.g., Conditions of Learning, Pupil Outcomes, and Engagement) and then by state priority. Some metrics have a red flag in the upper right hand corner of the cell. Hovering over the cell will provide you with a brief description of the metric.
 - a. If you entered any additional district identified metrics, they will be displayed in the rows after the prepopulated metrics.
 - b. If there are non-state required metrics that are not relevant to your district and were left blank in the Data tab, you can hide those rows so that they do not appear in you report. Once again, do not delete the rows as this will cause error messages to appear.
 - i. In order to hide a row, simply right click on the row number along the left of the workbook and select "Hide" from the menu.
- 3. Each cell or square contains an aggregate of the three years' worth of information entered into the Data tab. Each square, therefore, provides a quick and easy overview that, at a glance, informs you how the subgroup is performing on a given metric in the previous year and over time, and allows for the comparison of the subgroups against one another and against the state and district as a whole. Further detail on the squares is discussed below in "Understanding the Square".
- 4. Once you have entered data into the NAT, you will see red, yellow, or green "stop lights" along the top of each state priority.
 - a. The stop lights are included to draw attention to a subgroup that is performing below the district as a whole and to prompt a second look at the data. It may be that the difference is minimal and can be ignored, but the presence of a yellow or red stop light indicates that the metric warrants a second look.

- b. When all metrics within a priority are positive (i.e., the subgroup is performing at or above the district as a whole), then the stop light is green.
- c. When at least one of the metrics within a priority are negative (i.e., the subgroup is performing below the district as a whole), then the stop light is yellow or red.
 - i. A yellow stop light will be displayed when 50% or less of the metrics within a priority are performing below the district as a whole.
 - ii. A red stop light will be displayed when 51% or more of the metrics within a priority are performing below the district as a whole.

Understanding the Square

- 1. Each cell or square contains the following information:
 - a. The number shown in each square represents the metrics previous year's value.
 - b. The line within each square represents the trend for the three years, which provides the ability to visually see the change in that metric over time (i.e., a flat line indicates there has been no change over the three-year period while a "v" shaped line would indicate that the metric dipped in the second year and has now rebounded).
 - i. Each line includes three markers representing the values of the metric for each year of data provided.
 - ii. For the majority of the squares, the height represents the range for that metric and the location of the line on the y axis represents the values location within that range. For example, API scores range from 200 to 1000. A district with an API of 600 for all three years would show a straight line across the middle of the square.
 - iii. Lines without all three points or drastic swings in the line indicate a second look at the data is warranted to ensure accuracy and/or that all information has been entered. It is possible that a data point was intentionally left blank (i.e., no students from a particular subgroup were present in the given year); however, the lack of three points or drastically swinging lines should prompt a second look at the information to ensure the omission was intentional.
 - c. If the square is red, this represents that the value of that subgroup's metric is less than the district as a whole, which may provide evidence of an achievement gap and indicate that that subgroup needs improvement. Closer inspection may show that the difference is minimal and can be ignored, but the presence of the red square indicates that the metric for that subgroup warrants a second look.

The SARCs available on the California Department of Education's (CDE) website are for the 2012-13 school year. To obtain SARCs for previous years, go to your school or district website.

Where multiple data is provided for one category (e.g., Student Lacking Own Copy of Textbook Rate includes a percentage for each textbook), an average should be calculated.

For those categories for which the SARC does not provide a percentage (e.g., Teacher Misassignment Rate, Credentialed Teacher, etc.), a percentage will need to be calculated by dividing the number of teachers in the particular category by the total number of teachers.

 - a. If you don't select county, you will get statewide results

CST summary report provides an overall summary and not detail by grade level and subject. The needs assessment tool only requires this summary information.
