Important Safety Instructions

When using your telephone equipment, basic safety precautions should always be followed to reduce the risk of fire, electric shock and injury, including the following:

- 1. Read and understand all instructions.
- 2. Follow all warnings and instructions marked on the product.
- 3. Unplug this product from the wall outlet before cleaning. Do not use liquid or aerosol cleaners. Use a damp cloth for cleaning.
- 4. Do not use this product near water such as near a bath tub, wash bowl, kitchen sink, laundry tub or swimming pool, or in a wet basement or shower.
- 5. Do not place this product on an unstable table, shelf, stand or other unstable surfaces.
- 6. Slots and openings in the back or bottom of the telephone base and handset are provided for ventilation. To protect them from overheating, these openings must not be blocked by placing the product on a soft surface such as a bed, sofa or rug. 


About cordless telephones

- Privacy: The same features that make a cordless telephone convenient create some limitations. Telephone calls are transmitted between the telephone base and the cordless handset by radio waves, so there is a possibility that the cordless telephone conversations could be intercepted by radio receiving equipment within range of the cordless handset. For this reason, you should not think of cordless telephone conversations as being as private as those on corded telephones.
- Electrical power: The telephone base of this cordless telephone must be connected to a working electrical outlet. The electrical outlet should not be controlled by a wall switch. Calls cannot be made from the cordless handset if the telephone base is unplugged, switched off or if the electrical power is interrupted.
- Potential TV interference: Some cordless telephones operate at frequencies that may cause interference to televisions and VCRs. To minimize or prevent such interference, do not place the telephone base of the cordless telephone near or on top of a TV or VCR. If interference is experienced, moving the cordless telephone farther away from the TV or VCR often reduces or eliminates the interference.
- Rechargeable batteries: Exercise care in handling batteries in order not to create a short circuit with conducting material such as rings, bracelets, and keys. The battery or conductor may overheat and cause harm. Observe proper polarity between the battery and the battery charger.
- Nickel-metal hydride rechargeable batteries: Dispose of these batteries in a safe manner. Do not burn or puncture the battery. Like other batteries of this type, if burned or punctured, they could release caustic material which could cause injury.



Before use

Add and register a handset

You can add new **DS6600** handsets (purchased separately) to your **DS6611/DS6621** telephone system. Your **DS6611/DS6621** telephone system supports a maximum of five handsets.

Register each handset with the **DS6611/DS6621** telephone base before use. After charged, each expansion handset alternately displays **To register HS...** and **...see manual**.



Charge the new handset without interruption for at least 30 minutes before registering it to the telephone base.

To register a handset:

Place the new/non-registered handset in the telephone base. The handset shows Registering...

DS6621 telephone base

Do not place the handset in the charger.

The handset shows **Registered** and you hear a beep when the registration process completes. The registration process takes about 90 seconds to complete.

Deregister handsets

To replace a handset or reassign the designated handset number of a registered handset, you must deregister all handsets and then register each handset individually.

To deregister all handsets:

- 1. <u>Press and hold</u> /FIND HANDSET on the telephone base for about 10 seconds until the IN USE light on the telephone base flashes.
- 2. Immediately press //FIND HANDSET again.

All handsets show **To register HS...** and **...see manual** alternately when the deregistration process completes. The deregistration process takes about 10 seconds to complete.


Operating range

This cordless telephone operates with the maximum power allowed by the Federal Communications Commission (FCC). Even so, this handset and telephone base can communicate over only a certain distance - which can vary with the locations of the telephone base and handset, the weather, and the layout of your home or office.

When the handset is out of range, the handset displays Out of range or no pwr at base.

If there is a call while the handset is out of range, it may not ring, or if it does ring, the call may not connect well when you press $\hat{\mathbf{A}}$ /HOME or $\hat{\mathbf{P}}$ /CELL. Move closer to the telephone base, and then press $\hat{\mathbf{A}}$ /HOME or $\hat{\mathbf{P}}$ /CELL to answer the call.

If the handset moves out of range during a telephone conversation, there may be interference. To improve reception, move closer to the telephone base.

ECO mode

This power conserving technology reduces power consumption for optimal battery performance. The ECO mode activates automatically whenever the handset is synchronized with the telephone base

The handset shows ECO when the ECO mode activates.

Energy-saving charging mode

When first purchased and properly installed for charging (see **Install the battery**), put the handset on the handset charger to charge. The energy-saving charging mode is activated while charging. When this mode is activated, all telephone functions, except handset battery charging, will be disabled.

If you have registered the handset to the DS6611/DS6621 base, follow the instructions below to activate and deactivate the energy-saving charging mode.

To activate the energy-saving charging mode:

- 1. Unplug the telephone base power adapter from the power outlet. Make sure all handsets are plugged with charged batteries before proceeding.
- 2. While you press and hold //FIND HANDSET, plug the telephone base power adapter back to the power outlet.
- 3. After about 20 seconds, when the IN USE light starts flashing, release //FIND HANDSET and then press it again within 2 seconds.

When the phone successfully enters the energy-saving charging mode, the IN USE light turns off and all handsets display To register HS... and ... see manual alternately.

When the phone fails to enter this mode, repeat Step 1 through Step 3 above.

The telephone base will be powered up as normal if you fail to press //FIND HANDSET within 2 seconds in Step 3.

To deactivate the energy-saving charging mode:

- 1. Unplug the telephone base power adapter from the power outlet, and then plug it back in. Then the telephone base is powered up as normal.
- 2. Register your handsets back to the telephone base. See page 4 for handset registration instructions.

General product care

Remember that electrical appliances can cause serious injury if used when you are wet or standing in note water. If the telephone base should fall into water, DO NOT RETRIEVE IT UNTIL YOU UNPLUG THE POWER CORD AND TELEPHONE LINE CORD FROM THE WALL. Then remove the telephone by the unplugged cords.

Taking care of your telephone Your cordless telephone contains sophisticated electronic parts, so it must be treated with care.

Avoid rough treatment

Place the handset down gently. Save the original packing materials to protect your telephone if you ever need to ship it. Avoid water

Your telephone can be damaged if it gets wet. Do not use the handset outdoors in the rain, or handle it with wet hands. Do not install the telephone base near a sink, bathtub or shower.

Electrical storms
