

### **1.Hardware overview**


#### 1-1. Port name and function

1	LED (Power)	Power on / off indicator	
2	LED (Status)	Status indicator	
3	Restart switch	Push to restart device	
4	Initialize switch	Push and hold for 10 seconds to initialize to factory default	
5	Control out	Control signal out for door control or external alarm /lamp	
6	DC-in	DC inlet from AC adapter	
7	Ethernet PoE	Prnet PoE Connect to Ethernet for IP camera. PoE power supply is available	
8	Wireless	Connect to wireless module	

#### 1-2. Connectors


In case of using AC power supply Connect DC line from AC adapter. CAUTION USE ONLY GENUINE AC ADAPTER




#### IP camera

Connect IP camera via Ethernet

In case of using PoE function Use category 5e or higher cable. Never connect to AC adaptor.





Make sure installing area is enough and near switch device. Screw up to the wall with these 4 points.






### 3) Connecting


Connect Ethernet cable.

#### Pattern2 : Using Power cable






