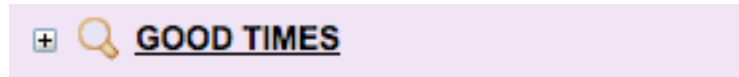
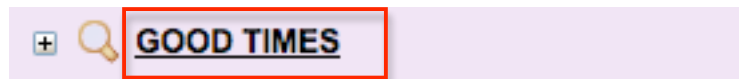


## How can I Display Work Details in CIS-Net?

There are two ways to display work details from the results page.



### First Option: Click on Work Title Hyperlink



This opens a new page providing all relevant details (as defined in your profile) on selected works together with a set of buttons/facilities such as 'View works', 'View Agreements' and 'IPI Details'

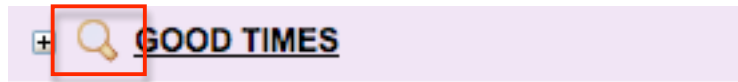

This opens a pop-up screen within the same page and provides the same level of details and the same access to functionalities as for the 1<sup>st</sup> option.
