

PLEASE READ AND SAVE THESE IMPORTANT SAFEGUARDS

Thank you for choosing an Optimus heater. To ensure the best performance from your heater, please read and save the following instructions.

WHEN USING ELECTRICAL APPLIANCES, BASIC PRECUATIONS SHOULD ALWAYS BE FOLLOWED TO REDUCE THE RISK OF FIRE, ELECTRIC SHOCK AND INJURY TO PERSON, INCLUDING THE FOLLOWING:

- · Read all instructions before using this heater.
- This heater is not when in use. To avoid burns, do not let bare skin touch hot surfaces. Use grip handle when provided.
- Keep combustible materials such as drapes, furniture, pillows, bedding, papers, clothes, and curtains
 at least three (3) feet (0.9m) from the front of heater and keep them at least 1 foot (0.3m) the sides
 and rear of the heater.
- Extreme caution is necessary when heater is used by or near children or invalids and whenever the heater is left operating and unattended.
- Always unplug heater when not in use.
- Do not use any heater with a damaged cord or plug or after the heater malfunctions or has been
 dropped or damaged in any manner. Return heater to manufacturer for examination, electrical or
 mechanical adjustment, or repair. (See Warranty for information).
- Do not use outdoors.
- This heater is not to be used in bathrooms, laundry areas or other similar indoor locations. Never locate heater where it may fall into a bathtub or other water container.
- Do not run cord under carpeting. Do not cover cord with throw rugs, runners or the like. Arrange cord
 away from traffic area where it will not be tripped over.
- To disconnect heater, turn control to OFF then remove plug from outlet.

During Season Care:

- Before cleaning, be sure to turn off and unplug the heater.
- Carefully wipe the unit with a soft, damp cloth. Please be very cautious near the motor and heating elements.
- · Do not immerse the heater in water.
- Never use gasoline, benzene or thinner. This will damage the surface of the heater.
- After cleaning, be sure to completely dry the unit with a cloth or towel.

After Season Care:

- · Store heater in a cool and dry location with power cord properly secured.
- Please store the unit in its original carton or suitable container.

OPERATING INSTRUCTIONS:

Pre-Operating Instructions:

- Carefully remove your heater from the box (please save the carton for off-season storage).
- Make sure the unit is in the OFF position before plugging the heater into the outlet.
- · Place heater on a firm level surface.

Operating Instructions:

- Put the Remote Control Hand Unit Cradle on either side of the U-shapped supporter by sliding it down from the top.
- Plug the power cord into a wall outlet (110-120V AC,60Hz)
- When the uniti is turned on the power indicator light will illuminate to tell you that the heater is functioning.
- Push the HEAT/OFF button to choose the desirde heat setting.
 800 Watt setting provides minimum level heating and
 1200 Watt setting probides maximum level heating.
- Push the OSC button to make the unit oscillate. Push it again to turn off the oscillation. The
 oscillation will only functionn when the unit is on.
- Push the TIMER button to make the unit turn off after 1 hr, 2 hrs or 4 hurs of running. The timer will only function when the unit is on.

Remote Control Instructions:

- Two AAA batteries are guired to put in before it can function.
- Remote Control Hand Unit key has the same function as manual control pad except the HEAT/ OFF button has been seperated by HEAT and ON/OFF buttons.
- Push ON/OFF button first before operating.
- Then adjust the desired heat level and Oscillating and Timer options.

SAFETY FEATURES:

Automatic Tip-Over Safety Switch:

The Tip-over safety switch is located at bottom of the base. The tip-over safety switch allows the unit to operate only when the heater is placed on a level surface. If the heater is tipped or tilted while in operation, it will automatically shut off.

Overheat Alert Light:

This heater includes a visual RED alarm light to warn that parts of the heater are getting excessive hot. If the alarm light flashes, immediately turn the heater off and inspect for any objects on or adjacent to the heater that may cause high temperatures. DO NOT OPERATE THE HEATER WITH THE ALARM LIGHT IN ON.
