Assay Summary

Step 1. Add 50 μ l of Standard or Sample per well. Incubate 1 hour.

Step 2. Wash, then add 50 μ l of Biotinylated Antibody per well. Incubate 30 minutes.

Step 3. Wash, then add 50 μ l of SP Conjugate per well. Incubate 30 minutes.

Step 4. Wash, then add 50 μ l of Chromogen Substrate per well. Incubate 10 minutes.

Step 5. Add 50 μ l of Stop Solution per well. Read at 450 nm immediately.

Introduction

Albumin, a serum hepatic protein, is the most abundant protein in serum. It contributes to the maintenance of oncotic pressure as well as the transport of hydrophobic molecules (1).

Principle of the Assay

The AssayMax Rat Albumin ELISA (Enzyme-Linked Immunosorbent Assay) kit is designed for detection of rat albumin in **urine and cell culture samples**. This assay employs a quantitative **sandwich enzyme immunoassay** technique that measures rat albumin in less than 3 hours. A polyclonal antibody specific for rat albumin has been pre-coated onto a 96-well microplate with removable strips. Albumin in standards and samples is sandwiched by the immobilized polyclonal antibody and biotinylated polyclonal antibody specific for rat albumin, which is recognized by a streptavidin-peroxidase conjugate. All unbound material is washed away and a peroxidase enzyme substrate is added. The color development is stopped and the intensity of the color is measured.

Caution and Warning

- This product is for Research Use Only and is Not For Use In Diagnostic Procedures.
- Prepare all reagents (working diluent buffer, wash buffer, standard, biotinylated antibody, and SP conjugate) as instructed, prior to running the assay.
- Prepare all samples prior to running the assay. The dilution factors for the samples are suggested in this insert. However, the user should determine the optimal dilution factor.
- Spin down the SP conjugate vial and the biotinylated antibody vial before opening and using contents.
- The Stop Solution is an acidic solution.
- The kit should not be used beyond the expiration date.

Reagents

- Rat Albumin Microplate: A 96-well polystyrene microplate (12 strips of 8 wells) coated with a polyclonal antibody against rat albumin.
- Sealing Tapes: Each kit contains 3 precut, pressure sensitive sealing tapes that can be cut to fit the format of the individual assay.
- Rat Albumin Standard: Rat albumin in a buffered protein base (300 ng, lyophilized).
- Biotinylated Rat Albumin Antibody (100x): A 100-fold concentrated biotinylated polyclonal antibody against rat albumin (60 μl).
- MIX Diluent Concentrate (10x): A 10-fold concentrated buffered protein base (30 ml).
- Wash Buffer Concentrate (20x): A 20-fold concentrated buffered surfactant (30 ml, 2 bottles).
- Streptavidin-Peroxidase Conjugate (SP Conjugate): A 100-fold concentrate (80 μl).
- Chromogen Substrate: A ready-to-use stabilized peroxidase chromogen substrate tetramethylbenzidine (8 ml).
- Stop Solution: A 0.5 N hydrochloric acid to stop the chromogen substrate reaction (12 ml).

Storage Condition

- Upon arrival, immediately store components of the kit at recommended temperatures up to the expiration date.
- Store SP Conjugate and Biotinylated Antibody at -20°C.
- Store Microplate, Diluent Concentrate (10x), Wash Buffer, Stop Solution, and Chromogen Substrate at 2-8°C.
- Unused microplate wells may be returned to the foil pouch with the desiccant packs and resealed. May be stored for up to 30 days in a vacuum desiccator.
- Diluent (1x) may be stored for up to 30 days at 2-8°C.
- Store Standard at 2-8°C before reconstituting with Diluent and at -20°C after reconstituting with Diluent.

Other Supplies Required

- Microplate reader capable of measuring absorbance at 450 nm.
- Pipettes (1-20 μl, 20-200 μl, 200-1000 μl, and multiple channel).
- Deionized or distilled reagent grade water.

Sample Collection, Preparation, and Storage

- Cell Culture Supernatants: Centrifuge cell culture media at 3000 x g for 10 minutes to remove debris. Collect supernatants and assay. Store samples at -20°C or below. Avoid repeated freeze-thaw cycles.
- Urine: Collect urine using sample pot. Centrifuge samples at 800 x g for 10 minutes. Dilute samples 1:800 into MIX Diluent and assay. The undiluted samples can be stored at -20°C or below for up to 3 months. Avoid repeated freeze-thaw cycles.

Reagent Preparation

- Freshly dilute all reagents and bring all reagents to room temperature before use.
- MIX Diluent Concentrate (10x): If crystals have formed in the
 concentrate, mix gently until the crystals have completely dissolved.
 Dilute the MIX Diluent Concentrate 1:10 with reagent grade water. Store
 for up to 30 days at 2-8°C.
- Standard Curve: Reconstitute the 300 ng of Rat Albumin Standard with 1.5 ml of MIX Diluent to generate a 200 ng/ml standard stock solution. Allow the standard to sit for 10 minutes with gentle agitation prior to making dilutions. Prepare duplicate or triplicate standard points by serially diluting the standard stock solution (200 ng/ml) 1:4 with MIX Diluent to produce 50, 12.5, 3.125, and 0.781 ng/ml solutions. MIX Diluent serves as the zero standard (0 ng/ml). Any remaining solution should be frozen at -20°C and used within 30 days.

- Biotinylated Rat Albumin Antibody (100x): Spin down the antibody briefly and dilute the desired amount of the antibody 1:100 with MIX Diluent. Any remaining solution should be frozen at -20°C.
- Wash Buffer Concentrate (20x): If crystals have formed in the concentrate, mix gently until the crystals have completely dissolved.
 Dilute the Wash Buffer Concentrate 1:20 with reagent grade water.
- SP Conjugate (100x): Spin down the SP Conjugate briefly and dilute the desired amount of the conjugate 1:100 with MIX Diluent. Any remaining solution should be frozen at -20°C.

Assay Procedure

- Prepare all reagents, standard solutions, and samples as instructed. Bring all reagents to room temperature before use. The assay is performed at room temperature (20-25°C).
- Remove excess microplate strips from the plate frame and return them
 immediately to the foil pouch with desiccants inside. Reseal the pouch
 securely to minimize exposure to water vapor and store in a vacuum
 desiccator.
- Add 50 µl of Rat Albumin Standard or sample per well. Cover wells with a sealing tape and incubate for 1 hour. Start the timer after the last addition.
- Wash five times with 200 µl of Wash Buffer manually. Invert the plate
 each time and decant the contents; hit 4-5 times on absorbent material
 to completely remove the liquid. If using a machine, wash six times with
 300 µl of Wash Buffer and then invert the plate, decanting the contents;
 hit 4-5 times on absorbent material to completely remove the liquid.
- Add 50 µl of Biotinylated Rat Albumin Antibody to each well and incubate for 30 minutes.
- Wash the microplate as described above.
- Add 50 µl of Streptavidin-Peroxidase Conjugate to each well and incubate for 30 minutes. Turn on the microplate reader and set up the program in advance.
- Wash the microplate as described above.

- Add 50 µl of Chromogen Substrate per well and incubate for 10 minutes or till the optimal blue color density develops. Gently tap plate to ensure thorough mixing and break the bubbles in the well with pipette tip.
- $\bullet \quad$ Add 50 μl of Stop Solution to each well. The color will change from blue to yellow.
- Read the absorbance on a microplate reader at a wavelength of 450 nm immediately. If wavelength correction is available, subtract readings at 570 nm from those at 450 nm to correct optical imperfections.
 Otherwise, read the plate at 450 nm only. Please note that some unstable black particles may be generated at high concentration points after stopping the reaction for about 10 minutes, which will reduce the readings.

Data Analysis

- Calculate the mean value of the duplicate or triplicate readings for each standard and sample.
- To generate a standard curve, plot the graph using the standard concentrations on the x-axis and the corresponding mean 450 nm absorbance (OD) on the y-axis. The best-fit line can be determined by regression analysis using log-log or four-parameter logistic curve-fit.
- Determine the unknown sample concentration from the Standard Curve and multiply the value by the dilution factor.



Performance Characteristics

- The minimum detectable dose of rat albumin as calculated by 2SD from the mean of a zero standard was established to be 0.4 ng/ml.
- Intra-assay precision was determined by testing replicates of three plasma samples in one assay.
- Inter-assay precision was determined by testing three plasma samples in twenty assays.

Troubleshooting

Issue	Causes	Course of Action
Low Precision	Use of expired components	Check the expiration date listed before use. Do not interchange components from different lots.
	Improper wash step	Check that the correct wash buffer is being used. Check that all wells are dry after aspiration. Check that the microplate washer is dispensing properly. If washing by pipette, check for proper pipetting technique.
/ Pre	Splashing of reagents while loading wells	Pipette properly in a controlled and careful manner.
Low	Inconsistent volumes loaded into wells	Pipette properly in a controlled and careful manner. Check pipette calibration. Check pipette for proper performance.
	Insufficient mixing of reagent dilutions	Thoroughly agitate the lyophilized components after reconstitution. Thoroughly mix dilutions.

	Improperly sealed microplate	 Check the microplate pouch for proper sealing. Check that the microplate pouch has no punctures. Check that three desiccants are inside the microplate pouch prior to sealing.
