

WARNING: This is an unvented gas-fired heater. It uses air (oxygen) from the room in which it is installed. Provisions for adequate combustion and ventilation air must be provided. Refer to Air for Combustion and Ventilation section on page 4.

This appliance may be installed in an aftermarket\*, permanently located, manufactured (mobile) home, where not prohibited by local codes.

This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases.

# SAFETY INFORMATION

# **A** WARNINGS

MARNING: This product contains and/or generates chemicals known to the State of California to cause cancer or birth defects, or other reproductive harm.

IMPORTANT: Read this owner's manual carefully and completely before trying to assemble, operate, or service this heater. Improper use of this heater can cause serious injury or death from burns, fire, explosion, electrical shock, and carbon monoxide poisoning.

A DANGER: Carbon monoxide poisoning may lead to death!

**Carbon Monoxide Poisoning:** Early signs of carbon monoxide poisoning resemble the flu, with headaches, dizziness, or nausea. If you have these signs, the heater may not be working properly. **Get fresh air at once!** Have heater serviced. Some people are more affected by carbon monoxide than others. These include pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

**Natural and Propane/LP Gas:** Natural and propane/LP gases are odorless. An odor-making agent is added to the gas. The odor helps you detect a gas leak. However, the odor added to the gas can fade. Gas may be present even though no odor exists.

Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this heater.

WARNING: Any change to this heater or its controls can be dangerous.

WARNING: Do not allow fans to blow directly into the fireplace. Avoid any drafts that alter burner flame patterns. Ceiling fans can create drafts that alter burner flame patterns. Altered burner patterns can cause sooting.

WARNING: Do not use a blower insert, heat exchanger insert, or other accessory not approved for use with this fireplace.

Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies.

Do not place clothing or other flammable material on or near the appliance. Never place any objects on the heater.

Heater base assembly becomes very hot when running heater. Keep children and adults away from hot surface to avoid burns or clothing ignition. Heater will remain hot for a time after shutdown. Allow surface to cool before touching.

Carefully supervise young children when they are in the room with heater. When using the hand-held remote accessory, keep selector switch in the OFF position to prevent children from turning on burners with remote.

Keep the appliance area clear and free from combustible materials, gasoline, and other flammable vapors and liquids.

- 1. This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases.
- 2. Do not place propane/LP supply tank(s) inside any structure. Locate propane/LP supply tank(s) outdoors (propane/LP units only).
- 3. To prevent performance problems, the use of a propane/LP fuel tank of less than 100 lb. capacity is not recommended (propane/LP units only).
- 4. If you smell gas
  - · shut off gas supply
  - do not try to light any appliance
  - do not touch any electrical switch; do not use any phone in your building
  - immediately call your gas supplier from a neighbor's phone.
     Follow the gas supplier's instructions
  - if you cannot reach your gas supplier, call the fire department
- 5. This heater shall not be installed in a bedroom or bathroom unless installed as a vented appliance (see *Installing Damper Clamp Accessory for Vented Operation*, page 10).
- 6. Before installing in a solid fuel burning fireplace, the chimney flue and firebox must be cleaned of soot, creosote, ashes, and loose paint by a qualified chimney cleaner. Creosote will ignite if highly heated. Inspect chimney flue for damage. If damaged, repair flue before operating heater.
- 7. If fireplace has glass doors, never operate this heater with glass doors closed. If you operate heater with doors closed, heat buildup inside fireplace will cause glass to burst. Make sure there are no obstructions across openings of fireplace.
- 8. This log heater is designed to be smokeless. If logs ever appear to smoke, turn off heater and call a qualified service person. *Note*: During initial operation, slight smoking may occur due to log curing and heater burning manufacturing residues.
- 9. To prevent the creation of soot, follow the instructions in *Cleaning and Maintenance*, page 19.
- 10. Before using furniture polish, wax, carpet cleaner, or similar products, turn heater off. If heated, the vapors from these products may create a white powder residue within burner box or on adjacent walls or furniture.
- 11. This heater needs fresh, outside air ventilation to run properly. This heater has an Oxygen Depletion Sensing (ODS) safety shutoff system. The ODS shuts down the heater if not enough fresh air is available. See *Air for Combustion and Ventilation*, pages 4 through 6. If heater keeps shutting off, see *Trouble-shooting*, pages 20 through 223.
- 12. Do not run heater
  - · where flammable liquids or vapors are used or stored
  - · under dusty conditions
- 13. Do not use this heater to cook food or burn paper or other objects.

- 14. Do not use heater if any part has been exposed to or under water. Immediately call a qualified service technician to inspect the room heater and to replace any part of the control system and any gas control which has been under water.
- 15. Do not operate heater if any log is broken. Do not operate heater if a log is chipped (dime-sized or larger).
- 16. Turn heater off and let cool before servicing, installing, or repairing. Make sure the remote selector switch is in the OFF position. Only a qualified service person should install, service, or repair heater.
- 17. Make sure the remote selector switch is in the OFF position when you are away from home for long periods of time.
- 18. This heater must not be connected to any external electrical source.
- 19. Operating heater above elevations of 4,500 feet may cause pilot outage.
- 20. Provide adequate clearances around air openings.




Figure 1 - Vent-Free Gas Log Heater (Logs May Vary By Model)

*Note:* Where listed vented decorative logs are required, thermostat operation is not permitted.

# **UNPACKING**

CAUTION: Do not remove the data plates attached to the heater base assembly. The data plates contain important warranty and safety information.

- Remove logs and heater base assembly from carton. *Note:* Do not pick up heater base assembly by burners. This could damage heater. Always handle base assembly by grate.
- Remove all protective packaging applied to logs and heater for shipment.
- 3. Check all items for any shipping damage. If damaged, promptly inform dealer where you bought heater.

# PRODUCT FEATURES

### **OPERATION**

This heater is clean burning. It requires no outside venting. There is no heat loss out a vent or up a chimney. Heat is generated by realistic dancing, yellow flames. This heater is designed for vent-free operation with flue damper closed. It has been tested and approved to ANSI Z21.11.2 standard for unvented heaters. This heater may also be operated as a vented decorative (ANSI Z21.60) product by opening flue damper (non-thermostat models only).

### **SAFETY PILOT**

This heater has a pilot with an Oxygen Depletion Sensing (ODS) safety shutoff system. The ODS/pilot is a required feature for vent-free room heaters. The ODS/pilot shuts off the heater if there is not enough fresh air.

### PIEZO IGNITION SYSTEM

This heater has a piezo ignitor. This system requires no matches, batteries, or other sources to light heater.

# REMOTE CONTROL ACCESSORIES

There are two optional remote controls that can be purchased separately for this log heater:

- hand-held ON/OFF remote
- · hand-held thermostat remote

See Accessories, page 28.

The hand-held thermostat may not be used where vented decorative listing is required.

# AIR FOR COMBUSTION AND VENTILATION

WARNING: This heater shall not be installed in a confined space or unusually tight construction unless provisions are provided for adequate combustion and ventilation air. Read the following instructions to insure proper fresh air for this and other fuel-burning appliances in your home.

Today's homes are built more energy efficient than ever. New materials, increased insulation, and new construction methods help reduce heat loss in homes. Home owners weather strip and caulk around windows and doors to keep the cold air out and the warm air in. During heating months, home owners want their homes as airtight as possible.

While it is good to make your home energy efficient, your home needs to breathe. Fresh air must enter your home. All fuel-burning appliances need fresh air for proper combustion and ventilation.

Exhaust fans, fireplaces, clothes dryers, and fuel burning appliances draw air from the house to operate. You must provide adequate fresh air for these appliances. This will insure proper venting of vented fuel-burning appliances.

#### PROVIDING ADEQUATE VENTILATION

The following are excerpts from *National Fuel Gas Code*, *ANSI Z223.1/NFPA 54*, *Section 5.3*, *Air for Combustion and Ventilation*.

All spaces in homes fall into one of the three following ventilation classifications:

- 1. Unusually Tight Construction
- Unconfined Space
- 3. Confined Space

The information on pages 4 through 6 will help you classify your space and provide adequate ventilation.

# AIR FOR COMBUSTION AND VENTILATION

#### Continued

### **Unusually Tight Construction**

The air that leaks around doors and windows may provide enough fresh air for combustion and ventilation. However, in buildings of unusually tight construction, you must provide additional fresh air.

Unusually tight construction is defined as construction where:

- a. walls and ceilings exposed to the outside atmosphere have a continuous water vapor retarder with a rating of one perm (6 x 10<sup>-11</sup> kg per pa-sec-m<sup>2</sup>) or less with openings gasketed or sealed <u>and</u>
- b. weather stripping has been added on openable windows and doors *and*
- c. caulking or sealants are applied to areas such as joints around window and door frames, between sole plates and floors, between wall-ceiling joints, between wall panels, at penetrations for plumbing, electrical, and gas lines, and at other openings.

If your home meets all of the three criteria above, you must provide additional fresh air. See *Ventilation Air From Outdoors*, page 6.

If your home does not meet all of the three criteria above, proceed to *Determining Fresh-Air Flow For Heater Location*..

### **Confined Space and Unconfined Space**

The National Fuel Gas Code, ANSI Z223.1/NFPA 54 defines a confined space as a space whose volume is less than 50 cubic feet per 1,000 Btu per hour (4.8 m³ per kw) of the aggregate input rating of all appliances installed in that space and an unconfined space as a space whose volume is not less than 50 cubic feet per 1,000 Btu per hour (4.8 m³ per kw) of the aggregate input rating of all appliances installed in that space. Rooms communicating directly with the space in which the appliances are installed\*, through openings not furnished with doors, are considered a part of the unconfined space.

\* Adjoining rooms are communicating only if there are doorless passageways or ventilation grills between them.

# AIR FOR COMBUSTION AND VENTILATION

#### Continued

The space in the example on page 5 is a confined space because the actual Btu/Hr used is more than the maximum Btu/Hr the space can support. You must provide additional fresh air. Your options are as follows:

- A. Rework worksheet, adding the space of an adjoining room. If the extra space provides an unconfined space, remove door to adjoining room or add ventilation grills between rooms. See *Ventilation Air From Inside Building*.
- B. Vent room directly to the outdoors. See Ventilation Air From Outdoors.
- C. Install a lower Btu/Hr heater, if lower Btu/Hr size makes room unconfined.

If the actual Btu/Hr used is less than the maximum Btu/Hr the space can support, the space is an unconfined space. You will need no additional fresh air ventilation.

A WARNING: If the area in which the heater may be operated is smaller than that defined as an unconfined space or if the building is of unusually tight construction, provide adequate combustion and ventilation air by one of the methods described in the National Fuel Gas Code, ANSI Z223.1/NFPA 54 Section 5.3 or applicable local codes.

#### **VENTILATION AIR**

### **Ventilation Air From Inside Building**




Figure 2 - Ventilation Air from Inside Building

This fresh air would come from an adjoining unconfined space. When ventilating to an adjoining unconfined space, you must provide two permanent openings: one within 12" of the ceiling and one within 12" of the floor on the wall connecting the two spaces (see options 1 and 2, Figure 2). You can also remove door into adjoining room (see option 3, Figure 2). Follow the *National Fuel Gas Code, ANSI Z223.1/NFPA 54, Section 5.3, Air for Combustion and Ventilation* for required size of ventilation grills or ducts.

#### **Ventilation Air From Outdoors**

Provide extra fresh air by using ventilation grills or ducts. You must provide two permanent openings: one within 12" of the ceiling and one within 12" of the floor. Connect these items directly to the outdoors or spaces open to the outdoors. These spaces include attics and crawl spaces. Follow the *National Fuel Gas Code, ANSI Z223.1/NFPA 54, Section 5.3, Air for Combustion and Ventilation* for required size of ventilation grills or ducts.

*IMPORTANT:* Do not provide openings for inlet or outlet air into attic if attic has a thermostat-controlled power vent. Heated air entering the attic will activate the power vent.




Figure 3 - Ventilation Air from Outdoors

NOTICE: This heater is intended for use as supplemental heat. Use this heater along with your primary heating system. Do not install this heater as your primary heat source. If you have a central heating system, you may run system's circulating blower while using heater. This will help circulate the heat throughout the house. In the event of a power outage, you can use this heater as your primary heat source.

NOTICE: State or local codes may only allow operation of this appliance in a vented configuration. Check your state or local codes.

MARNING: A qualified service person must install heater. Follow all local codes.

A WARNING: Make sure the selector switch is in the OFF position before installing heater.

▲ WARNING: Before installing in a solid fuel burning fireplace, the chimney flue and firebox must be cleaned of soot, creosote, ashes, and loose paint by a qualified chimney cleaner. Creosote will ignite if highly heated. A dirty chimney flue may create and distribute soot within the house. Inspect chimney flue for damage. If damaged, repair flue before operating heater.

WARNING: Seal any fresh air vents or ash cleanout doors located on floor or wall of fireplace. If not, drafting may cause pilot outage or sooting. Use a heat-resistant sealant. Do not seal chimney flue damper.

**A** WARNING: Never install the heater

- in a bedroom or bathroom unless installed as a vented appliance, see page 10.
- in a recreational vehicle
- where curtains, furniture, clothing, or other flammable objects are less than 42 inches from the front, top, or sides of the heater
- · in high traffic areas
- · in windy or drafty areas

CAUTION: This heater creates warm air currents. These currents move heat to wall surfaces next to heater. Installing heater next to vinyl or cloth wall coverings or operating heater where impurities (such as, but not limited to, tobacco smoke, aromatic candles, cleaning fluids, oil or kerosene lamps, etc.) in the air exist, may discolor walls or cause odors.

*IMPORTANT:* Vent-free heaters add moisture to the air. Although this is beneficial, installing heater in rooms without enough ventilation air may cause mildew to form from too much moisture. See *Air for Combustion and Ventilation*, pages 4 through 6.

#### **CHECK GAS TYPE**

Use the correct gas type (natural or propane/LP) for your unit. If your gas supply is not correct, do not install heater. Call dealer where you bought heater for proper type heater.

# INSTALLATION AND CLEARANCES (Vent-Free Operation Only)

WARNING: Maintain the minimum clearances. If you can, provide greater clearances from floor, ceiling, and adjoining wall.


# Minimum Clearances for Side Combustible Material, Side Wall, and Ceiling

A. Clearances from the side of the fireplace cabinet to any combustible material and wall should follow diagram in Figure 4.

*Example:* The face of a mantel, bookshelf, etc. is made of combustible material and protrudes 3 ½" from the wall. This combustible material must be 4" from the side of the fireplace opening (see Figure 4).

*Note:* When installing your gas logs into a manufactured firebox, follow firebox manufacturer's instructions for minimum clearances to combustible materials.

B. Clearances from the top of the fireplace opening to the ceiling should not be less than 42 inches.



\*Minimum 16 inches from Side Wall

NOTICE: Manual control heaters may be used as a vented product. If so, you must always run heater with chimney flue damper open. If running heater with damper open, noncombustible material above fireplace opening is not needed. Go to *Installing Damper Clamp Accessory for Vented Operation*, page 10.

### **Minimum Noncombustible Material Clearances**

#### If Not Using Mantel

*Note:* If using a mantel, proceed to *If Using Mantel*. If not using a mantel, follow the information below.




Figure 5 - Heat Resistant Material (Slate, Marble, Tile, etc.) Above Fireplace

You must have noncombustible material(s) above the fireplace opening. Noncombustible materials (such as slate, marble, tile, etc.) must be at least 1/2 inch thick. With sheet metal, you must have noncombustible material behind it. Noncombustible material must extend at least 8" up (for all models). If noncombustible material is less than 12", you must install the fireplace hood accessory (24" and 30" models only). See Figure 5 for minimum clearances.

*IMPORTANT:* If you cannot meet these minimum clearances, you must operate heater with chimney flue damper open. Go to *Installing Damper Clamp Accessory for Vented Operation*, page 10.

#### If Using Mantel




Figure 6 - Minimum Mantel Clearances Without Using Hood




Figure 7 - Minimum Mantel Clearances When Using Hood

You must have noncombustible material(s) above the fireplace opening. Noncombustible materials (such as slate, marble, tile, etc.) must be at least 1/2 inch thick. With sheet metal, you must have noncombustible material behind it. Noncombustible material must extend at least 8 inches up (for all models). If noncombustible material is less than 12", you must install the fireplace hood accessory (24" and 30" models only). Even if noncombustible material is more than 12", you may need the hood accessory to deflect heat away from your mantel shelf. See Figure 5 and Figures 6 and 7 on page 9 for minimum clearances.

*IMPORTANT:* If you cannot meet these minimum clearances, you must operate heater with chimney flue damper open. Go to *Installing Damper Clamp Accessory for Vented Operation*, page 10.

Noncombustible Material Distance (A)	Requirements for Safe Installation
12" or more	Noncombustible material okay.
Between 8" and 12"	Install fireplace hood accessory (GA6050, GA6052, or GA6053, see <i>Accessories</i> , page 28).
Less than 8"	Noncombustible material must be extended to at least 8". See Between 8" and 12", above. If you cannot extend material, you must operate heater with flue damper open.

### **MANTEL CLEARANCES**

In addition to meeting noncombustible material clearances, you must also meet required clearances between fireplace opening and mantel shelf. If you do not meet the clearances listed below, you will need a hood.

# **Determining Minimum Mantel Clearances**

If you meet minimum clearance between mantel shelf and top of fireplace opening, a hood is not required (see Figure 6).

# **Determining Minimum Mantel Clearances When Using a Hood**

If minimum clearances in Figure 6 are not met, you must have a hood. When using a hood there are still certain minimum mantel clearances required. Follow minimum clearances shown in Figure 7 when using hood.

NOTICE: Surface temperatures of adjacent walls and mantels become hot during operation. Walls and mantels above the firebox may become hot to the touch. If installed properly, these temperatures meet the requirements of the national product standard. Follow all minimum clearances shown in this manual.

NOTICE: If your installation does not meet the minimum clearances shown, you must do one of the following:

- · operate the logs only with the flue damper open
- · raise the mantel to an acceptable height
- · remove the mantel.

### FLOOR CLEARANCES




Figure 8 - Minimum Fireplace Clearances If Installed at Floor Level

- A. If installing appliance on the floor level, you must maintain the minimum distance of 14" to combustibles (see Figure 8).




Figure 9 - Minimum Fireplace Clearances Above Combustible Flooring

- B. If combustible materials are less than 14" to the fireplace, you must install appliance at least 5" above the combustible flooring (see Figure 9).

# INSTALLING DAMPER CLAMP ACCESSORY FOR VENTED OPERATION

*Note:* When used as a vented heater, appliance must be installed only in a solid-fuel burning fireplace with a working flue and constructed of noncombustible material.

If your heater is a manually-controlled model, you may use this heater as a vented product. There are three reasons for operating your heater in the vented mode.

- The fireplace does not meet the clearance to combustibles requirements for vent-free operation.
- 2. State or local codes do not permit vent-free operation.
- 3. You prefer vented operation.




Figure 10 - Attaching Damper Clamp

If reasons number 1 or 2 above apply to you, you must permanently open chimney flue damper. You must install the damper clamp accessory (to order, see *Accessories*, page 28). This will insure vented operation (see Figure 10). The damper clamp will keep damper open. Installation instructions are included with clamp accessory.

See chart below for minimum permanent flue opening you must provide. Attach damper clamp so the minimum permanent flue opening will be maintained at all times.

#### INSTALLING HEATER BASE ASSEMBLY

A CAUTION: Do not remove the data plates attached to the heater base assembly. The data plates contain important warranty and safety information.

WARNING: You must secure this heater to fireplace floor. If not, heater will move when you adjust controls. Moving heater may cause a gas leak.

WARNING: If installing in a sunken fireplace, special care is needed. You must raise the fireplace floor to allow access to heater control panel. This will insure adequate air flow and guard against sooting and controls being damaged. Raise fireplace floor with noncombustible material. Make sure material is secure.

A CAUTION: Do not pick up heater base assembly by the burner. This could damage heater. Only handle base assembly by grates.

*IMPORTANT:* Make sure the heater burners are level. If heater is not level, heater will not work properly.

#### Installation Items Needed

- hardware package (provided with heater)
- approved flexible gas hose (not provided) (if allowed by local codes)
- · sealant resistant to propane/LP gas, not provided
- electric drill with 3/16" masonry drill bit

*Note:* Install optional remote receiver and hand-held remote kit (see *Accessories*, page 28) before installing gas log heater. See installation instructions included with the kit.




Figure 11 - Attaching Flexible Gas Hose to Heater

- 1. Apply pipe joint sealant lightly to male threads of the fitting to be threaded into gas regulator. Connect approved flexible gas hose to gas regulator of heater (see Figure 11).
- 2. Locate masonry screws in hardware package.
- 3. Position heater base assembly in fireplace.
- 4. Place logs in their proper positions on heater base.
- 5. Center heater base and logs front-to-back and side-to-side in fireplace.
- 6. Carefully remove logs without moving heater base.




Figure 12 - Attaching Base Assembly to Fireplace Floor

- Mark screw locations through holes in mounting flanges (see Figure 12). If installing in a brick-bottom fireplace, mark screw locations in mortar joint of bricks.
- 8. Remove heater base from fireplace.
- 9. Drill holes at marked locations using 3/16" masonry drill bit.
- 10. Attach base assembly to fireplace floor using two masonry screws (in hardware package) (see Figure 12).
- 11. Connect to gas supply. See Connecting To Gas Supply.

### **CONNECTING TO GAS SUPPLY**

WARNING: This appliance requires a 1/2" NPT (National Pipe Thread) inlet connection to the pressure regulator.

MARNING: A qualified service person must connect heater to gas supply. Follow all local codes.

A CAUTION: Never connect propane/LP heater directly to the propane/LP supply. This heater requires an external regulator (not supplied). Install the external regulator between the heater and propane/LP supply.

WARNING: Never connect natural gas heater to private (non-utility) gas wells. This gas is commonly known as wellhead gas.

#### Installation Items Needed

Before installing heater, make sure you have the items listed below.

- piping (check local codes)
- sealant (resistant to propane/LP gas)
- equipment shutoff valve \*
- test gauge connection \*
- sediment trap
- tee joint
- · pipe wrench
- \* A CSA design-certified equipment shutoff valve with 1/8" NPT tap is an acceptable alternative to test gauge connection. Purchase the optional CSA design-certified equipment shutoff valve from your dealer. See *Accessories*, page 28.




Figure 13 - External Regulator With Vent Pointing Down

For propane/LP units, the installer must supply an external regulator. The external regulator will reduce incoming gas pressure. You must reduce incoming gas pressure to between 11 and 14 inches of water. If you do not reduce incoming gas pressure, heater regulator damage could occur. Install external regulator with the vent pointing down as shown in Figure 13, page 12. Pointing the vent down protects it from freezing rain or sleet.

A CAUTION: Use only new, black iron or steel pipe. Internally-tinned copper tubing may be used in certain areas. Check your local codes. Use pipe of 1/2" diameter or greater to allow proper gas volume to heater. If pipe is too small, undue loss of volume will occur.



### Continued




Figure 14 - Gas Connection

Installation must include an equipment shutoff valve, union, and plugged 1/8" NPT tap. Locate NPT tap within reach for test gauge hook up. NPT tap must be upstream from heater (see Figure 14).

*IMPORTANT:* Install equipment shutoff valve in an accessible location. The equipment shutoff valve is for turning on or shutting off the gas to the appliance.

Check your building codes for any special requierments for locating equipment shutoff valve to fireplaces.

Apply pipe joint sealant lightly to male NPT threads. This will prevent excess sealant from going into pipe. Excess sealant in pipe could result in clogged heater valves.

WARNING: Use pipe joint sealant that is resistant to liquid petroleum (LP) gas.

We recommend that you install a sediment trap in supply line as shown in Figure 14. Locate sediment trap where it is within reach for cleaning. Install in piping system between fuel supply and heater. Locate sediment trap where trapped matter is not likely to freeze. A sediment trap traps moisture and contaminants. This keeps them from going into heater controls. If sediment trap is not installed or is installed wrong, heater may not run properly.

A CAUTION: Avoid damage to regulator. Hold gas regulator with wrench when connecting it to gas piping and/or fittings.

- \*\* Minimum inlet pressure for purpose of input adjustment.

#### **CHECKING GAS CONNECTIONS**

WARNING: Test all gas piping and connections, internal and external to unit, for leaks after installing or servicing. Correct all leaks at once.

WARNING: Never use an open flame to check for a leak. Apply a noncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.

A CAUTION: Make sure external regulator has been installed between propane/LP supply and heater. See guidelines under *Connecting to Gas Supply*, page 11.

### **Pressure Testing gas Supply Piping system**

#### Test Pressures In Excess Of 1/2 PSIG (3.5 kPa)

- Disconnect appliance with its appliance main gas valve (control valve) and equipment shutoff valve from gas supply piping system. Pressures in excess of 1/2 psig will damage heater regulator.
- 2. Cap off open end of gas pipe where equipment shutoff valve was connected.
- Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas or opening main gas valve located on or near gas meter for natural gas, or using compressed air.
- 4. Check all joints of gas supply piping system. Apply noncorrosive leak detection fluid to gas joints. Bubbles forming show a leak.

### Continued

- 5. Correct all leaks at once.
- 6. Reconnect heater and equipment shutoff valve to gas supply. Check reconnected fittings for leaks.

#### Test Pressures Equal To or Less Than 1/2 PSIG (3.5 kPa)




Figure 15 - Equipment Shutoff Valve

- 1. Close equipment shutoff valve (see Figure 15).
- Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas or opening main gas valve located on or near gas meter for natural gas, or using compressed air.




Figure 16 - Checking Gas Joints




Figure 17 - Checking Gas Joints

- 3. Check all joints from propane/LP supply tank to equipment shutoff valve for propane/LP gas (see Figure 16) or from gas meter to equipment shutoff valve for natural gas (see Figure 17). Apply noncorrosive leak detection fluid to gas joints. Bubbles forming show a leak.
- 4. Correct all leaks at once.

## **Pressure Testing Heater Gas Connections**

- 1. Open equipment shutoff valve (see Figure 15).
- Open propane/LP supply tank valve or main gas valve located on or near gas meter for natural gas.
- 3. Make sure control knob of heater is in the OFF position.
- 4. Check all joints from propane/LP supply tank to equipment shutoff valve for propane/LP gas (see Figure 16) or from gas meter to equipment shutoff valve for natural gas (see Figure 17). Apply noncorrosive leak detection fluid to gas joints. Bubbles forming show a leak.
- 5. Correct all leaks at once.
- 6. Light heater (see *Operating Heater*, pages 16 through 18). Check all other internal joints for leaks.
- 7. Turn off heater (see *To Turn Off Gas to Appliance*, page 17).

### **INSTALLING REMOTE RECEIVER UNIT**

- 1. Disconnect switch wires from the control valve.
- 2. Remove phillips head screws and heat shield.




Figure 18 - Switch Plate and Wiring Harness (Switch Plate and Orientation May Vary Depending On Model)

- 3. Remove switch plate (see Figure 18). Discard after removing.
- 4. Install remote receiver unit onto gas log heater base using phillips head screws.
- 5. Connect wires as shown in Figure 20.




Figure 19 - Installing Remote Receiver




Figure 20 - Connecting Wires

# INSTALLING WIRELESS REMOTE CONTROL ACCESSORY

Two 9-volt alkaline batteries (not included) are required to operate this heater with the wireless hand-held remote control set. One battery must be installed in the receiver and one in the hand-held remote control unit. *Note*: Only use alkaline batteries.

### Installing 9-Volt Battery in Receiver

- 1. Locate back of receiver under front burner of heater.
- 2. Locate the battery clip mounted on the back of the receiver.
- 3. Slide a 9-volt battery through the clip.
- 4. Attach the terminal wires to the battery.




Figure 21 - Installing Receiver on the Back of the Base




Figure 22 - Installing Battery in Hand-Held Remote Control Unit




Figure 23 - Installing Battery in Hand-Held Remote Control Unit (GHRCTA Series)

# INSTALLING LOGS (CCL3018PR/PRA, CCL3018NR/NRA, CCL3924PR/PRA, CCL3924NR/NRA, CCL3930PR/PRA, AND CCL3930NR/NRA)

⚠ WARNING: Failure to position the parts in accordance with these diagrams or failure to use only parts specifically approved with this heater may result in property damage or personal injury.

CAUTION: After installation and periodically thereafter, check to ensure that no flame comes in contact with any log. With the heater set to HI, check to see if flames contact any log. If so, reposition logs according to the log installation instructions in this manual. Flames contacting logs will create soot.

Each log is marked with a number. These numbers will help you identify the log when installing. It is very important to install these logs exactly as instructed. Do not modify logs. Only use logs supplied with heater.




Figure 24 - Installing Front Log (#1) (CCL3930PR/NR Shown)

- 1. Place the front log (#1) on the grate fingers. Make sure the front log rests firmly between the grate fingers and the grate base (see Figure 24).




Figure 25 - Installing Middle Log (#2) (CCL3930PR/NR Shown)

- 2. Place the base of the middle log (#2) in the U-shaped slots of the grate base. The cutout on the right of the middle log should fit over the burner (see Figure 25). Make sure the front of the middle log is resting on the tabs of the grate base.




Figure 26 - Installing Rear Log (#3) (CCL3930PR/NR Shown)

- 3. Locate pegs on the bottom of back log (#3). Slide these pegs into the holes in the grate base behind the burner (see Figure 26).




Figure 27 - Installing Crossover Log (#4) (CCL3930PR/NR Shown)

- 4. Locate pegs on the bottom of crossover log (#4). Slide these pegs into the holes located in middle log (#2) and back log (#3). See Figure 27 for placement.




Figure 28-Installing Crossover Log (#5) (CCL3930PR/NR Shown)

- 5. Locate pegs on the bottom of crossover log (#5). Slide these pegs into the holes located in crossover log (#4) and front log (#1). See Figure 28.




Figure 29 - Installing Crossover Log (#5) (CCL3018PR/PRA and CCL3018NR/NRA Only)

  - **For CCL3018PR/NR Only:** Locate holes on the bottom of crossover log (#5). Slide the holes over the left pegs on middle log (#2) and front log (#1). See Figure 29.




Figure 30 - Installing Crossover Log (#6) (CCL3930PR/NR Shown)

- 6. Locate pegs on the bottom of crossover log (#6). Slide these pegs into the holes located in middle log (#2) and front log (#1). See Figure 30.




Figure 31 - Installing Crossover Log (#7) to Models CCL3930PR/PRA and CCL3930NR/NRA Only

- 7. **For CCL3930PR/NR only**, locate holes on the bottom of crossover log (#7). Slide onto the pegs located in crossover log (#6) and middle log (#2). See Figure 31.
- 8. Add lava rock around base of heater if desired. Do not place any lava rock on logs or burner.

# **OPERATING HEATER**



# FOR YOUR SAFETY READ BEFORE LIGHTING



A WARNING: If you do not follow these instructions exactly, a fire or explosion may result causing property damage, personal injury or loss of life.

- A. This appliance has a pilot which must be lighted by hand. When lighting the pilot, follow these instructions exactly.
- B. BEFORE LIGHTING smell all around the appliance area for gas. Be sure to smell next to the floor because some gas is heavier than air and will settle on the floor.

#### WHAT TO DO IF YOU SMELL GAS

- Do not try to light any appliance.
- Do not touch any electric switch; do not use any phone in your building.
- Immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions.
- If you cannot reach your gas supplier, call the fire department.
- C. Use only your hand to push in or turn the gas control knob. Never use tools. If the knob will not push in or turn by hand, don't try to repair it, call a qualified service technician or gas supplier. Force or attempted repair may result in a fire or explosion.
- D. Do not use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.





# **A** WARNING:

- If fireplace has glass doors, never operate this heater with glass doors closed. If you operate heater with doors closed, heat buildup inside fireplace will cause glass to burst. Make sure there are no obstructions across opening of fireplace.
- You must operate this heater with a fireplace screen in place. Make sure fireplace screen is closed before running heater.

NOTICE: During initial operation of new heater, burning logs will give off a paper-burning smell. Orange flame will also be present. Open damper or window to vent smell. This will only last a few hours.

**Note:** Home owners generally prefer to operate their heater with the chimney damper closed. This will put all the heat into the room. However, there may be times you will desire the full flames of the HI heat setting but will find the heat output excessive. You can open the chimney damper (if you have one) fully or partially to release some of the heat.

WARNING: Damper handle will be hot if heater has been running.

- 1. STOP! Read the safety information in column 1.
- 2. Make sure equipment shutoff valve is fully open.
- 3. Set selector switch in the OFF position.

WARNING: Burners will come on automatically within one minute when the selector switch is in the ON position after the pilot is lit.




Figure 32 - Control Knob and Ignitor Button Location

- 4. Press in and turn control knob clockwise to the OFF position (see Figure 32).
- 5. Wait five (5) minutes to clear out any gas. Then smell for gas, including near the floor. If you smell gas, STOP! Follow "B" in the safety information in column 1. If you don't smell gas, go to the next step.
- 6. Press in and turn control knob counterclockwise to the PILOT position. Press in control knob for five (5) seconds (see Figure 32).

**Note:** You may be running this heater for the first time after hooking up to gas supply. If so, the control knob may need to be pressed in for 30 seconds or more. This will allow air to bleed from the gas system.

7. With control knob pressed in, press and release ignitor button. This will light pilot. The pilot is attached to the front burner. If needed, keep pressing ignitor button until pilot lights.

**Note:** If pilot does not stay lit, contact a qualified service person or gas supplier for repairs. Until repairs are made, light pilot with match. To light pilot with match, see *Manual Lighting Procedure*, page 17.

- 8. Keep control knob pressed in for 30 seconds after lighting pilot. After 30 seconds, release control knob.
  - If control knob does not pop out when released, contact a qualified service person or gas supplier for repairs.

Note: If pilot goes out, repeat steps 4 through 8.

- 9. Slightly push in and turn control knob counterclockwise to the ON position.
- 10. Wait one minute and switch selector switch to the ON position to light burners.
- 11. Set flame adjustment knob to any level between HI and LO.

A CAUTION: Do not try to adjust heating levels by using the equipment shutoff valve.

WARNING: Make sure the selector switch is in the OFF position when you are away from home for long periods of time. Heater will come on automatically with selector switch in the ON position.




Figure 33 - Pilot



(Optional CGHRCTA Only) The thermostat control setting on the remote control unit can be set to any comfort level between WARMER and COOLER. The burner will turn on and off automatically to maintain the comfort level you select. The ideal comfort setting will vary by household depending upon the amount of space to be heated, the output of the central heating system, etc.

NOTICE: You must light the pilot before using the hand-held remote control unit. See *Lighting Instructions* on pages 16 and 17.

1. After lighting, let pilot flame burn for about one minute. Turn control knob to ON position. Adjust flame adjustment knob anywhere between HI and LO. Slide the selector switch to the REMOTE position. *Note:* The burners may light if hand-held remote ON button was on when selector switch was last turned off. You can now turn the burners on and off with the hand-held remote control unit.

**IMPORTANT:** Do not leave the selector switch in the RE-MOTE position when the pilot is not lit. This will drain the battery.

**IMPORTANT:** Be sure to press the ON/OFF buttons on the hand-held remote control unit for up to 3 seconds to assure proper operation.

### **CGHRC Series Operation:**

2a. Press the ON/OFF button to turn the burners on and off. When turning burners off, the pilot will remain lit.

### **CGHRCTA Series Operation:**

- 2b. Press the AUTO/ON/OFF button on the hand-held remote control (see Figure 35). The lights to the left of the button will show AUTO, ON, or OFF.
  - In the ON mode, the burners will ignite. The heater is in manual mode when ON is lit.
  - In the AUTO mode, the thermostat in the hand-held remote unit controls the room temperature. To increase the room temperature, press the top arrow of the TEMP button. To lower the room temperature, press the bottom arrow of the TEMP button. At higher settings the heater will run longer.

IMPORTANT: This remote control has been specially engineered to take an air temperature sample every 5.5 minutes in the auto mode. It will not respond immediately to the temperature setting being turned up or down. IMPORTANT: The hand-held remote control unit must be near the heater. Do not keep the hand-held remote control unit too close to the heater. The thermostat on the hand-held remote control unit will heat up too quickly and turn the heater off.

3. To turn the burner off, press the AUTO/ON/OFF button until OFF lights. The pilot will remain lit.

**IMPORTANT:** To turn the pilot off, manually turn the control knob on the heater to the OFF position.




Figure 34 - Setting the Selector Switch, Control Knob, and Flame Adjustment Knob for Remote Operation




Figure 35 - Thermostat Hand-Held Remote Control Unit Selections (CGHRCTA Series Only)

# INSPECTING BURNERS

Check pilot flame pattern and burner flame patterns often.

#### PILOT FLAME PATTERN




Figure 36 - Correct Pilot Flame Pattern





Figure 37 - Incorrect Pilot Flame Pattern

Figure 36 shows a correct pilot flame pattern. Figure 37 shows an incorrect pilot flame pattern. The incorrect pilot flame is not properly heating the thermocouple. When the thermocouple cools, the heater will shut down. If pilot flame pattern is incorrect, as shown in Figure 37

- turn heater off (see *To Turn Off Gas to Appliance*, page 17)
- see Troubleshooting, pages 20 through 22

*Note:* The pilot flame on natural gas units will have a slight curve, but the flame should be blue and have no yellow or orange color.

### **MAIN BURNER**

Periodically inspect all burner flame holes with the heater running. All slotted burner flame holes should be open with yellow flame present. All round burner flame holes should be open with a small blue flame present. Some burner flame holes may become blocked by debris or rust, with no flame present. If so, turn off heater and let cool. Remove blockage, blocked burner flame holes will create soot.

# CLEANING AND MAINTENANCE

**MARNING:** Turn off heater and let cool before cleaning.

A CAUTION: You must keep control areas, burner, and circulating air passageways of heater clean. Inspect these areas of heater before each use. Have heater inspected yearly by a qualified service person. Heater may need more frequent cleaning due to excessive lint from carpeting, bedding material, pet hair, etc.

# CLEANING BURNER INJECTOR HOLDER AND PILOT AIR INLET HOLE

The primary air inlet holes allow the proper amount of air to mix with the gas. This provides a clean burning flame. Keep these holes clear of dust, dirt, lint, and pet hair. Clean these air inlet holes prior to each heating season. Blocked air holes will create soot. We recommend that you clean the unit every three months during operation and have heater inspected yearly by a qualified service person.

We also recommend that you keep the burner tube and pilot assembly clean and free of dust and dirt. To clean these parts we recommend using compressed air no greater than 30 PSI. Your local computer store, hardware store, or home center may carry compressed air in a can. You can use a vacuum cleaner in the blow position. If using compressed air in a can, please follow the directions on the can. If you don't follow directions on the can, you could damage the pilot assembly.

- 1. Shut off the unit, including the pilot. Allow the unit to cool for at least thirty minutes.




Figure 38 - Injector Holder On Outlet Burner Tube

- 2. Inspect burner, pilot, and primary air inlet holes on injector holder for dust and dirt (see Figure 38).
- 3. Blow air through the ports/slots and holes in the burner.
- 4. Check the injector holder located at the end of the burner tube again. Remove any large particles of dust, dirt, lint, or pet hair with a soft cloth or vacuum cleaner nozzle.
- 5. Blow air into the primary air holes on the injector holder.
- 6. In case any large clumps of dust have now been pushed into the burner repeat steps 3 and 4.




Figure 39 - Pilot Inlet Air Hole

Clean the pilot assembly also. A yellow tip on the pilot flame indicates dust and dirt in the pilot assembly. There is a small pilot air inlet hole about two inches from where the pilot flame comes out of the pilot assembly (see Figure 39). With the unit off, lightly blow air through the air inlet hole. You may blow through a drinking straw if compressed air is not available.

#### LOGS

- If you remove logs for cleaning, refer to *Installing Logs*, pages 14 and 15, to properly replace logs.
- Replace log(s) if broken or chipped (dime-sized or larger).

### **MAIN BURNER**

Periodically inspect all burner flame holes with the heater running. All slotted burner flame holes should be open with yellow flame present. All round burner flame holes should be open with a small blue flame present. Some burner flame holes may become blocked by debris or rust, with no flame present. If so, turn off heater and let cool. Remove blockage, blocked burner flame holes will create soot.

*Note:* All troubleshooting items are listed in order of operation.

WARNING: Turn off heater and let cool before servicing. Only a qualified service person should service and repair heater.




