Quick set-up guide:

- I) Install you lamp 30 cm (12 inches) from the wall. Plug the USB cable to the charger then the charger to the wall plug.
- 2) Hold the central button for 3 seconds. Holî will start blinking.
- In your iPhone/iPad Settings page, go to Bluetooth and select HOLI
- 4) Download HOLI APP from the APPSTORE
