## **TECH TALK**

Some of you may have noticed a new button on the **Help > About Debt\$Net** screen. The button will appear if (1) you

are currently using Release 6.9 and (2) you h a v e r e c e n t l y downloaded an Update.



The Tech Talk feature is currently being tested by our tech support department. When we are finished testing, it will allow users to address error messages via an online chat format. The idea is to be able to provide real-time response, in a less-expensive method.

Tech support personnel on our side will be able to gather better information on when and how the error occurred, and user's will receive a faster response. In addition, costs will be lower on both sides as phone time is minimized!

#### RELEASE 7.0

As we head towards the year 2007, we have started planning Release 7.0. A coincidence? Or strategic planning at its best? We like to think its clever planning.

Actually, Release 7.0 was underway ten seconds after we installed the first Release 6.9 with an existing user. At The Computer Manager, product development is a continuous process. Each time we meet with users, whether its an Annual User's Conference, Regional Training Session, or one of the many industry functions we attend, we listen to what our users have to say about how they use Debt\$Net<sup>TM</sup> and what functions would really help them do their job. We also pay attention to custom programming requests. Those that begin to be repeated often find their way into the software as a new feature, or an Extended Service Option. Another source of ideas is the changes to the industry and features that our competitors offer. It is our aim that Debt\$Net<sup>TM</sup> keeps pace with the needs of our users.

## **NEW BUILDING/MOVE**

# FOCUS ON RELEASE 6.9 - COLLECTOR **GROUPS**

Debt\$Net<sup>TM</sup> Release 6.9 includes some new ways to help you organize your staff and manage work. Two new fields have been added to the collector form; "Supervisor" and "Collector Class." For each collector (User) created in the system, you can assign another Collector as the supervisor. Collector activity reports can be generated by Supervisor number, so you can monitor the productivity of individual work groups.

The Collector Distribution Group menu option that was formerly located under Agency Management, has been moved to the Collector Maintenance Menu.

Another submenu option, "Collector Reassignment", has been added. Collector reassignment is used to reassign accounts in conjunction with Collector Distribution Groups. It can be used by agencies to distribute accounts out of house accounts, or move accounts to different collectors based on where the account is in the collection process. The process is very similar to Mass Account Change. In addition, reassignment actions that are routinely repeated can be saved as jobs and processed in a batch run.

#### WILD PARTIES

Ok, we confess. This article is NOT about wild parties. But we were afraid




month of July, four of our best users and friends still ran into trouble. Their systems crashed, and their backups were seriously outdated.

We sent the email out to remind others not to let it happen to them. At least one user called back in to let us know that the reminder caused him to check his system, and discovered it was not working correctly. If we can only save one user every time we run an article or email on backups, we feel we have done our job.

So here goes, one more time:

- (1) First, check to see if you are making backups. Make sure you have the hardware, media, and someone in your organization is responsible for making it happen.
- (2) Test the backup file to see if it works. Sometimes, the media wears out. Or, a power failure has happened and the automatic timer or other set up indicators have been lost. Sometimes, you are backup up empty directories.
- (3) Review Appendix E of the User's Guide. This covers basics on how to create an effective backup system.
- (4) If you have any questions or concerns about your backup process, call tech support. They would be happy to help you now, and avoid a serious problem later!
