

Flagged Fields

Prevent mistakes with field flags. By setting a field flag, you direct the software to require follow up on that field prior to finalizing the return. Use them in two different ways:

- > Set field flags on-the-fly when you need a reminder to follow up on a particular form or line item
- > Set field flags globally to ensure your office procedure is followed for every return

PDF Printer


