

User Guide & Helpful Hints

- 1. Click button 5 times to turn off, light will blink twice
- 2. Hold button down and inhale to use. Light will remain blue when you are using it.
- 3. If MedPen does not turn on, make sure Battery is charged.
 - · Allow to charge completely 4 hours
- 4. Check the connection from the battery to cartridge
- 5. If threads or surfaces are sticky, clean with Q-Tip and rubbing alcohol.
- 6. Check cartridge for damage where it connects to battery. Overheating can cause damage to cartridge and battery connection

Caution & Disclaimers

MedPen should be kept away from children's reach and stored safely in a non-damp environment. MedPen should be maintained regularly. Clean the screw threads of the different parts such as atomizer, cartridges, and power supply with a tissue dipped in purified alcohol. A clean thread will provide a better electric conduction. Blow into the atomizer once in a while to remove left over liquid.

Other: The MedPen is powered by a 3.7 V - 650/1100 Mah special power supply. Input voltage of the USB home charger is AC 100 V - 240 V 50/60 HZ. The input voltage of the USB power supply from a computer is usually DC 5V. Pay attention to the value of the voltage so that it is in accordance with the MedPen charger. The input voltage of the USB Battery Charger is 5V, 500Mah and the output voltage is 4.2 V 200 mah.

Warranty

- 1. Warranties
- a. 30 day satisfaction warranty
- i. Example: The 30 day satisfaction guarantee states that if you purchased the product directly from, then for the first 30 days after the original purchase date, if for any reason you are not satisfied with the purchase and you have not damaged the product through neglect or misuse, then you may contact returns@medpen.co to obtain a return authorization number and shipping instructions. Once the product has been returned to us and has been ascertained to be complete (including the original product box, with the unit in its original packing materials) and undamaged, your purchase price, less shipping and handling, will be refunded to you. We do not refund any shipping costs, and we may have to charge you extra if your original real shipment costs were greater than our invoiced amount. Note that if the product is defective, you may either request a refund or an exchange-or-repair-based replacement (per our 30 day warranty). Always contact returns@medpen.co first to verify that the satisfaction guarantee applies and to obtain the return authorization number. We cannot guarantee that we will accept returns that have not been authorized by us. This guarantee is limited to one refund on one product per customer. No refunds will ever be given after 30 days from the original purchase date.
- b. 30 day manufacturer's warranty
- i. Example: The 30 day manufacturer's warranty states that if the product fails in normal use (with no abuse and no customer changes or modifications to the MED PEN) within the first 30 days of ownership, then we will repair or replace it (at our option) at no charge to you except for your cost of shipping it to us. Please contact support@medpen.co to obtain a return authorization number and shipping instructions, and to determine if this warranty applies to your case. Always contact support@medpen.co first to verify that the warranty applies and to obtain the return authorization number. We cannot accept returns that have not been authorized by us.
- ii. Refund, replacement, and repair are your only remedies under our warranty. Your only remedy under our warranty is the above mentioned refund (30 day satisfaction guarantee) or the replacement or repair (30 day warranty) of your eligible MED PEN as described above.
