INTRODUCTION TO GIATEC Perma2TM

Giatec Perma 2^{M} is a re-engineered laboratory test device for measuring the resistance of concrete to the penetration of chloride ion. The test procedure is consistent with different standards, including:

- ASTM C1202 / AASHTO T277
- ASTM C1760

The device is capable of measuring the electrical charge passing through a standard concrete sample. The Perma2[™] device can be operated as a stand-alone unit or controlled using the Data Monitor PC software. The measurements can be used in the performance-based quality control of concrete materials. Measurements can also be used to estimate the chloride diffusion coefficient of concrete for the purpose of service life prediction.

The ASTM C1202 test provides an indication of concrete resistance to the penetration of chloride. A widely accepted qualitative relationship (see Table 1) between the electrical charge (measured according to ASTM C1202) and the long-term chloride penetrability of concrete was originally proposed by Whiting et al. (1981).

An alternative procedure to the test was proposed and standardized (ASTM C1760) to predict the bulk electrical conductivity of saturated specimens of hardened concrete. The results reveal a rapid indication (i.e. in one minute) of the concrete's resistance to the penetration of chloride by diffusion. The results of this test method can be also related to the

apparent chloride diffusion coefficient that is determined using ASTM C1556 test method.

APPLICATION

Perma2[™] is a laboratory device for testing the durability of concrete that is or has been exposed to chloride-contaminated environment including:

- Concrete's ability to resist chloride ion penetration (ASTM C1202, AASHTO T277)
- Bulk electrical conductivity of concrete (ASTM C1760)
- Performance-based quality control of concrete
- Estimation of the chloride diffusion coefficient of concrete
- Estimation of the chloride migration coefficient of concrete
- Service life design of concrete structures
- Estimation of the remaining service life of concrete structures

MEASUREMENT CONCEPT

Fig. 1 depicts a typical functional diagram for one of the four channels available on the device. In accordance with the testing standards requirements, each channel must be supplied by a controlled precision

 60 ± 0.1 DC voltage source. The electrical current passing through the cell is measured through an accurate and stable shunt resistor. The electrical potential over this shunt resistor will be used to calculate the current passing through the cell.

Each channel is protected against short circuit to prevent damage to the device and the test cells in case of faulty connection in the output circuitry. The short circuit protection system is also designed to reduce the fire hazard from excessive temperature rise in wires during a prolonged short circuit period. In addition, each output port is monitored continuously for its current consumption to limit the maximum allowable current to 504 ± 5 mA. A current consumption in excess of this limit would automatically turn off the overloaded channel.

The temperature of each test cell is continuously monitored with the accuracy of $\pm 1^{\circ}$ C using the temperature sensors to prevent overheating that might damage the test apparatus. When the temperature inside a cell reaches 90.5 $\pm 1^{\circ}$ C, the corresponding channel will be turned off automatically.

The duration of the test is also controlled by an internal clock system which will disconnect the power from the channels once the test is completed.

DEVICE OVERVIEW

Giatec Perma2[™] has two main components: A measuring device (Fig. 2, and 3), and four concrete sample cells (Fig. 4). The measuring device can be used as a stand-alone equipment to perform the tests. It can also be connected to a personal computer (PC) using the USB connection port. The Data Monitor software provided in the package controls the device and also records the measurement data. In this section, the key functions of these components are described.

Measuring Device

The front panel of the measuring device includes channel ports (see Fig. 2 Items 1, 2 and 3), Display, and the control keypad. The test cells are connected to the measuring device using the cables included in the package.

DEVICE OPERATION

Before starting the test, make sure that the concrete specimens meet the requirements of the standards. Then, the concrete specimen should be installed in the test cell proeprly. In order to run a test, follow the step-by-step instructions below:

Preparing the Test Cells

Step 1: The stainless steel wire mesh must be placed inside each test cell's cup and the corresponding connector must be tightened to provide a firm electrical connection between the mesh and the connector.

The bolts with provided washers should be inserted into the holes located at the four corners of the cell.



Place the steel wire mesh inside each Test Cell container

Step 2: Place one rubber gasket at one end of the specimen. Then place the spacer ring around the specimen. Push the second rubber gasket to the other end of the specimen. Make sure that the spacer ring is located right at the middle of the concrete sample by adjusting the location of the rubber gaskets.

Step 3: Place the assembled unit into the test cell.



Insert the prepared sample assembly into the cell, and fasten the nuts

Step 4: Place the second piece of the cell as described in the figure above. Carefully pass the bolts through the holes on the corners, and place the washers and nuts. Using an appropriate wrench, tighten the bolt-nut combination.

Filling the Test Cell

In order to fill the cell containers, place the cell such that the filling inlets are facing upward. Fill the right container (with black color jack) with 3.0% NaCl and the left container (with red color jack) with 0.3 Normal NaOH solution.

DO NOT close the filling inlets during the test.

DO NOT fill the test cells with the liquids when the test is running.

Leakage Test

Once the test cells are filled up with the solutions, the leakage test must be conducted as follows:

Control the level of liquids inside each container. If the level of the liquids is not constant within ten minutes, or if any dripping is observed below the cell, there may be a leak between the gasket and the specimen surface or between the test cell and connectors. Any leakage problem should be fixed before starting the test.

If the leakage is between the gasket and the specimen surface, try tightening the bolts and refilling the cell containers. If the source of leakage is between the cell and connectors, try tightening the connector, if it is possible. Otherwise, use silicon glue to seal the space between the connector and the cell. You may also need to adjust the position of the rubber gaskets and ensure they are properly located within the Plexiglas cell part to fix the leakage problem.

<u>_</u>

To avoid electric shock, all the cells must be leak free before running the test.

Disconnect the test cells from the measuring device before checking or fixing the leakage.

Connect the Test Cells to the Measuring Device

-<u>À</u>

To avoid electric shock, the device must be turned off before connecting any cables and cells.

Each cell should be connected to the corresponding channels on the front panel. The red connector of the cell (+) should be connected to the red terminal of the channel using the red cable. In a similar way, connect the black terminal to the black connector on the other half of the cell (-). The temperature sensor should also be placed inside the NaCl container. The other end of the temperature sensor cable should be connected to the designated terminal on the front panel.

TURN ON Perma2[™]

Before turning on the device, make sure that the cable, sensors, and test cells are connected to the appropriate connection terminals. Also make sure that there is no short circuit.

The main power switch of $Perma2^{IM}$ is located on the back panel of the device. Turn the switch from **O**-off to **I**-on. The LCD screen on the front panel will turn on; after a few seconds, the **Test Parameters** menu will appear on the LCD screen.

The default test method is set to ASTM C1202. If you want to perform the test according to ASTM C1760, you should change the test method using the options available in the Menu.

DEVICE SETUP

The system setup can be changed by pressing the **Menu** key on the front panel. The menu options will then appear on the LCD display. Using the Up \blacktriangle and Down \checkmark keys on the front panel, the user can access these options.

TESTING STANDARD

The user can change the test method by selecting either of the two available standard test procedures: ASTM C1202, or ASTM C1760. You can select the test method by using the Up \blacktriangle and Down \checkmark keys on the front panel. Press Select \triangleright to choose your test method.

DEVICE VERIFICATION

The verification kit is a useful accessory kit that can be used to ensure the appropriate functionality of the Perma $2^{\mathbb{M}}$ system. In order to verify the device, select the verification option in the Main Menu and follow the instructions.

SCREEN CONTRAST

In order to adjust the contrast of the device display, use the Up \blacktriangle key to increase the contrast or the Down \checkmark key to reduce the contrast.

PERFORM THE TEST

In the main menu, select the test method you want to use: ASTM C1202, or ASTM C1760.



Press the **Start** \triangleright key on the front panel to start the test; all four channels will be checked by the system to ensure their appropriate functionality before starting the test.



If the channel is working properly, the values of the current and temperature will appear in front of the channel number on the display and the red LED lights on the front panel will turn on.

Measured current and temperature during the test

For those channels that are not connected to the measuring device, the corresponding LED light will remain off during the test. No data will be recorded for these channels. A turned off message will appear in front of the channel number.

If there is any error, a specific error message will appear. Refer to the ERROR section of this user manual for information regarding the troubleshooting of the malfunctioning channels.

At any time during the test, the user can terminate the test by pressing the **STOP** \blacksquare key. A message will appear on the screen to verify the termination of the test. By pressing the **YES** key, the test will be terminated. For an incomplete test, using the recorded data the total electrical charge until the termination time will be calculated and displayed on the screen. The user can choose to continue the test by pressing the **NO** \clubsuit key.



The end of the test

When the test is completed, the channel(s) will be turned off; for ASTM C 1202, the total electrical charge will be calculated and displayed in front of the channel number; for ASTM C1760, the current value after 1 minute will be displayed in front of the channel number.

a) ASTM C1202: in this test, the total electrical charge (Coulomb) for each specimen is calculated by integrating the area under the current curve. This area can be calculated using the trapezoidal rule.

$$Q = \frac{1}{2} \Delta t \{ I_0 + 2I_{\Delta t} + \dots + 2I_{t-\Delta t} + I_t \}$$

Where Q, is the total electrical charge (Coulombs), t and Δt (seconds), are the total duration of the test, and sampling intervals, respectively, and I is the electric current (Amperes).

Sample Calculations

If the current is recorded at 30 min intervals, the total electric charge can be calculated as:

$$Q = \frac{1}{2} 1800 (I_0 + 2I_{30} + 2I_{60} + \dots + 2I_{330} + I_{360})$$

b) ASTM C1760: in this test, the value of electric current will be displayed at the end of the 60 second test period.

The user needs to record the results (as there is no onboard memory) and turn off the device in order to set up the next series of test samples.

During the sample replacement, the device must be kept off to avoid electrical shock hazard.

To avoid electric shock, the device must be turned off before connecting any cables and cells. Placing the temperature sensor in the positive cell might cause a serious damage to the device if the epoxy on the tip of the sensor is damaged. Therefore, it is highly recommended to place the supplied temperature sensor in the cell with black jack containing sodium chloride solution that is connected to the negative terminal.

MESSAGES

Perma2[™] has been designed and tested to the highest standards to ensure the safety of the user and the instrument. Several safety measures have been implemented in the device. Depending on the situation, one or more of these features might prevent the unit from continuing its normal functions. The channels are designed to work individually, therefore, these safety features will only apply to the channel experiencing trouble. In this case, a message will appear on the display.

Turn Off

The channel(s) will automatically be turned off if no electric current is drawn following the start of the test. In this case, a "**Turned off**" message will appear in front of the channel name on the display. This condition could arise in one or more following conditions:

- Test cables are not connected to the cell or the device (or are loose).
- No liquid was poured into test cell.
- The sample were not fully saturated before running the test.



Communication error in Channel 4

If all four channels are disconnected, the "turned off" message will appear for all channels. The user has to press the stop \square key to terminate the test. The user is then asked to turn off the device using the main power key on the back panel and check the test cells and wires.

ADC Err.

When the current measurement circuit does not function properly, the "**ADC Err.**" message will appear on the display. To resolve the issue, try turning off the device first, and then turn it on after a few seconds. If the issue is not resolved, contact Giatec customer service.

Short Circuit

If the positive and negative test leads are short circuited to each other by error when connecting them together, the channel with this fault will be turned off and "**short cir.**" Message will be showed on display.

Turn off the device and remove the short circuit before restarting the test.

Disconnected Sensor

If the temperature sensor is not connected to the test device, or if the temperature sensor is damaged, a "**DC**" message will appear in front of the channel number under the temperature column. As soon as the temperature sensor is appropriately connected to the device, the temperature value will appear on the LCD display.

Over Current

The electric current on each channel is continuously monitored so that the maximum allowable current is not exceeded. The current is limited to 504 ± 2 mA; if the current exceeds this value, the channel will be turned off automatically. The "**Over curr.**" message will appear in front of the corresponding channel name on the display and the channel will be turned off. No additional data will be recorded from a turned-off channel.

Over Heat

If the temperature in the test cell exceeds 90.5 ± 1 °C, the channel will be turned off, and the "**Over heat**" message will appear in front of the channel name on the display.

If the temperature sensor is not connected to the device, or if the temperature sensor is not working properly, the overheat check will not work and device will not be able to shut down the channels. There is a chance that the test cell can be seriously damaged if it becomes overheated.

DATA MONITOR SOFTWARE

Perma2[™] Data Monitor software can be used to control the measuring device, perform the tests, and log the test data on your computer. In order to be able to use the Perma2[™] Data Monitor, you have to install the software on your PC. You should also connect the measuring device to the PC using the USB cable provided.

DEVICE DRIVER

When you connect the Perma2TM measuring device to your computer for the first time, Microsoft Windows will automatically install the required driver if your computer has access to internet. A pop-up message will appear on the lower right corner of the screen (Windows taskbar).



Installing the device driver

When the installation has successfully completed, a message will appear confirming the installation:



USB Serial Port successfully installed on the computer

If your computer is running an older version of Windows (i.e., XP or 2000), or if your computer does not have internet access, you have to install the driver manually.

The driver file is located on the Perma2 Data Monitor CD. In order to install, or update a previously unsuccessful installation, go to the **Device Manager**. In Windows, you can access **Device Manager** under **System** in the **Control Panel**.

Insert the Perma2 Data Monitor software CD in your computer's CD-ROM drive. The Setup file is an autorun application. If the autorun did not start automatically, you can start the setup by clicking on the setup icon in the installation CD.

Click on Setup to start installing the Perma2 Data Monitor

The setup wizard will guide you through the rest of the installation. Follow the instructions on your screen to install the software. This process may be different depending on the version of your operating system (Windows XP, 2000, 7 or 8). Following a successful installation, a Perma2[™] Data Monitor icon will be created on your desktop. Click on this icon to run the software.

USING DATA MONITOR SOFTWARE

Click on the Perma2[™] Data Monitor icon on the desktop to launch the software. Alternatively, you can open the software from the **Programs** in the windows **Start Menu**.

The device should be connected to the PC with the USB cable, and turned on before launching the Data Monitor software.

The Perma2^M Data Monitor home window will appear on the screen. The menu strip box at the top of this form helps the user to perform different tasks.

DEVICE VERIFICATION

A verification kit can be purchased with $Perma2^{TM}$ that can be used to ensure the appropriate functionality of the device. The verification kit contains various electrical circuits that generate known electrical charge when it is tested by the device.

To ensure appropriate functionality of the measurement system, verify the device with the verification kit from time to time. The verification procedure may be repeated, as required. If the device does not pass the verification procedure, the device should be returned to Giatec for hardware calibration. The hardware calibration is also advised to be conducted once per year to ensure the appropriate functionality and accuracy of the measurements. It is noted that the optional verification practice will not assure the required accuracy of the system and therefore, the calibration procedure is necessary to be conducted regardless of the verification practice.

The verification of the device can be performed from the main menu option on the front panel of the device. Alternatively, you can verify the device by using the Data Monitor software.
