Connecting a Bluetooth Mouse or Keyboard

To start a Bluetooth connection with a mouse or keyboard:



- 1. Double-click **My Bluetooth Places** on the desktop to begin the setup.
- 2. Select Enter Bluetooth Neighborhood.
- 3. To see an updated list of devices, right-click anywhere, except on a device name, and then select **Refresh** from the pop-up menu.
- 4. Double-click the mouse or strike any key on the keyboard that you are trying to connect.
- 5. Each time the computer is turned on, the connection will be re-established automatically.

Setting Up Additional Bluetooth Devices



To set up additional Bluetooth devices, double-click **My Bluetooth Places** on the desktop, and then click on **Bluetooth Setup Wizard**.

Installing on Mac OS X (10.2.8 and Later)



After you plug in the Bluetooth USB Adapter, a Bluetooth icon appears in the upper-right corner of the Finder Menu. Use this menu to set up other Bluetooth devices, send files to paired Bluetooth devices, or open the Bluetooth System Preferences pane.



With the Bluetooth USB adapter plugged in, go to System Preferences to adjust your Bluetooth configuration.
