Wireless Installation



Press the channel connect button on the receiver. While the lights are flashing on the receiver, press the channel connect button on the bottom of the mouse. This will establish a connection between the mouse and receiver.

Wireless Installation

Product Features





Wireless range is about 6 feet between the mouse and the receiver.



IMPORTANT: This wireless device is similar to an FM radio, by adjusting the antenna you can get better reception. You may also want to experiment with different locations and positions of the receiver.



Your mouse features two side buttons that are pre-configured to "Forward" and "Back" in Internet browsers. You can easily change this setting using MouseWorks software.

Product Features



The receiver can charge NiMH (Nickel Metal Hydride) batteries while the computer is on. Insert 2 NiMH batteries into the receiver. The charging LED will blink to indicate that the batteries are charging. When the light stops blinking, the batteries are ready to use. The Data LED will flash green when the mouse is communicating with the receiver.



Note: Do not attempt to charge alkaline (non-rechargeable) batteries in the receiver.

Common Troubleshooting Steps

- 1. Plug and re-plug mouse. Make sure you are plugged into a USB port directly on computer (not via a USB hub).
- 2. Test batteries in another device. If they are low or drained, recharge them.
- 3. Test the device on another computer.
- Adjust the position of the receiver to improve wireless range. Large metal objects, radio towers, and other environmental factors may hinder wireless range.
- 5. Some surfaces may "trick" the optical sensor, such as high gloss wood, and reflective surfaces like glass or mirrors. The ideal surface is a bright white surface (such as a piece of paper).
