QuickTrieve and QuickManager, CSI's original DOS PC downloader and data management programs, have been used by traders for over a decade. These programs will help you process historical data received on disk and let you download daily updates and historical data via modem. Graphics are supported with QuickPlot<sup>®</sup>. Through QuickTrieve, CSI offers complete database services, including updates on global commodities, stocks, indexes and mutual funds.
