1. GENERAL

This chapter describes the outline of the License in the form of a floating license for managing the license of development environment for developing applications and systems for the microcontrollers (RH850, RX and RL78).

1.1 Introduction

Floating licensing is a licensing approach in which a limited number of licenses for a software are managed by the server and any computer connected to the server can use the software within the number of the licenses.

A floating license cannot be used unless the computer is connected to the server. Offline licensing is a mechanism that occupies the license for a certain period in order to use the license in a state disconnected from the network environment.

1.2 Operating Environment

A floating license operates in the following environment.

 - Windows Vista (32 bits and 64 bits): Business and Enterprise
 - Windows 7 (32 bits and 64 bits): Professional and Enterprise
 - Windows 8 (32 bits and 64 bits): Pro and Enterprise
 - Windows 8.1 (32 bits and 64 bits): Pro and Enterprise
- Runtime library
 - .NET Framework 4
 - ".NET Framework 4" is required. Cannot operate correctly in ".NET Framework 4 Client Profile".
- Development environment
 - CC-RL V1.01.00 or later
 - CC-RX V2.03.00 or later
 - CC-RH V1.02.00 or later
- License
 - RL78 License Pack 1 (CC-RL) or later
 - RX License Pack 2 (CC-RX) or later
 - RH850 License Pack 1 (CC-RH) or later



2. FUNCTIONS

This chapter describes functions of a floating license client.

2.1 Installing Floating License Client

Insert the CD in the drive of each client's PC. The preparing to Install page appears automatically. If the page does not appear automatically, double-click "Setup.exe" in the route directory of the CD.

Click the [Begin Client Setup] button, the floating license client setup begins.

Caution The floating license client setup must be conducted with administrator privileges.

2.2 Uninstalling Floating License Client

You can uninstall the floating license using [Programs and Features] in the control panel. Select "Renesas MCU Tools Floating License" and click the [Uninstall] button.

Caution Uninstalling the floating license client must be conducted with administrator privileges.



2.3 Using a Floating License

This section describes how to use a floating license.

2.3.1 Setting up the client

Start up the client GUI from the start menu and make initial settings.

Caution Set up the client after the server settings was finished.

 Launch the client GUI Select Windows [Start] menu >> [All Programs] >> [Renesas Electronics Utilities] >> [Renesas Floating License].

Remark Windows 8 or Windows 8.1, select [Renesas Floating License] on the start screen.

The option dialog box is opened at the first startup. If it is not opened, click the [Option] button.

(2) Connect the license server

Enter the IP address (example: 192.168.0.1) or host name (example: license.example.com) of the license server into [Server Address], the port number specified by the license server administrator into [Port]. If you don't know, please contact the license server administrator.

2.3.2 Acquiring a floating license

You don't need to take a particular action to acquire a floating license.

Starting the software subject to licensing automatically acquires a floating license.

The license will be returned automatically when the license was out of date. If the license will be required, the software subject to licensing automatically acquires a floating license again.

2.3.3 Confirming the status

Start up the client GUI from the start menu.

Select Windows [Start] menu >> [All Programs] >> [Renesas Electronics Utilities] >> [Renesas Floating License].

Remark Windows 8 or Windows 8.1, select [Renesas Floating License] on the start screen.

The Floating License window will open.

The license name is displayed by a bold font, and the license status is indicated by an icon.

2.3.4 Acquiring an offline license

A floating license cannot be used unless the computer is connected to the server. Offline licensing is a mechanism that occupies the license for a certain period in order to use the license in a state disconnected from the network environment.

(1) Open the Get Offline License dialog box

When the client is connected to the server, click the license name and the [Get Offline License] button in the Floating License window.

2.3.6 Change options

Below is the description of other options of the floating license client. In the Floating License window, click the [Option] button. The Floating License Option dialog box will open.

In this dialog box, the following options can be changed.

- [Logging status of use] checkbox

If this is checked, the status of the usage of the license is recorded in the log files. If this is unchecked, the log files are not saved.

- [Folder for saving log file] text box

Specifies the path for the folder in which the log files are to be saved. If the [Browse] button is clicked, the folder can be specified in the [Browse for folder] dialog box.

Logs are recorded with the numerical part of the file name changed for every 3 Mbytes with a file name of "FloatingLicense.xxx.log" (xxx is a 3-digit numerical value).

- [Max log file size] spin box

Specifies the maximum size of log files. When recording a log immediately after the maximum size has been reached, the oldest log file is deleted to keep the file size within the size of this setting.

- [Save detailed status] checkbox

If this is checked, the internal operations of programs are also recorded. If this is unchecked, only acquiring and releasing of licenses and their results are recorded.



2.4 Resetting When the Server Is Changed

When the server has been changed due to a failure or replacement, enter the new server's [Server Address] and [Port] in the option dialog box. After the settings have been changed, all existing licenses are revoked.



3. MESSAGE

This chapter describes internal error messages, fatal error messages, abort error messages, information messages, choice messages and warning messages that Floating License outputs.

The message is output to the Message dialog box or log file, etc...

3.1 Message Types

The message types (1 alphabetic character) when Floating License is operated are as follows.
