



Please keep this instruction sheet for future reference, as it contains important information.

Requires three "AA" (LR6) alkaline batteries (not included) for operation.

Adult assembly is required for battery installation.

Tool required for battery installation: Phillips screwdriver (not included). This toy has no consumer serviceable parts. Do not take this toy apart. Water toys sometimes get messy. Do not play with this toy on surfaces that can be damaged by water. Protect these play surfaces.

After each use, drain and rinse this toy. Dry thoroughly before storing. Wipe the toy with a clean cloth dampened with a mild soap and water solution.

Battery Installation

Note: To avoid moisture in the battery compartment, replace the battery compartment door after installing batteries. Tighten the screws in the battery compartment door with a Phillips screwdriver. Make sure the battery compartment door is fully assembled, according to these instructions.



- Locate the battery compartment door on the bottom on the toy. Loosen the screws in the battery compartment door and remove the door.
- Insert three "AA" (LR6) alkaline batteries.

Hint: We recommend **alkaline** batteries for longer battery life.

- Replace the battery compartment door and tighten the screws. Do not over-tighten.
- If this toy begins to operate erratically, you may need to reset the electronics. Remove the batteries and replace them.
- When lights or motion from this toy become faint or stop, it's time for an adult to change the batteries.

Battery Safety Information



In exceptional circumstances, batteries may leak fluids that can cause a chemical burn injury or ruin your product. To avoid battery leakage:

- Do not mix old and new batteries or batteries of different types: alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium).
- Insert batteries as indicated inside the battery compartment.
- Remove batteries during long periods of non-use. Always remove exhausted batteries from the product. Dispose of batteries safely. Do not dispose of this product in a fire. The batteries inside may explode or leak.
- Never short-circuit the battery terminals.
- Use only batteries of the same or equivalent type, as recommended.
- Do not charge non-rechargeable batteries.
- Remove rechargeable batteries from the product before charging.
