



your phone



basics —

You may have mastered these already, but here are a few essential basics:



turn it on & off

Press and hold for a few seconds to turn the phone on/off.

menu navigation



Press the center key • to open the Main Menu



Press the navigation key � up, down, right or left to highlight a menu option.



Press • or Select (left soft key) to select the highlighted option.



Press • when you see I in the display to show menu options.

customize —

Add your personal touch.

create shortcuts

Choose the features you want to access with a single key press from the home screen - really useful stuff:

set your screen saver and wallpaper

Change the wallpaper and screen saver images to ones that make you smile.

shortcuts —

A few shortcuts we think you'll find really useful:

voicemail

Press and hold 1. If your voicemail number is preset, you will connect. If not, press 1 then Store. If you don't know the number, ask your service provider.

recent calls

Quickly see your call history by pressing

• > Recent Calls. You can then choose to access your Received Calls. Dialed Calls or Call Times.

lock/unlock keys

Prevent accidental calls by pressing $\hat{\P}$ followed by Ξ . Your screen will go black and your keys are locked.

music player

Press Music (left soft key) from the home screen.

auick text

To set quick text on your home screen, press • Personalize > Home Screen > Home Keys > Ub/Down/Left /Right > Quick Text.

release the top of the cover. Then, working down the phone, release the cover and slide off.





Swap the keypad to the new cover, ensuring the top and bottom tabs are located securely. To replace the cover, first clip into the bottom of the phone and then work up the body, locking the tabs at the top. Finally, refit your battery and cover.

Caution: To avoid risk of personal injury or equipment damage, and maintain compliance with international RF exposure guidelines, do not use or charge your phone with either cover removed.

Caution: The front cover is made of plastic, so take care when handling. Also, when removing the cover take extra care not to expose to dirt, dust, liquids, condensation and static electricity. Always use Motorola approved covers.

emergency calls



To call an emergency number, enter the emergency number and press .

Your service provider programs emergency phone numbers (such as 112 or 911) that you can call under any circumstances, even when your phone is locked.

Emergency numbers vary by country. Your phone's pre-programmed emergency number(s) may not work in all locations, and sometimes an emergency call cannot be placed due to network, environmental, or interference issues

redial a number

- From the home screen, press to see a list of recently dialed calls.
- 2 Scroll to the entry you want to call and press .

music

When music is what you need ...

To use the music player, insert a microSD memory card, which is an optional accessory.

Your phone can play songs in the iMelody, MIDI and MP3 file formats. Your phone cannot play WMA, AAC, AAC+, AAC++ files, or MP3 files with a bit rate higher than 320 Kbps.



the small print -

battery use & safety

IMPORTANT: HANDLE AND STORE BATTERIES PROPERLY TO AVOID INJURY OR

DAMAGE. Most battery issues arise from improper handling of batteries, and particularly from the continued use of damaged batteries.

DON'Ts

- Don't disassemble, crush, puncture, shred, or otherwise attempt to change the form of your battery.
- Don't let the phone or battery come in contact with water. Water can get into the
 phone's circuits, leading to corrosion. If the phone and/or battery get wet, have them
 checked by your carrier or contact Motorola, even if they appear to be working
 properly.
- Don't allow the battery to touch metal objects. If metal objects, such as jewelry, stay in prolonged contact with the battery contact points, the battery could become very hot.
- Don't place your battery near a heat source. Excessive heat can damage the phone or the battery. High temperatures can cause the battery to swell, leak, or malfunction. Therefore:
- Do not dry a wet or damp battery with an appliance or heat source, such as a hair dryer or microwave oven.
- Avoid leaving your phone in your car in high temperatures.

DOs

- Do avoid dropping the battery or phone. Dropping these items, especially on a hard surface, can potentially cause damage.
- Do contact your service provider or Motorola if your phone or battery has been damaged from dropping or high temperatures.

Specific Absorption Rate Data

This model wireless phone meets the government's requirements for exposure to radio waves.

Your wireless phone is a radio transmitter and receiver. It is designed and manufactured not to exceed limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission (FCC) of the U.S. Government and by the Canadian regulatory authorities. These limits are part of comprehensive guidelines and establish permitted levels of RF energy for the general population. The guidelines are based on standards that were developed by independent scientific organizations through periodic

and thorough evaluation of scientific studies. The standards include a substantial safety margin designed to assure the safety of all persons, regardless of age or health. The exposure standard for wireless mobile phones employs a unit of measurement known as the Specific Absorption Bate, or SAR. The SAR limit set by the FCC and by the Canadian regulatory authorities is 1.6 W/kg. ¹ Tests for SAR are conducted using standard operating positions accepted by the FCC and by Industry Canada with the phone transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the phone while operating are well below the maximum value. This is because the phone is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station, the lower the power output.

Before a phone model is available for sale to the public in the U.S. and Canada, it must be tested and certified to the FCC and Industry Canada that it does not exceed the limit established by each government for safe exposure. The tests are performed in positions and locations (e.g., at the ear and worn on the body) reported to the FCC and available for review by Industry Canada. The highest SAR value for this model phone when tested for use at the ear is 1.28 W/kg, and when worn on the body, as described in this user guide, is 1.32 W/kg. The SAR value for this product in its data transmission mode (body-worn use) is 0.73 W/kg. (Body-worn measurements differ among phone models, depending upon available accessories and regulatory requirements).²

While there may be differences between the SAR levels of various phones and at various positions, they all meet the governmental requirements for safe exposure. Please note that improvements to this product model could cause differences in the SAR value for later products; in all cases, products are designed to be within the guidelines.

Safety and General Information

This section contains important information on the safe and efficient operation of your mobile device. Read this information before using your mobile device.

Exposure to Radio Frequency (RF) Energy

Your mobile device contains a transmitter and receiver. When it is ON, it receives and transmits RF energy. When you communicate with your mobile device, the system handling your call controls the power level at which your mobile device transmits.

Your Motorola mobile device is designed to comply with local regulatory requirements in your country concerning exposure of human beings to RF energy.

Operational Precautions

For optimal mobile device performance, and to be sure that human exposure to RF energy does not exceed the guidelines set forth in the relevant standards, always follow these instructions and precautions.

Product Operation

When placing or receiving a phone call, hold your mobile device just like you would a landline phone.

If you wear the mobile device on your body, always place the mobile device in a Motorolasupplied or approved clip, holder, holster, case, or body harness. If you do not use a bodyworn accessory supplied or approved by Motorola—or if you hang your mobile device from a lanyard around your neck—keep the mobile device and its antenna at least 2.5 centimeters (1 inch) from your body when transmitting.

Using accessories not supplied or approved by Motorola may cause your mobile device to exceed RF energy exposure guidelines. For a list of Motorola-supplied or approved accessories, visit our Web site at: www.motorola.com.

RF Energy Interference/Compatibility

Nearly every electronic device is subject to RF energy interference from external sources if inadequately shielded, designed, or otherwise configured for RF energy compatibility. In some circumstances your mobile device may cause interference with other devices.

Follow Instructions to Avoid Interference Problems

Turn off your mobile device in any location where posted notices instruct you to do so. In an aircraft, turn off your mobile device whenever instructed to do so by airline staff. If your mobile device offers an airplane mode or similar feature, consult airline staff about using it in flight.

Implantable Medical Devices

Potentially Explosive Atmospheres

When you are in such an area, turn off your mobile device, and do not remove, install, or charge batteries. In such areas, sparks can occur and cause an explosion or fire.

- Limit the amount of time you use headsets or headphones at high volume.
- Avoid turning up the volume to block out noisy surroundings.
- Turn the volume down if you can't hear people speaking near you.

If you experience hearing discomfort, including the sensation of pressure or fullness in your ears, ringing in your ears, or muffled speech, you should stop listening to the device through your headset or headphones and have your hearing checked.
