Acerca de AppAssure 5.4.2

El software de protección de datos Dell AppAssure ofrece copias de seguridad rápidas con recuperación verificada para sus máquinas virtuales y servidores físicos, tanto in situ como a distancia. Dell AppAssure es un software diseñado para profesionales de TI que necesitan una solución de [copias de seguridad, replicación y recuperación](#) potente, asequible y fácil de usar que proporcione protección para servidores y aplicaciones esenciales para la empresa como Microsoft Exchange, Microsoft SQL Server y Microsoft SharePoint. Realice copias de seguridad y proteja sus datos y aplicaciones esenciales de forma constante a través de una única consola de gestión basada en web.

Aviso sobre versiones recientes

Lea esta sección completamente antes de decidir el momento y el modo de instalar esta versión en su propio entorno.

Problemas que afectan a las versiones 5.4

- 1 Dell ha identificado un potencial problema con AppAssure versión 5.4.2.189, que puede evitar temporalmente el acceso a algunos puntos de recuperación en Cores que sufren ciertas condiciones de carga o fallos. En casos extremos, este problema puede provocar la pérdida de algunos puntos de recuperación. Se recomienda a todos los clientes que usen la versión 5.4.2.189 que actualicen inmediatamente a la versión 5.4.2.228 o posterior (5.4.2.230 o posterior para Linux).

Productos afectados: AppAssure versión 5.4.2.189 es la única versión afectada. La versión anterior, 5.4.1.77 está libre de fallos. Todas las versiones 5.4 posteriores, empezando por la 5.4.2.192, tampoco están afectadas.

Detalles: En la versión 5.4.2.189 se realizó un cambio en la lógica de consolidación que la endurece en los modos de fallos extremos, como las pérdidas de alimentación eléctrica o fallos de controlador catastróficos. Este cambio introdujo inadvertidamente la posibilidad de que los puntos de recuperación quedaran huérfanos, si un Agent en particular tuviera puntos de recuperación en los que a) faltaran uno o más volúmenes o b) fallara una comprobación de montaje de Exchange o una comprobación de

conectividad SQL. Los Cores que ya estén funcionando normalmente, sin puntos de recuperación incompletos ni comprobaciones de puntos de recuperación con fallos, no están afectados.

Existe la posibilidad de que los puntos de recuperación huérfanos puedan repararse con la ayuda del Servicio de atención al cliente. Sin embargo, en algunos casos, no es posible recuperar los puntos de recuperación huérfanos. Por ello, se insta a todos los clientes a que actualicen a la versión 5.4.2.228 o posterior tan rápido como les sea posible. Los clientes que no puedan actualizar inmediatamente deberán desactivar la consolidación hasta que les sea posible realizar la actualización.

- 2 Como parte de los cambios realizados para mejorar el rendimiento de las aplicaciones, AppAssure 5.4.1 y sus versiones posteriores representan los puntos de recuperación de un modo distinto a las versiones anteriores. Al actualizar desde AppAssure 5.3.x a AppAssure 5.4.1 o posterior, incluida esta versión 5.4.2, los puntos de recuperación existentes se convertirán a la nueva representación. **Por este motivo, no puede cambiar de una instalación de la versión 5.4.x a una versión 5.3 anterior, a menos que vuelva a crear su repositorio.**

NOTA: Cuando el Core se inicia por primera vez tras actualizar desde AppAssure 5.3.x a AppAssure 5.4.x, los puntos de recuperación existentes se convertirán a la nueva representación. Este proceso tardará aproximadamente el doble de tiempo que al cargar los mismos puntos de recuperación en versiones anteriores. Sin embargo, tras esta conversión inicial la carga de puntos de recuperación será notablemente más rápida que con versiones anteriores.

Si elige no instalar esta versión en este momento, Dell Software recomienda actualizar a AppAssure 5.3.7 para disfrutar de las mejoras más recientes en el código base de la versión 5.3. Para obtener más información sobre AppAssure 5.3.7, consulte las notas de la versión AppAssure 5.3.7.

Funciones

La siguiente lista incluye las nuevas funciones de AppAssure 5 en la versión 5.4.2.

- **Funciones de archivado e importación en la nube.** AppAssure 5.4.2 ahora ofrece nuevas funciones de la nube relacionadas con el archivado y la recuperación de su almacenamiento de datos a largo plazo y la gestión del acceso a sus cuentas de la nube.
 - **Archivado en la nube.** Al archivar sus datos para una retención a largo plazo, ahora puede almacenar sus archivos en destinos de almacenamiento de la nube, lo que incluye Amazon S3, Microsoft Azure, Rackspace y otras plataformas de almacenamiento basadas en estándares de OpenStack.
 - **Importación desde la nube.** Al admitir el archivado basado en la nube, también puede importar sus datos archivados en AppAssure 5 Core transmitiéndolos directamente desde un destino de almacenamiento de la nube que asocie a su Core.
 - **Gestión de acceso a la nube.** Al admitir el archivado y la importación basados en la nube, ahora puede gestionar sus cuentas de la nube en el menú Herramientas del Core seleccionando nubes y añadiendo o eliminando cuentas.
- **Certificado FIPS.** DellAppAssure 5.4.2 ha obtenido la validación FIPS 140-2 de nivel 1 del Instituto Nacional de Estándares y Tecnología (NIST) del Gobierno de EE. UU. FIPS 140-2 es un estándar de seguridad del Gobierno de EE. UU. utilizado para acreditar módulos criptográficos. Este cifrado certificado por el gobierno es obligatorio según muchos organismos gubernamentales (federales, estatales y locales), instituciones financieras y empresas de atención médica o biotecnología. Esta información todavía no aparece en la documentación del producto aparte de estas notas de la versión.

- **Búsqueda avanzada de Mailbox Restore para Exchange 2013.** La versión de Mailbox Restore incluida con AppAssure 5.4.2 ahora ofrece la capacidad de realizar una búsqueda avanzada de almacenes de datos de Exchange 2013. Parecida a la función de Exchange 2007 y 2010, la función Búsqueda avanzada de Exchange 2013 le permite restringir su búsqueda de elementos añadiendo especificadores como Desde, A, Asunto, Fecha y Tamaño a una lista de criterios de búsqueda.

Todavía no aparece ningún procedimiento para esta función en la *Guía del usuario de Dell AppAssure Mailbox Restore para Exchange*.

Mejoras

La siguiente lista incluye las mejoras de AppAssure 5 en la versión 5.4.2.

- **Mejoras en funciones de archivado.** AppAssure 5 aumenta su capacidad de gestionar archivos ofreciendo las siguientes mejoras:
 - **Archivado programado.** Ahora puede programar archivos de manera regular, seleccionando entre archivos diarios, semanales o mensuales. Esta función admite archivos locales, de red y basados en la nube.
 - **Archivado incremental.** Anteriormente, los archivos se sellaban una vez que se creaban. Ahora puede añadir puntos de recuperación incrementales a cualquier archivo existente, almacenando únicamente los cambios desde el último archivado.
- **Incremento de la compatibilidad con la virtualización.** AppAssure 5 ahora admite la próxima generación de máquinas virtuales para plataformas virtuales compatibles.
 - **Exportación virtual a máquinas virtuales de segunda generación Hyper-V.** En la versión 5.4.2, AppAssure 5 ahora admite máquinas virtuales de segunda generación Hyper-V, que admiten el firmware de la Interfaz de firmware extensible unificada (UEFI), arranque seguro, arranque SCSI y arranque de red a través de PXE. AppAssure 5.4.2 añade la opción de realizar una exportación virtual a este nuevo tipo de máquina virtual para hosts Windows 8.1 y Windows 2012 R2. Solamente los equipos protegidos con los siguientes sistemas operativos con UEFI ofrecen una exportación virtual para la segunda generación de Hyper-V: Windows 8, Windows 8.1, Windows Server 2012 y Windows Server 2012 R2.
 - **Compatibilidad con máquinas virtuales VMware/ESXi.** AppAssure 5 ahora admite la exportación a VMware Workstation, versión 10.0, y para plataformas de servidor, la exportación a ESXi, versión 5.5, y vSphere 5.5. Esto incluye la exportación virtual y la implementación masiva. Estas máquinas virtuales introducen compatibilidad con controladoras SATA, un incremento de la memoria máxima y compatibilidad con Hyper-V anidado.
- Para la exportación virtual, como VMware Workstation es una aplicación de escritorio, se le pedirá que seleccione la versión específica de VMware al definir una exportación virtual (puntual o continua). Como ESXi y vSphere son aplicaciones basadas en servidor con API nativas, no es necesario designar una versión específica de AppAssure 5; cuando defina información de conexión de host virtual, la versión adecuada se detectará automáticamente.
- **Mejoras de la GUI.** Las siguientes mejoras se incluyen en la versión 5.4.2 de AppAssure.
 - **Resumen de panel de control.** La página de resumen de panel de control de AppAssure que resultaba tan familiar y se utilizaba en las versiones anteriores a la versión 5.4.1 se ha restaurado en la versión 5.4.2. La página de inicio del Core proporciona un resumen de los equipos protegidos y los clústeres, los equipos replicados y los Agents solamente de puntos de recuperación (huérfanos). Para cada uno, obtendrá una vista del estado del equipo, el repositorio al que está asociado cada equipo, el número de puntos de recuperación, la última instantánea y la cantidad total de espacio consumido por los equipos protegidos.
 - **Guía de inicio rápido del Core.** La función Guía de inicio rápido introducida en la versión 5.4.1 ahora se ha etiquetado como Guía de inicio rápido del Core en la pantalla emergente, y el enlace del menú Ayuda ahora utiliza la terminología correcta, esto es, Guía de inicio rápido.
 - **Biblioteca de documentos actualizada.** Ahora, al hacer clic en el logotipo de Dell en AppAssure 5 Core, irá a nuestra biblioteca de documentación de Dell en el sitio web de asistencia de Dell, donde tendrá acceso a nuestro conjunto completo de documentación.
- **Compatibilidad mejorada para SQL Server.** La versión 5.4.2 incluye las siguientes mejoras:
 - **Compatibilidad de AppAssure 5.4.2 Core y Agent con SQL Server 2014.** AppAssure 5.4.2 ahora es totalmente compatible con Microsoft SQL Server 2014. Puede proteger equipos o clústeres SQL Server 2014 Agent en el Core y, desde AppAssure Core en 5.4.2, puede gestionar la conectividad

de SQL para SQL Server 2014, lo que incluye habilitar comprobaciones de conectabilidad nocturnas y forzar comprobaciones de conectabilidad según demanda.

- **Compatibilidad de DocRetriever for SharePoint 5.4.2 para SQL Server 2014.** Para DocRetriever, todas las funciones compatibles con versiones anteriores de SQL Server también se admiten para la versión 5.4.2. Puede utilizar un archivo de copia de seguridad de SQL Server 2014 nativo como origen de recuperación (de modo que pueda restaurar directamente desde SharePoint) y puede recuperar objetos de SharePoint desde bases de datos de SQL Server 2014.
- **Cambios en la ayuda sensible al contexto.** Las versiones anteriores de AppAssure 5 incluían archivos de ayuda, denominados anteriormente “ayuda en línea”. La versión 5.4.2 incluye archivos de ayuda ampliados, que ahora denominamos “ayuda sensible al contexto” o CSH. Desde AppAssure 5 Core Console, cuando hace clic en el ícono de signo de interrogación azul, aparece una ventana de explorador, con un número seleccionado de temas en un marco de navegación a la izquierda. El contenido relativo al tema sobre el que haga clic aparecerá en el marco de contenido de ayuda principal a la derecha. En cualquier momento, el árbol de navegación puede ampliarse para mostrar la ubicación del tema seleccionado dentro de su jerarquía.

La ayuda sensible al contexto incluye los siguientes cambios en esta versión:

- **La organización del árbol de navegación ahora sigue la estructura de la guía del usuario.** En el marco de navegación de la izquierda de la ayuda sensible al contexto, los temas raíz ahora están organizados como aparecen en la *Guía del usuario de AppAssure 5*. Para esta versión, los temas relativos al portal de licencias de Dell AppAssure siguen apareciendo como el segundo tema, “Acerca de la obtención de una clave de licencia”.
- **NOTA:** El contenido relacionado con el portal de licencias de Dell AppAssure se deja de utilizar en la ayuda sensible al contexto y se eliminará en una versión futura, ya que la información más reciente siempre aparece en la *Guía del usuario del portal de licencias de Dell AppAssure*, que está en un ciclo de versión diferente que el software AppAssure 5.
- **Acceso completo al contenido de la guía del usuario.** Ahora puede examinar todo el contenido de la guía del usuario de AppAssure 5 desde dentro del sistema de ayuda sensible al contexto.
- **Nuevo tema para gestionar cuentas de la nube.** Hay una nueva referencia de ayuda de AppAssure 5 Core Console (desde el Core, haga clic en Herramientas y, a continuación, haga clic en Nubes). Este tema de ayuda incluye información sobre nuestras nuevas funciones relativas al archivado y la importación en cuentas de la nube.
- **Ayuda interna del producto actualizada para DocRetriever for SharePoint.** Ahora hay disponible ayuda interna del producto actualizada desde la DocRetriever Console. Desde el menú Ayuda, seleccione Ayuda de DocRetriever for SharePoint (o pulse F1 en su teclado). Aparecerá una ventana autocontenido, con el formato HTML compilado de Microsoft (CHM). La Ayuda actualizada incluye todo el contenido de la *Guía del usuario de DocRetriever for SharePoint, versión 5.4.2* y sustituye al contenido heredado de la *Guía de instalación de DocRetriever for SharePoint*.

- Al iniciar el Core por primera vez tras actualizar desde versiones anteriores a AppAssure 5.4.1, la conversión de puntos de recuperación existentes tardará en cargarse aproximadamente el doble que la carga de los mismos puntos de recuperación de versiones anteriores. Sin embargo, tras esta conversión inicial la carga de puntos de recuperación será notablemente más rápida que con versiones anteriores.
- Tras actualizar desde versiones anteriores a AppAssure 5.4.1, si intenta configurar una política de retención en un Core de destino replicado distinta de la política de replicación del Core de origen, primero se le pedirá que realice el nuevo trabajo de comprobación de integridad del repositorio. Se aplica el mismo requisito si quiere configurar una política de retención personalizada para un Agent replicado. Al ejecutar este trabajo pueden identificarse incoherencias de forma preventiva en puntos de recuperación replicados, lo que permite reemplazar aquellos que tengan errores por puntos de recuperación sin errores.

 **PRECAUCIÓN:** La realización de este trabajo puede tardar un tiempo considerable, en función de los datos de su repositorio y el sistema de almacenamiento subyacente. Mientras el trabajo se está ejecutando, no es posible realizar ninguna otra transacción en ese repositorio, incluyendo las transferencias (instantáneas, copias de seguridad de imagen base y replicación), trabajos nocturnos, etc.

Prácticas recomendadas

- Los equipos del Agent no deben ejecutar una versión de AppAssure más reciente que la versión instalada en el Core. Esto se aplica a los tres primeros dígitos del nombre de la versión (por ejemplo, 5.3.7 o 5.4.2).

NOTA: Dentro de una misma versión se pueden usar distintos números de compilaciones. Por ejemplo, si usa implementación masiva o actualización automática, puede que haya pequeñas diferencias entre Agents o entre un Agent y el Core.

- El orden recomendado de actualización de componentes es: primero el Core y después los Agents.

Preamble

The licenses for most software are designed to take away your
freedom to share and change it. By contrast, the GNU General Public
Licenses are intended to guarantee your freedom to share and change
free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some
specially designated software packages--typically libraries--of the
Free Software Foundation and other authors who decide to use it. You
can use it too, but we suggest you first think carefully about whether
this license or the ordinary General Public License is the better
strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use,
not price. Our General Public Licenses are designed to make sure that
