**STEP 1.** Identify the main parts of the full-body fall arrest harness (fig. 1). Hold the full-body fall arrest harness by the tether loop insuring the harness is upright and leg straps are hanging down. Straighten any parts that have become twisted. Insert arms through each shoulder strap. (fig. 2)

**STEP 2.** Feed the left leg strap between legs and thread through the bottom left waist loop. Repeat with the right leg strap, feeding between legs and through right waist loop. (fig. 3)

**STEP 3.** Secure the two leg straps by threading the 3 bar buckle as shown in Figure 4. Tighten the leg straps snuggly. DO NOT over tighten as this will cut off the circulation to your leg. The Big Game<sup>®</sup> Treestands full-body fall arrest harness should look like the one depicted in Figure 6 when donned correctly.

**NOTE:** If leg straps are too long, feed left leg strap with buckle through bottom of the left waist loop, down the top of the right waist loop and secure to right leg strap with 3 Bar Buckle as instructed.

WARNING! It is very important to complete this step of the assembly. An improperly secured buckle may cause full-body fall arrest harness failure resulting in serious injury or death! **STEP 4.** If necessary to use a climbing belt for the field installation of your treestand, feed the climbing belt through one of the waist loops and wrap the free end around the tree. Then

feed opposite end through the opposite waist loop and use 3 bar buckle method described in Figure 4 to secure. (fig. 5)

**STEP 5.** Once you have reached your desired height, insert the tree belt through the loop of the tether. (fig. 6) Then, carefully wrap the tree belt around the tree at a height that allows just enough slack for you to sit comfortably in your stand. Keeping the tether as short as possible limits the distance you will travel in case of a fall. To secure the strap, insert free end up through the slot in the buckle closest to opposite end of the tree belt strap, then cross over the sliding mechanism and back down through opposite slot. Pull on strap to secure and test to make sure sliding mechanism engages, creating secure strap placement. (fig. 7, 8, 9)

WARNING! There is time to make a correct decision on what action to take if a fall occurs while wearing a full-body fall arrest harness. It is important NOT TO PANIC! WARNING! A suspension relief device must be on your person and readily accessible while using a full-body fall arrest harness. **STEP 4.** If you are able to reach your ladder or climbing system, use it to get back into your secured treestand and then carefully climb down to ground-level. If you are not able to reach your stand, remain calm and continue to stand in the **SRD loop** until help arrives. (see fig. 13)

STEP 5. Use your personal locating device or cell phone to call for help.

**NOTE:** Several optional products/systems are available that offer self-recovery or self-extraction from a fall when suspended in a full-body fall arrest harness. Some systems automatically descend the user while others allow user control. One of these products/systems can be considered for use as an additional safety precaution against prolonged suspension and suspension trauma. STEP 2. Next attach the top ladder section and foot rest to the left/right foot platforms using (2)  $1/4" \ge 13/4"$  hex bolts [A], (4) nylon washers and (2) 1/4" nylock nuts. (fig. 1)

**STEP 3.** Using (2)  $5/16" \ge 21/2"$  hex bolts [I] and (2) 5/16" nylock nuts attach the **left outer foot platform** to the **left foot platform**. Repeat for right side. (fig. 1)

**STEP 4.** Attach the **platform support** to the **left/right foot platforms** using (4) 1/4" x 3" hex bolts [B] and (4) 1/4" nylock nuts. **NOTE:** The **seat hub bracket** on the **platform support** should be toward the rear of the unit. (fig. 2)

**STEP 9.** Attach the **rail supports** to the **left and right foot platforms** and **left and right outer foot platforms** using (8)  $5/16" \ge 11/2"$  hex bolts [E] and (8) 5/16" nylock nuts. Then attach the **rear rail supports** in the same method using (4)  $5/16" \ge 11/2"$  hex bolts [E] and (4) 5/16" nylock nuts to secure. (fig. 4)

## FIELD INSTALLATION - LADDERSTANDS

**STEP 1.** Select a healthy and straight tree. Remove all dead branches or limbs that will be in the way prior to setting up this ladderstand.

**STEP 2.** Assemble ladder sections to the main section. **NOTE:** All ladder sections will be assembled with the narrow section facing upward and all larger ends (sleeves) facing downward. (fig. 1) After assembling the ladder, insert snap pins in every joint to secure. **NOTE:** If your ladder has Safety Sleeves (CR4850-S) please refer to page 94.

**STEP 3**. Attach the (2) stabilizer straps to each side of the rear frame support (near the bark biters). Secure straps by wrapping strap around rear frame support and pulling through its looped end. (fig. 2) Then, firmly tie straps to a lower-level ladder rung.

**NOTE:** Do not attempt to install your ladderstand without the straps firmly tied to the ladder.

**STEP 4.** Place the ladderstand flat on the ground in front of the tree with the bottom ladder section approximately 2 feet away from the base of the trunk. Then with at least 3 adults, gently raise the ladderstand to a vertical position allowing the bark biters to come into direct contact with the tree. (fig. 3) Once elevated completely, carefully pull the base away from the tree until the sitting & standing platforms are parallel to the ground. (fig. 4)





WARNING! You must have three (3) adults to install or remove your stand from the tree. Failure to follow these instructions may result in serious injury or death!

**STEP 5.** Attach the adjustable support bar to the ladderstand. **NOTE:** The adjustable support bar for CR4200-S and CR4850-S should be attached to the highest ladder rung that is reachable from the ground. The other support bars should be attached to receivers on the middle ladder section. Adjust the length so that the tree piece fits snugly to the tree, providing rigid support to the ladder; insert snap pin or bolt cap to secure. Once you have set the adjustable support bar, use the rope to secure it to the tree. (See pages 94-95). **NOTE:** No support bar is included or required for CR5020-S

**STEP 6.** When the ladderstand is level and the adjustable support bar is secure, untie the stabilizer straps from the ladder section. Crisscross stabilizer straps behind the tree trunk pulling them snug. Then, secure each stabilizer strap by tying several firm knots around a middle section ladder rung. **NOTE:** The the stabilizer straps as high as you can reach while standing safely on the ground. WARNING! Prior to attempting to climb a ladder stand for the first time, make certain the feet of the bottom rung ladder section are firmly planted on solid, level ground. If they are not firmly planted on level ground, **DO NOT** climb the ladder. With the help of two (2) other adults, lower the stand and find a suitable location to safely install the ladder stand. Failure to follow these instructions may result in serious injury or death!

**WARNING!** Before attempting to climb the ladderstand, bounce on the bottom ladder section to set the ladder into the ground before proceeding higher. Failure to follow this warning may result in serious injury or death!

WARNING! Always lean forward while climbing and securely attach your full-body fall arrest harness tree belt to the tree prior to securing the platform to the tree and stepping onto the platform. Failure to follow this warning may result in serious injury or death!

**STEP 7. CRITICAL STEP!** After installing the adjustable support bar and stabilizer straps, it is now time to attach the **RATCHET STRAP(S)** to the top section of your ladderstand. Ratchets are attached at the contact point from the stand to the tree. Hook one end of the ratchet onto the rear frame support, near the bark biters, wrap around tree trunk, and connect to opposite side. Carefully tighten the **VITAL RATCHET STRAP** securely. (see fig. 6, page 90) **NOTE: TWO (2) VITAL RATCHET STRAPS ARE INCLUDED AND NECESSARY FOR SOME MODELS. ALWAYS USE ALL PARTS REQUIRED.** 

WARNING! When climbing to secure the ratchet strap(s) on the platform(s), it is important to lean forward when climbing to keep the stand centered and secure to the tree trunk. DO NOT lean backwards when climbing. Failure to follow these instructions may result in serious injury or death!

WARNING! When climbing, always maintain three points of contact as you ascend (climb up) and while descending (climb down). Failure to maintain three points of contact puts the user at serious risk of bodily injury. Failure to follow these instructions may result in serious injury or death!

WARNING! The platform ratchet strap(s), stabilizer straps and adjustable support bar(s) have all been included with your new ladderstand to ensure its solid attachment to the tree. All three of these safety devices must be installed as outlined in this Instruction Manual. Failure to install these safety devices as outlined in this Instruction Manual may result in serious injury or death! **NOTE:** No support bar is included or required for CR5020-S.

STEP 8. You are now ready to use your ladderstand!
